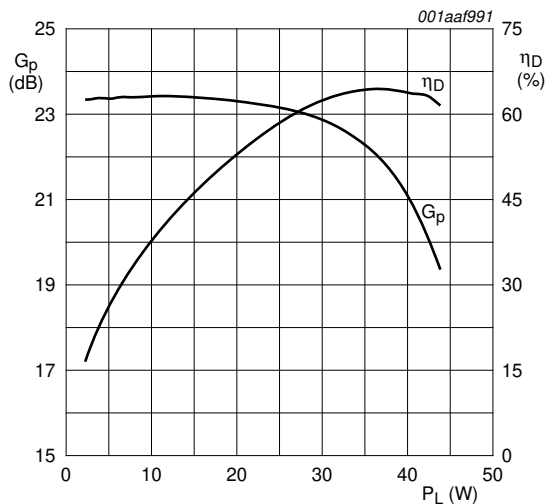

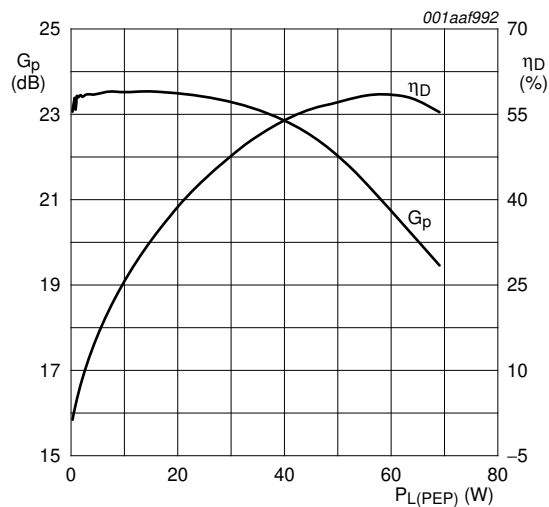
7.1 Ruggedness in class-AB operation

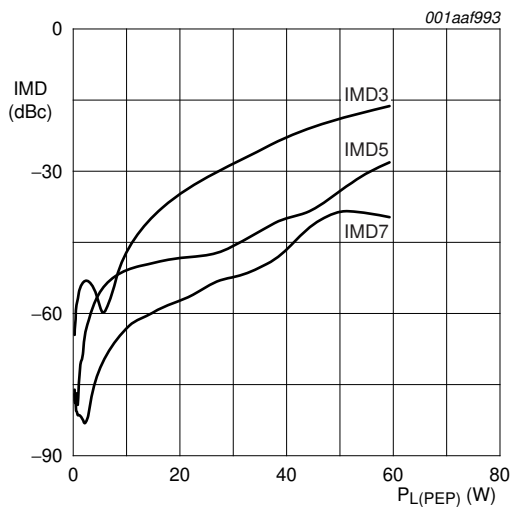

Fig 1. One-tone CW power gain and drain efficiency as functions of load power; typical values



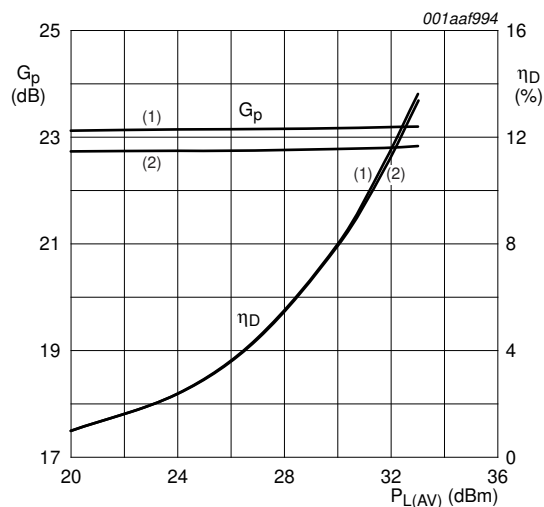

 $f_2 = 960.1 \text{ MHz}$.

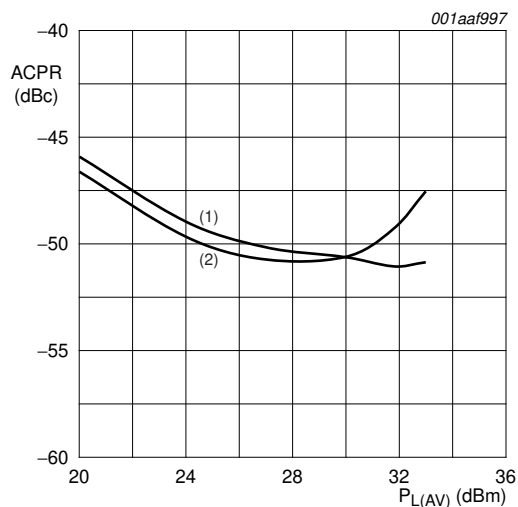
Fig 3. Intermodulation distortion as a function of peak envelope load power; typical values

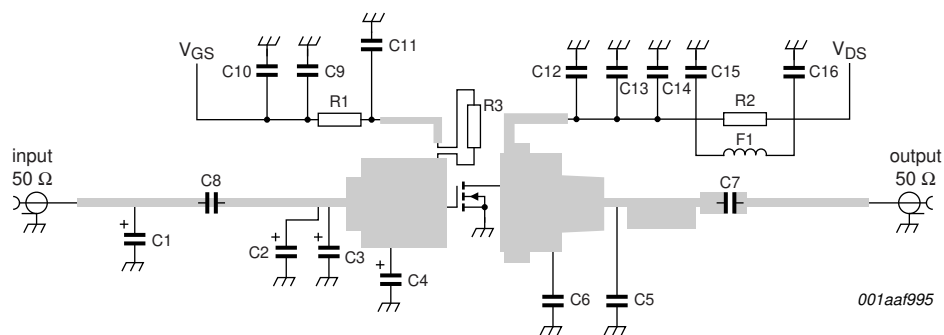


Fig 6. Test circuit for operation at 900 MHz

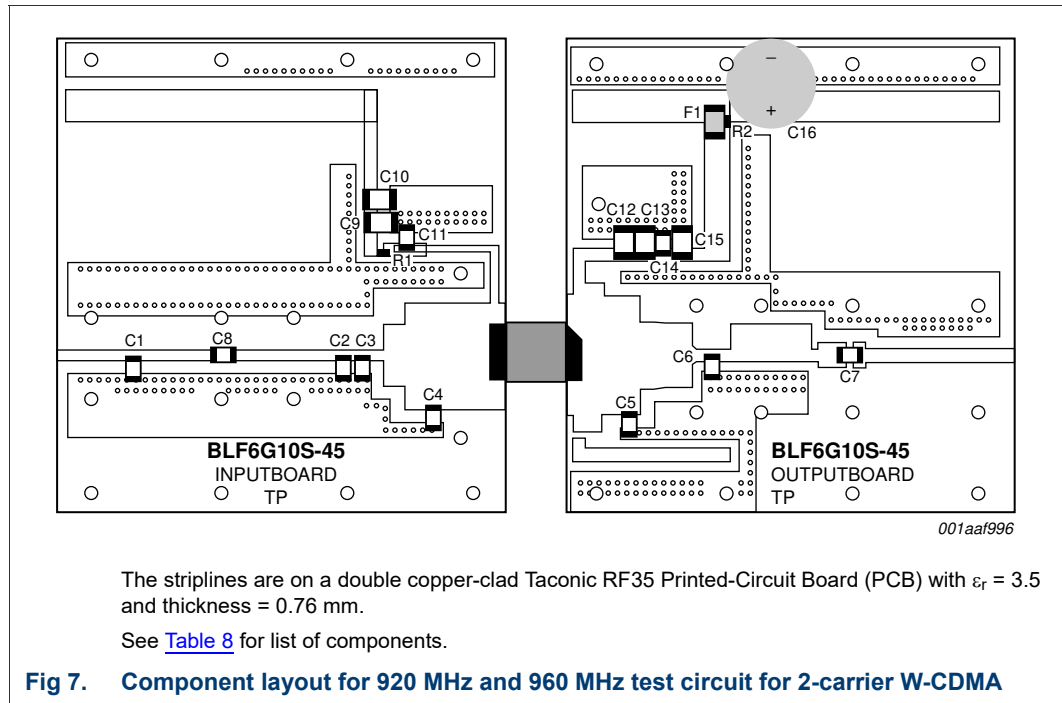

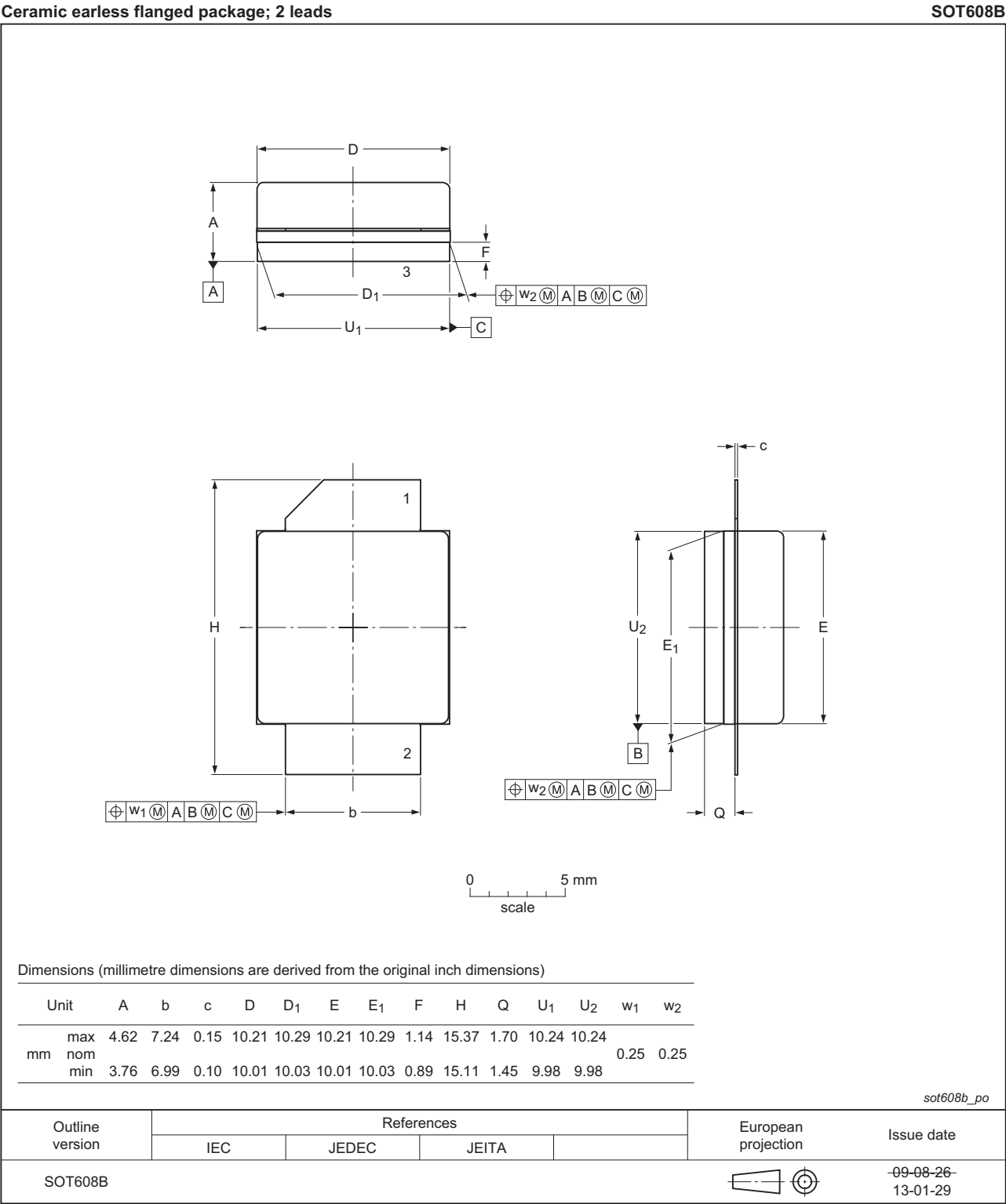


Fig 8. Package outline SOT608B
