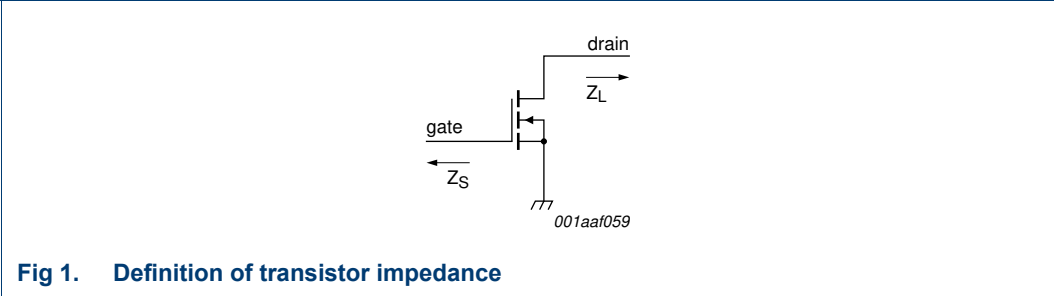
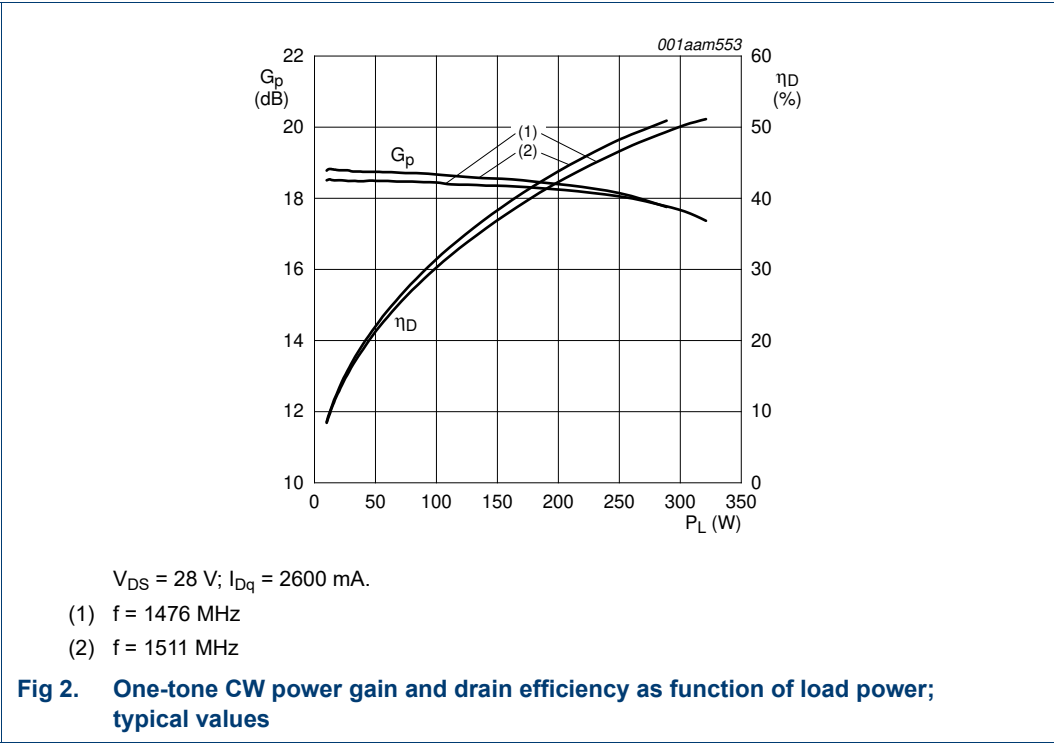
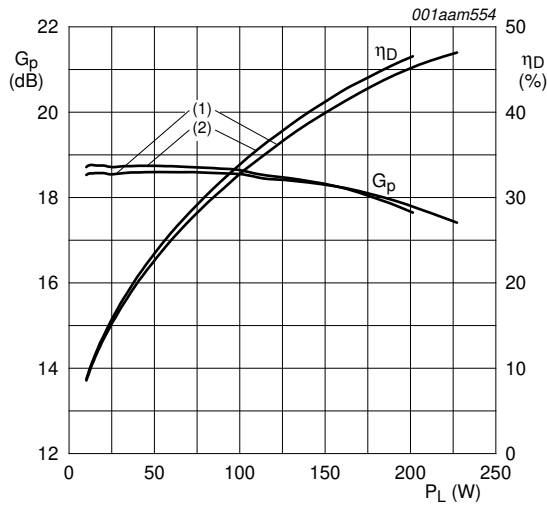


Fig 1. Definition of transistor impedance

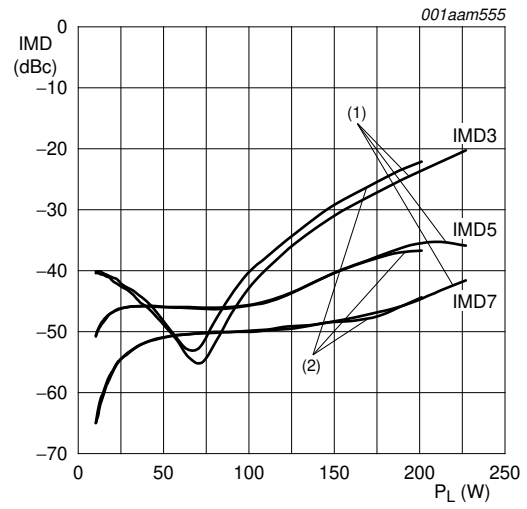

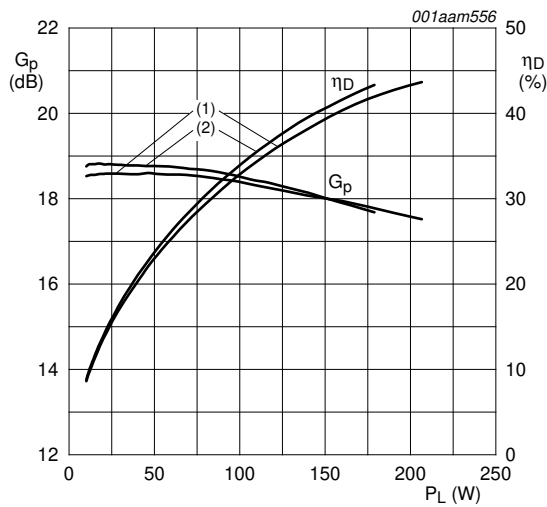
Fig 3. Two-tone CW power gain and drain efficiency as function of average load power; typical values

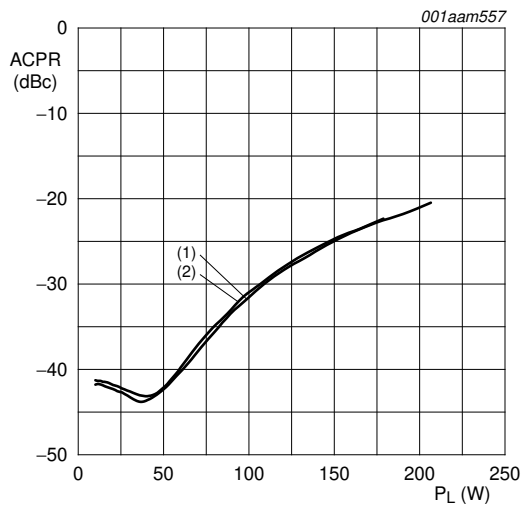
Fig 4. Two-tone intermodulation distortion as a function of average load power; typical values

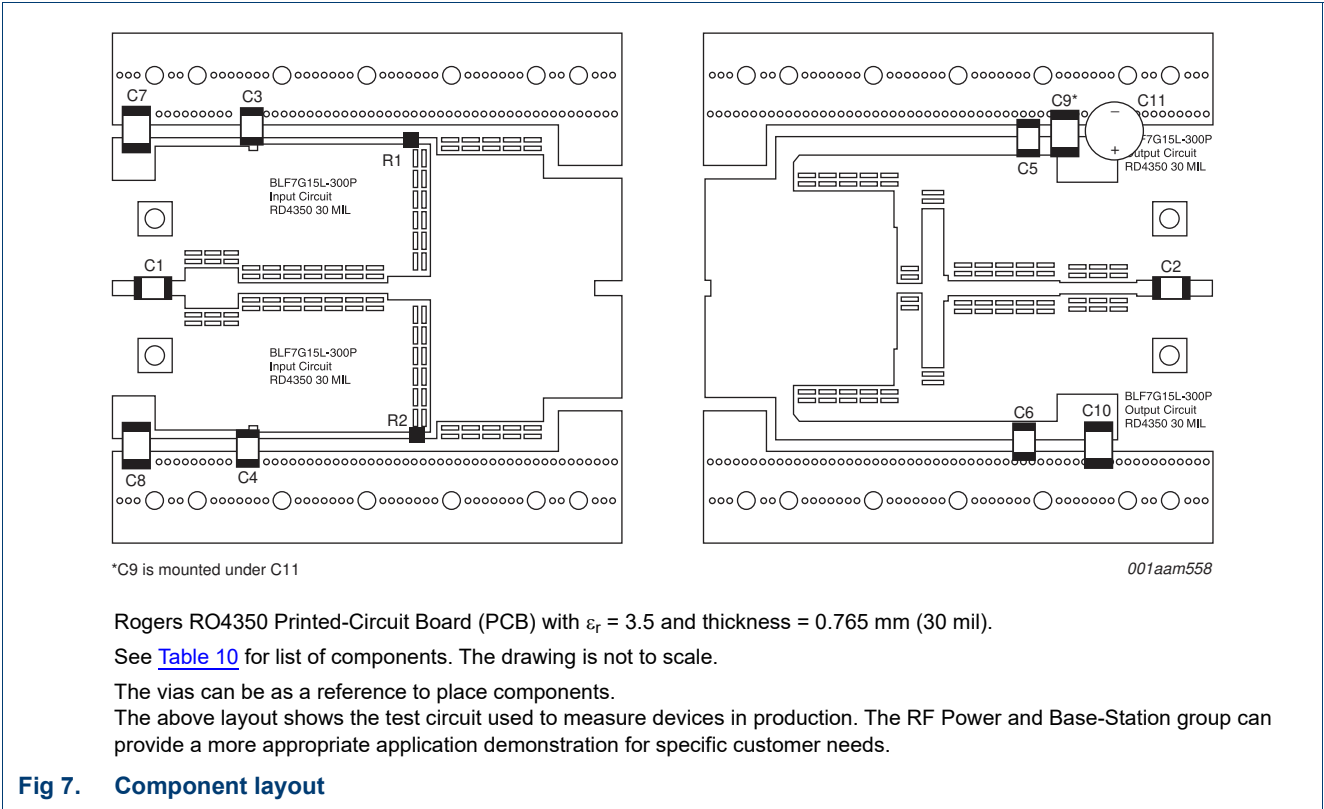

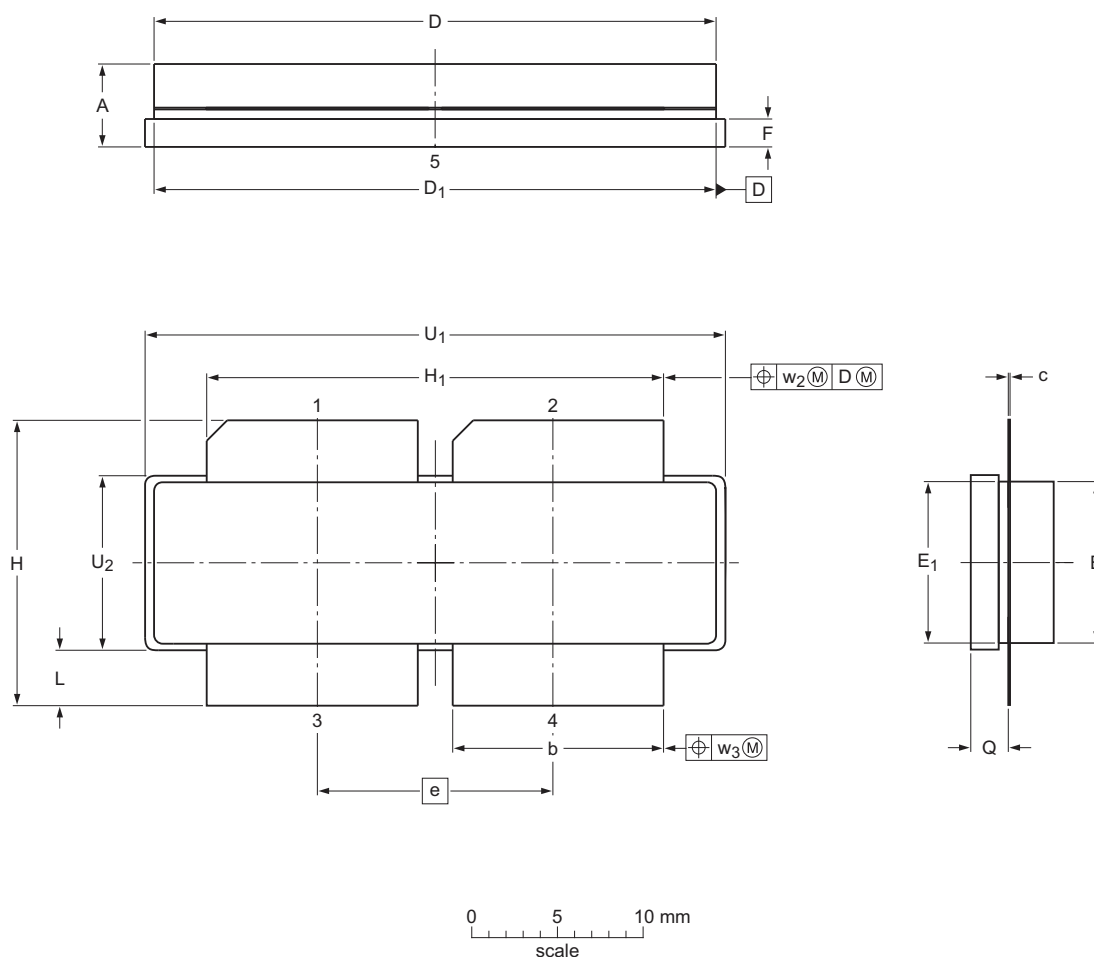
