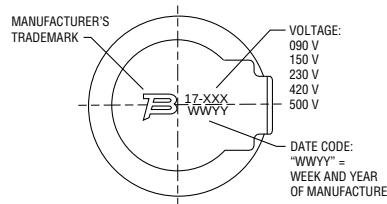

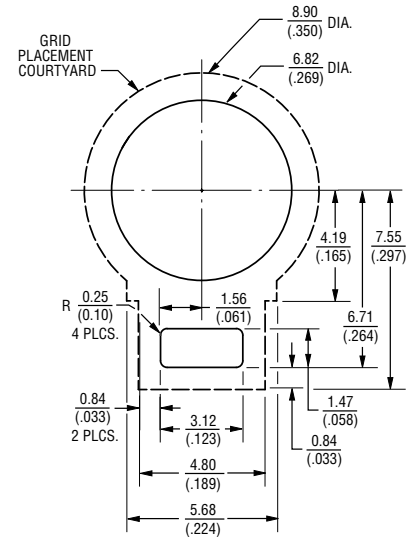
Typical Part Marking



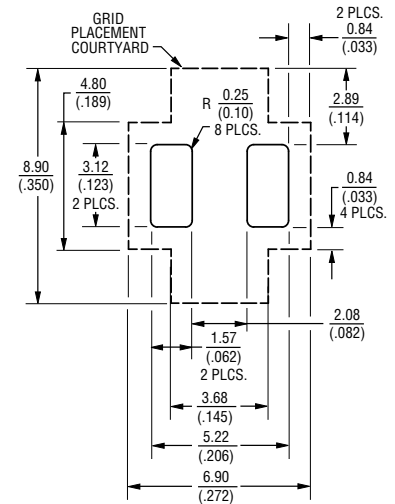
