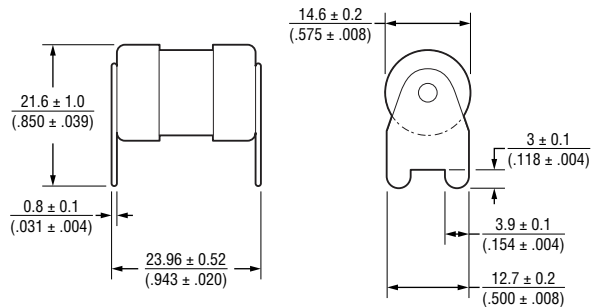

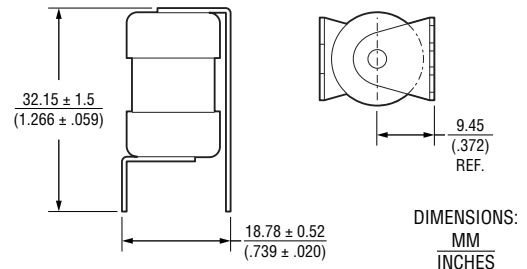

PCB Mounting/T2

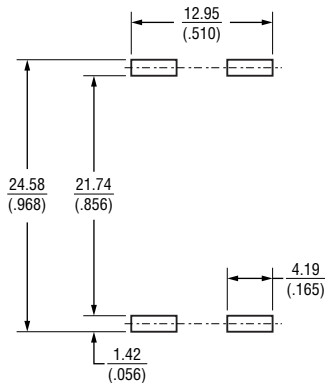


PCB Mounting/T5

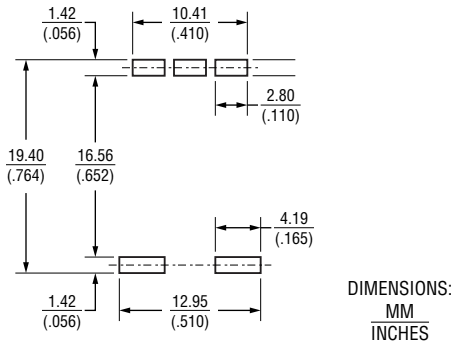


Recommended Drilling Pattern

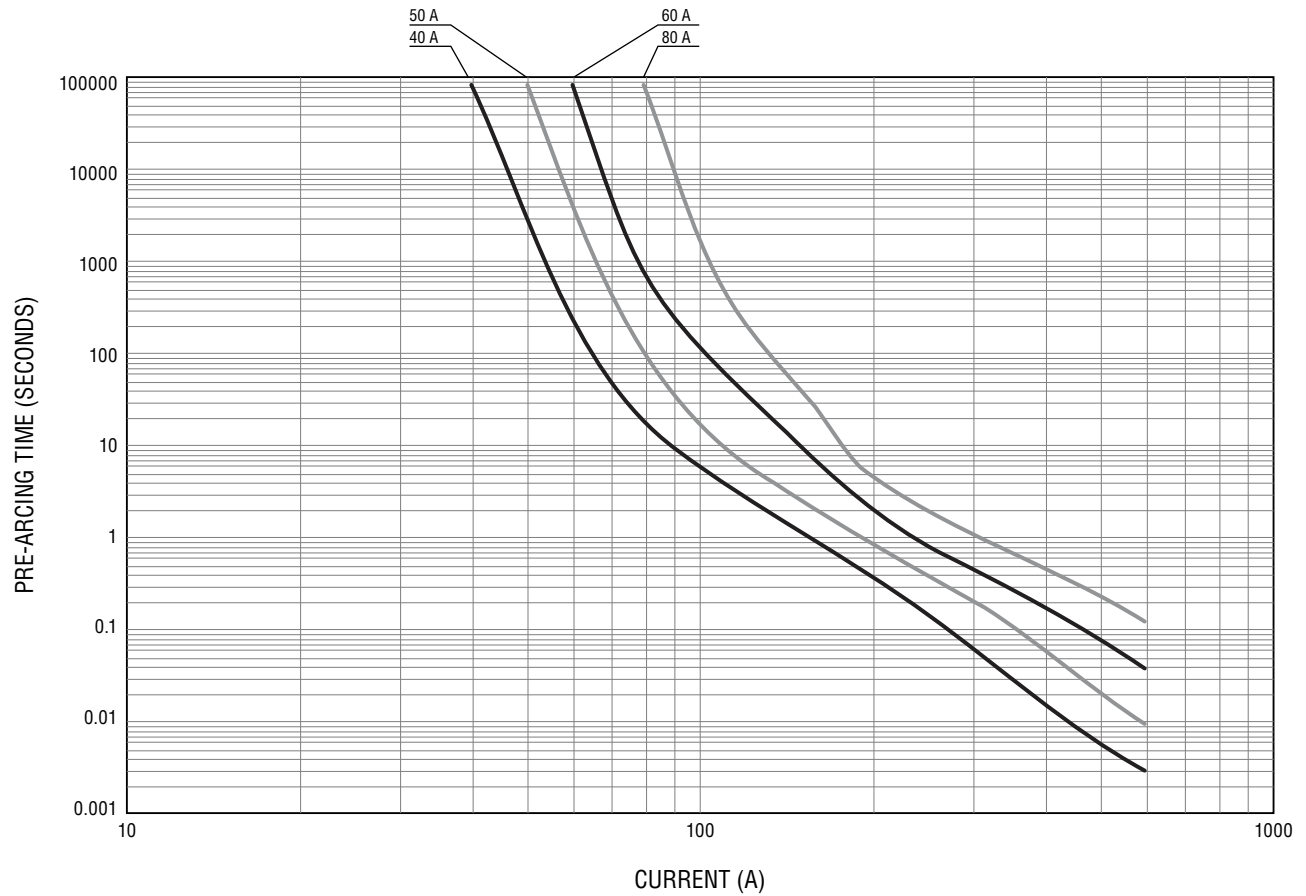

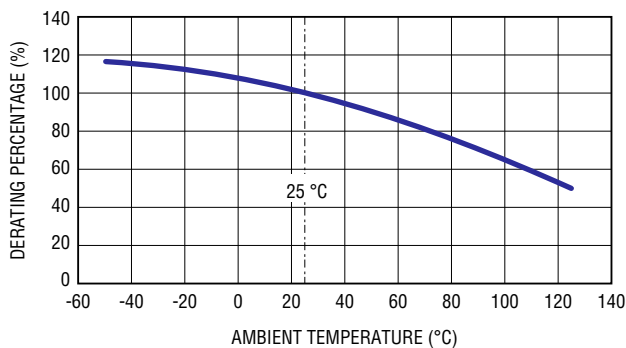
