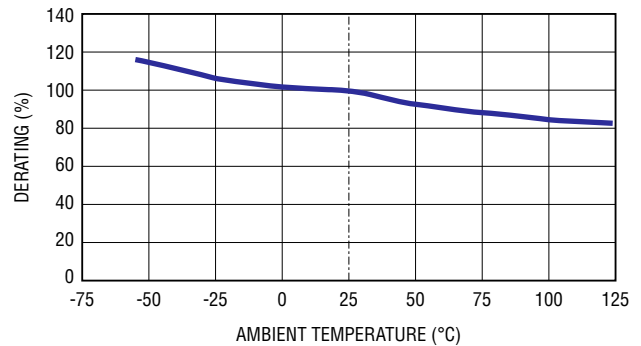

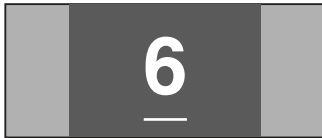

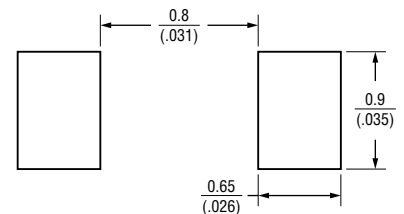

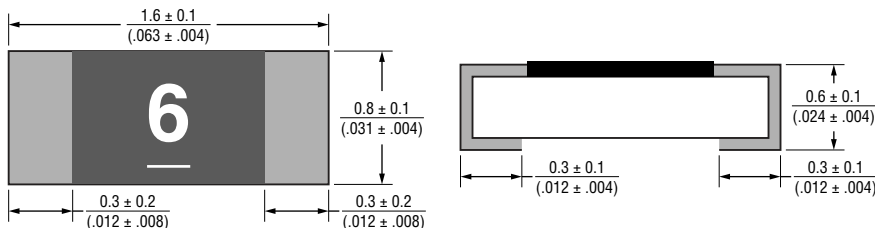

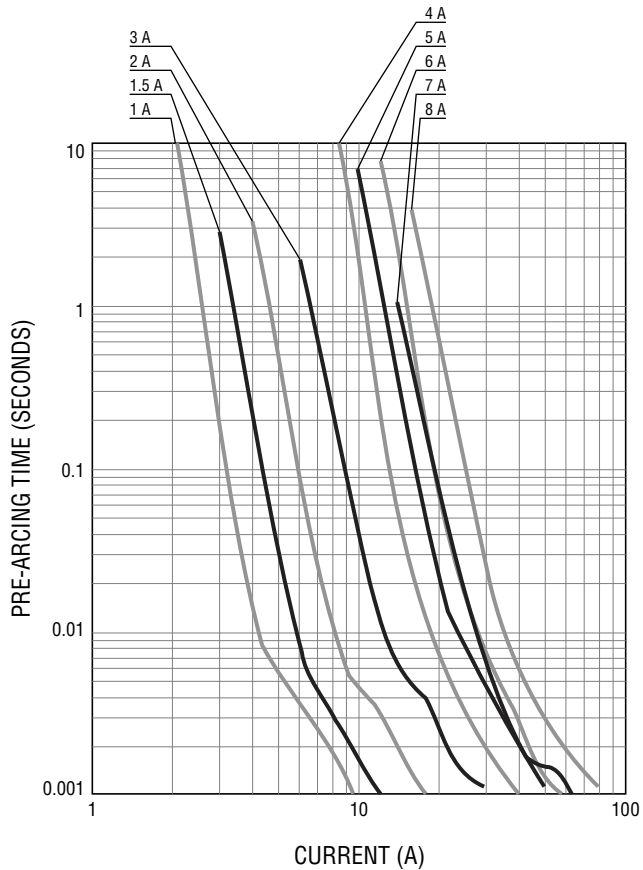

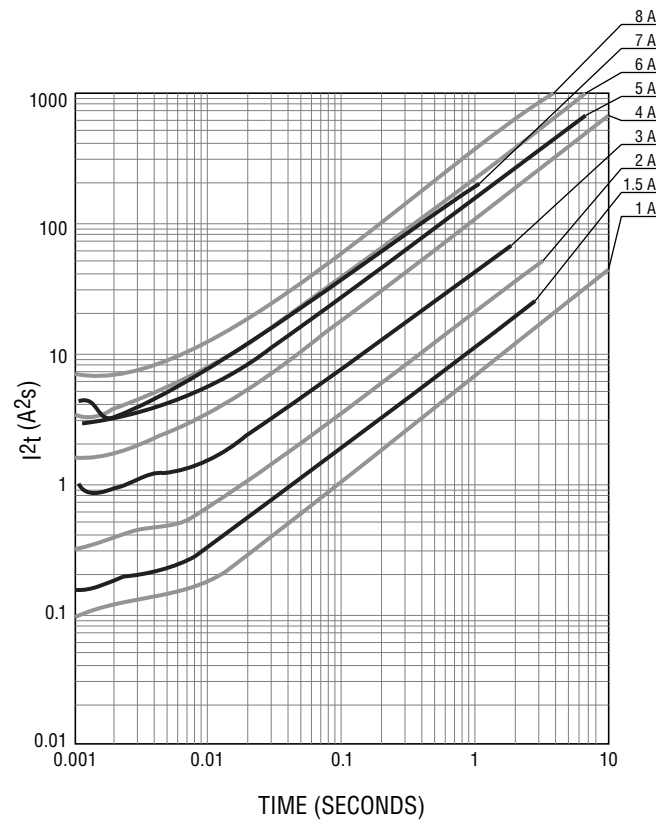

**Average  $I^2t$  vs.  $t$  Curves**

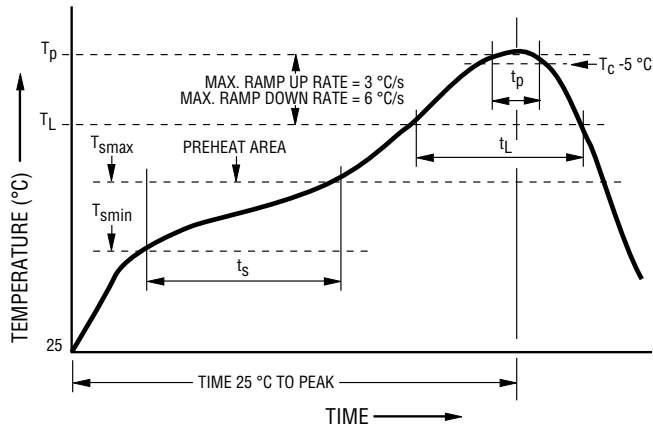
