Package Outline Dimensions

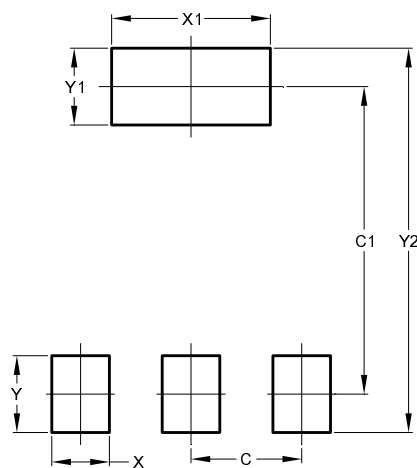
