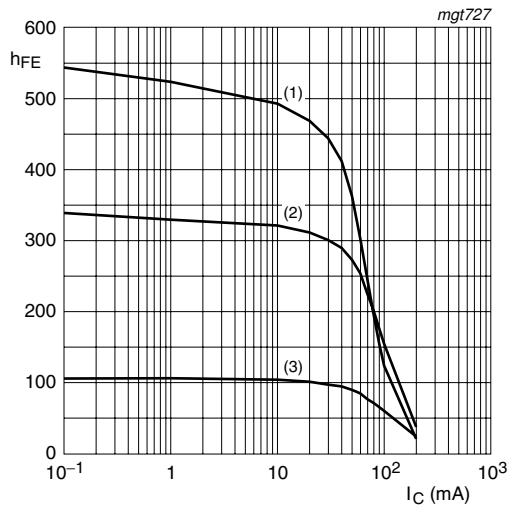

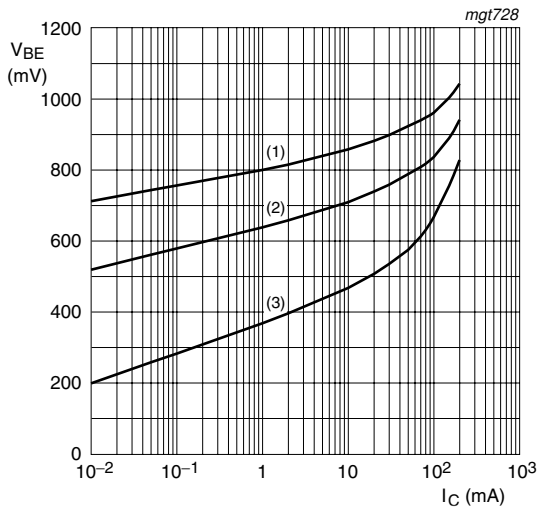

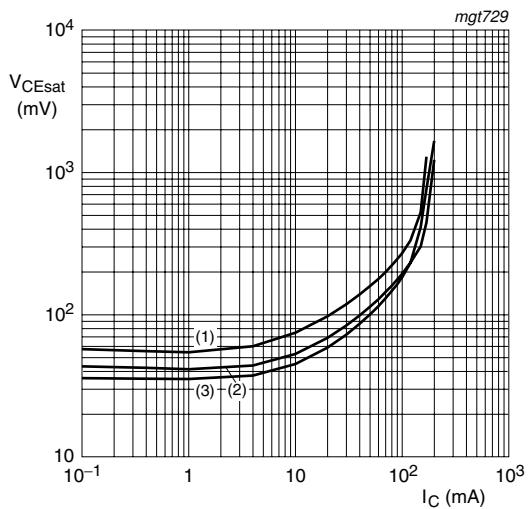

Fig 1. BC848B: DC current gain as a function of collector current; typical values



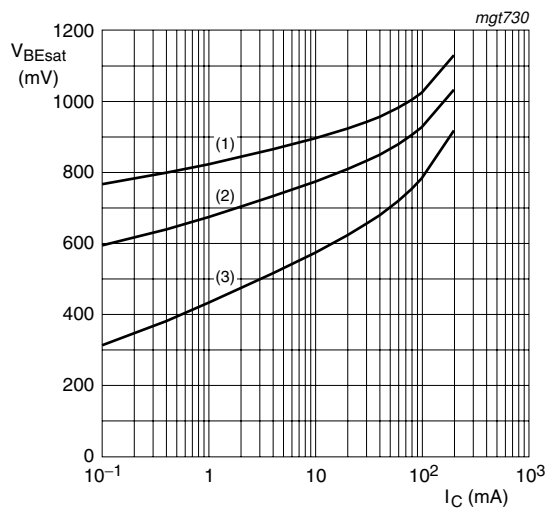

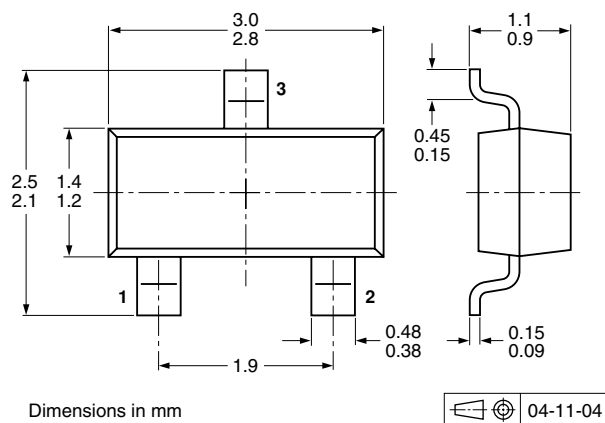


Fig 5. Package outline SOT23 (TO-236AB)

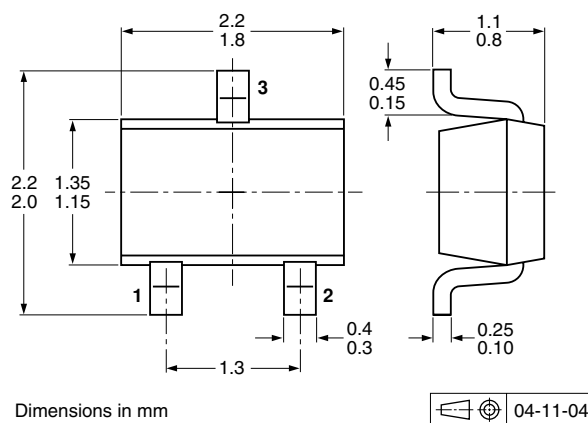
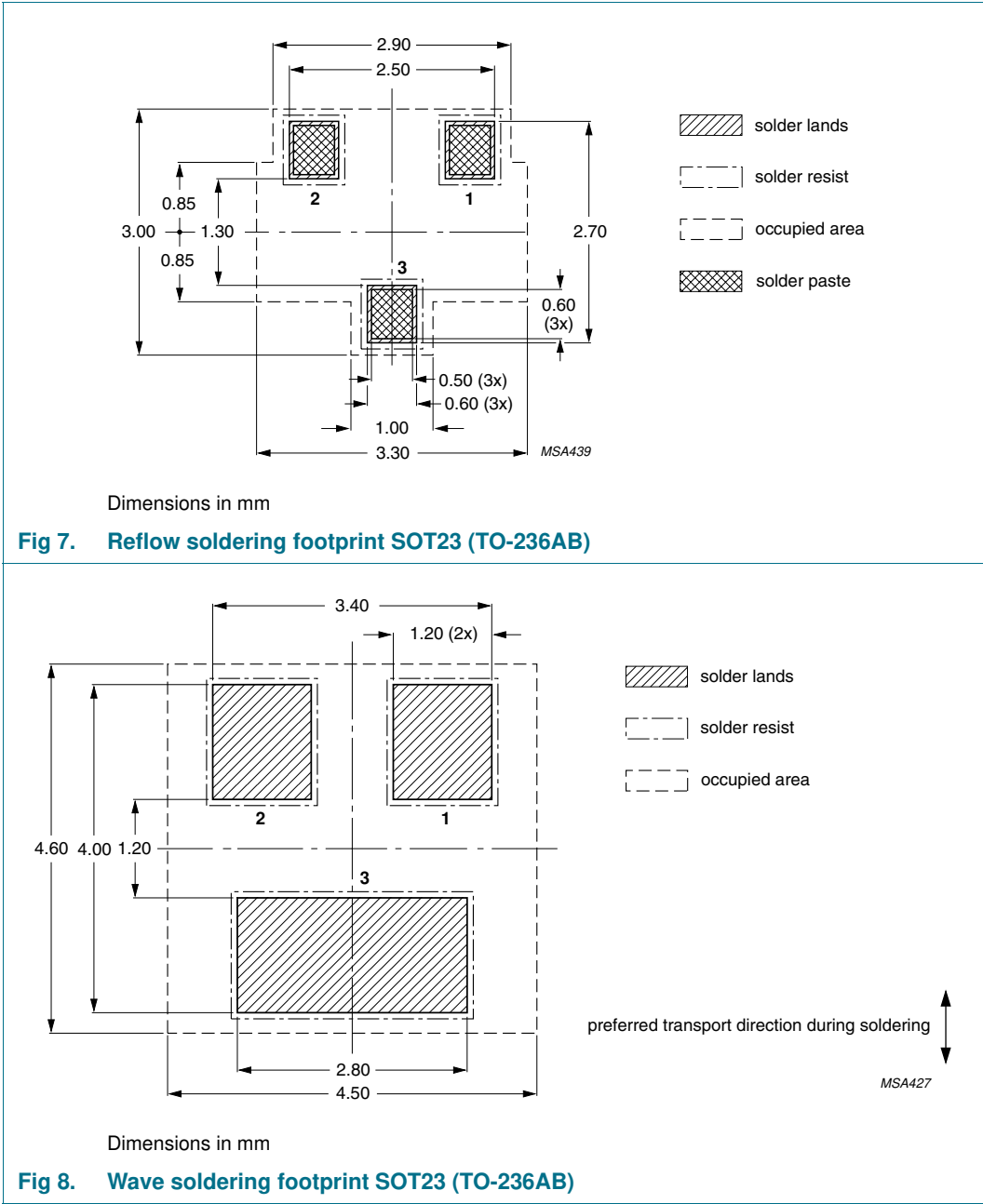


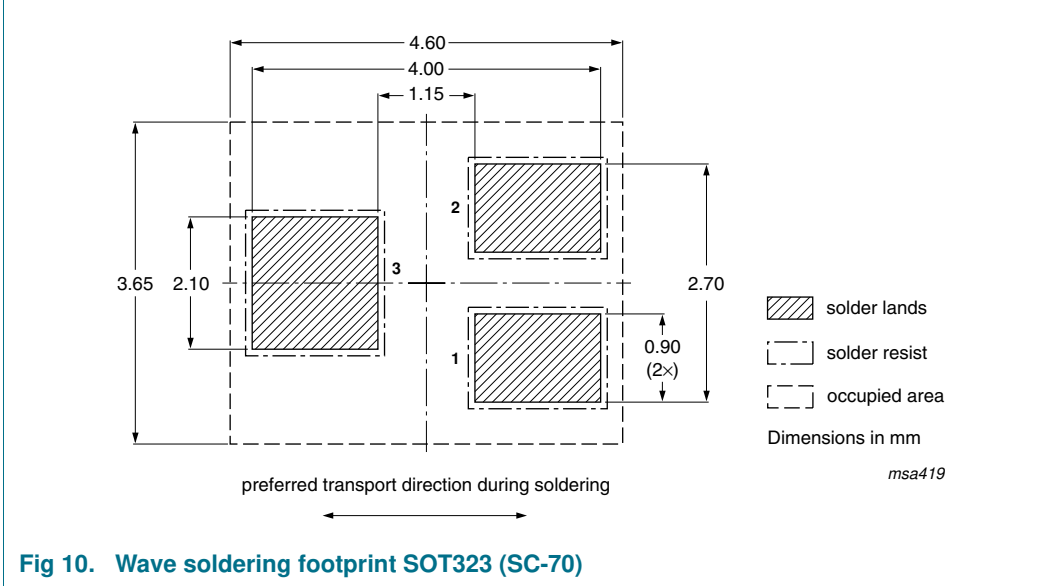
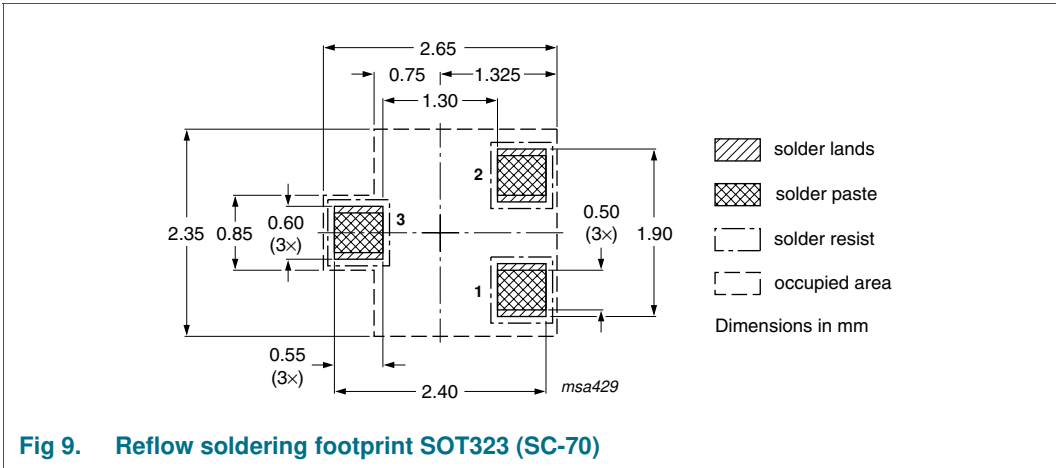
Fig 6. Package outline SOT323 (SC-70)

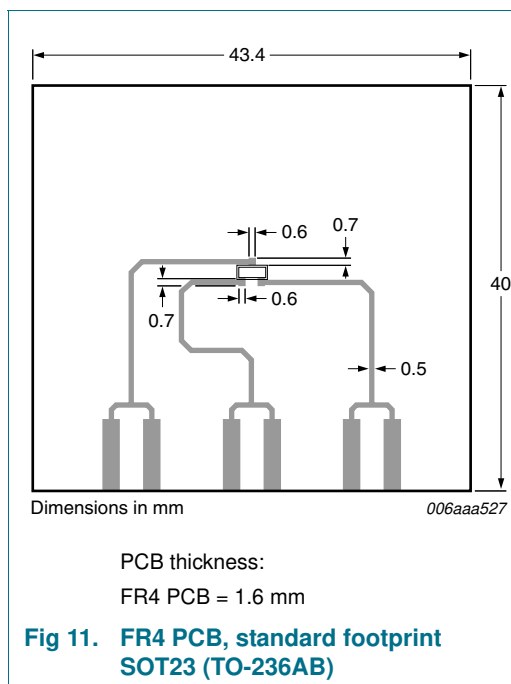


Fig 11. FR4 PCB, standard footprint SOT23 (TO-236AB)

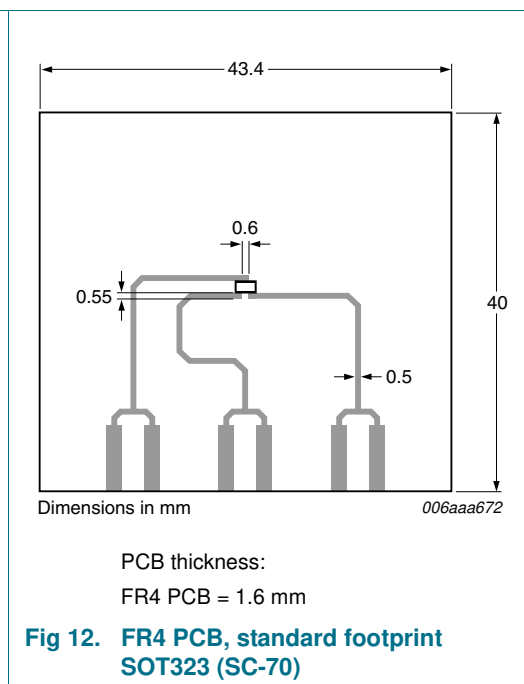


Fig 12. FR4 PCB, standard footprint SOT323 (SC-70)
