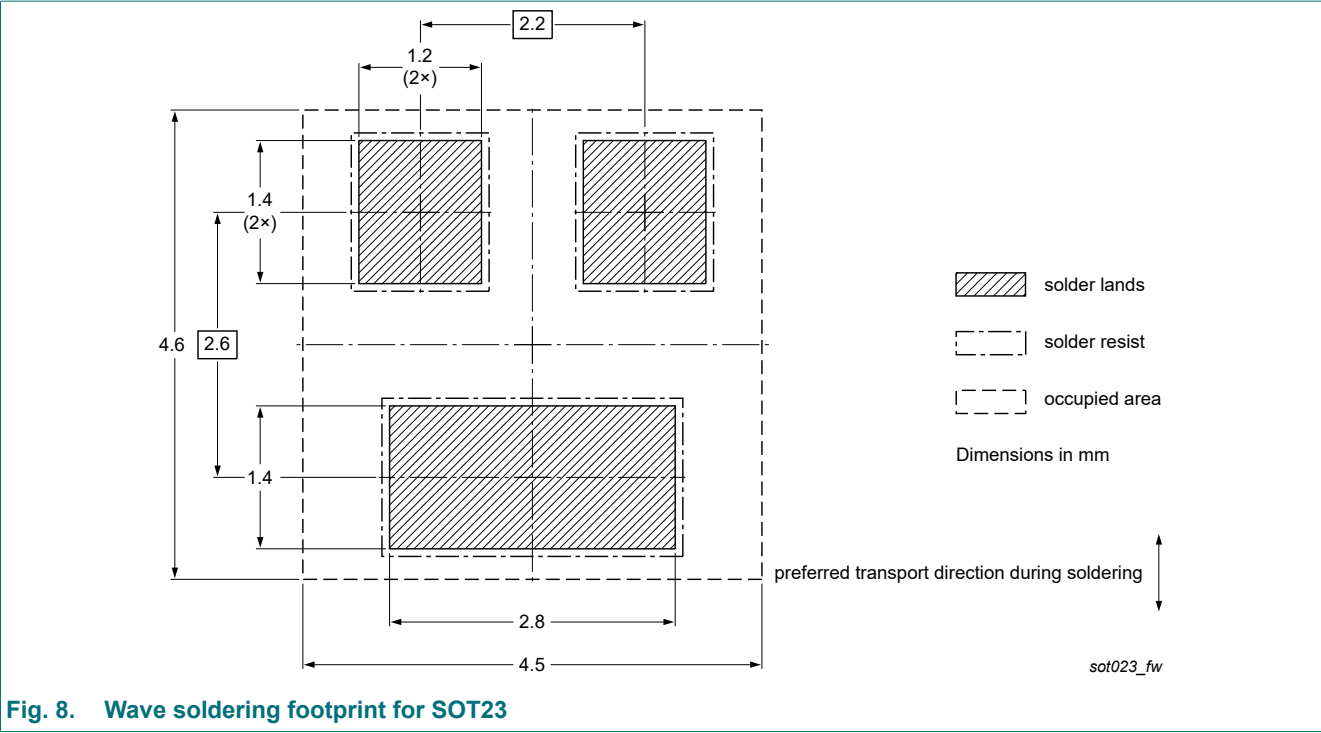


Fig. 8. Wave soldering footprint for SOT23
