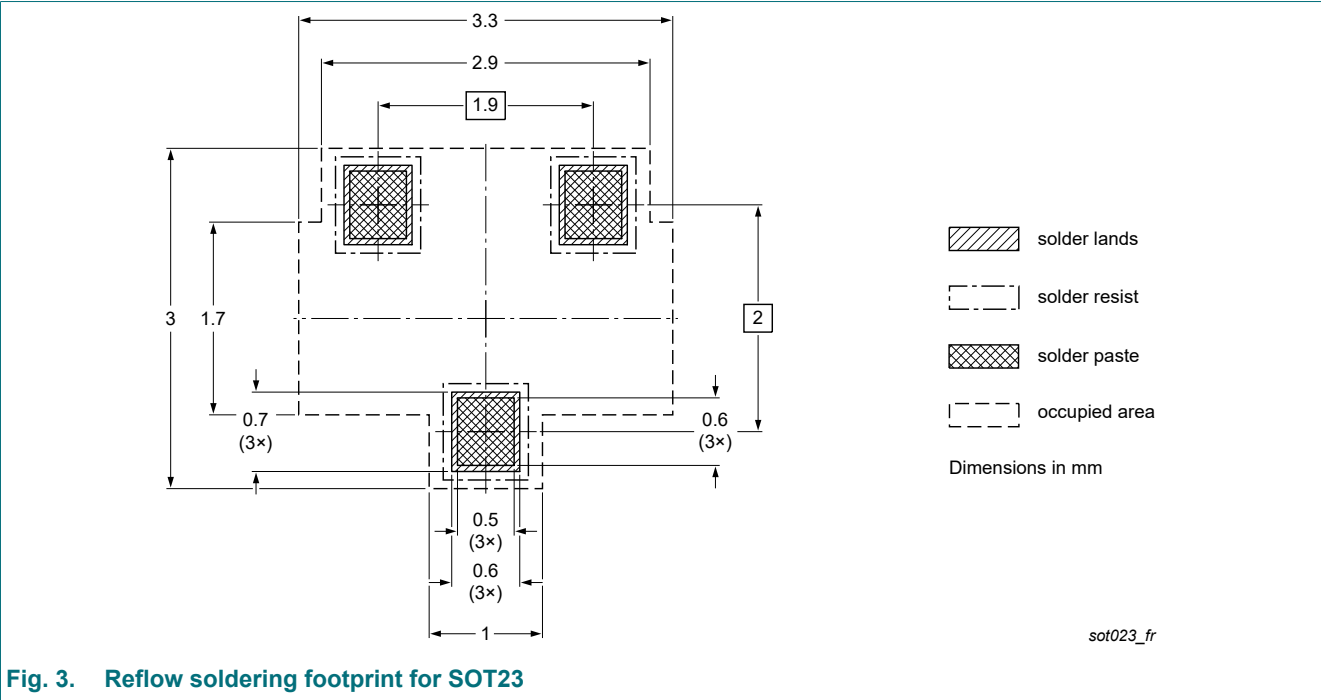

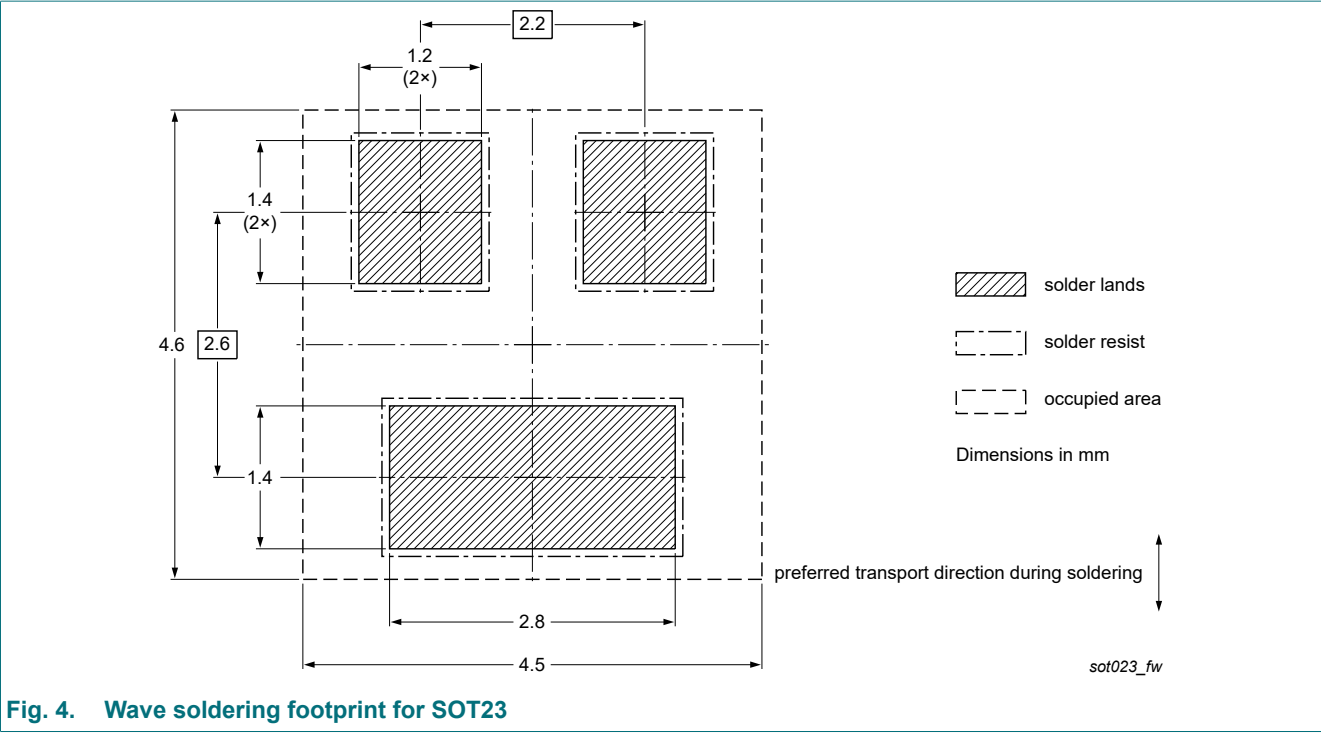


Fig. 4. Wave soldering footprint for SOT23
