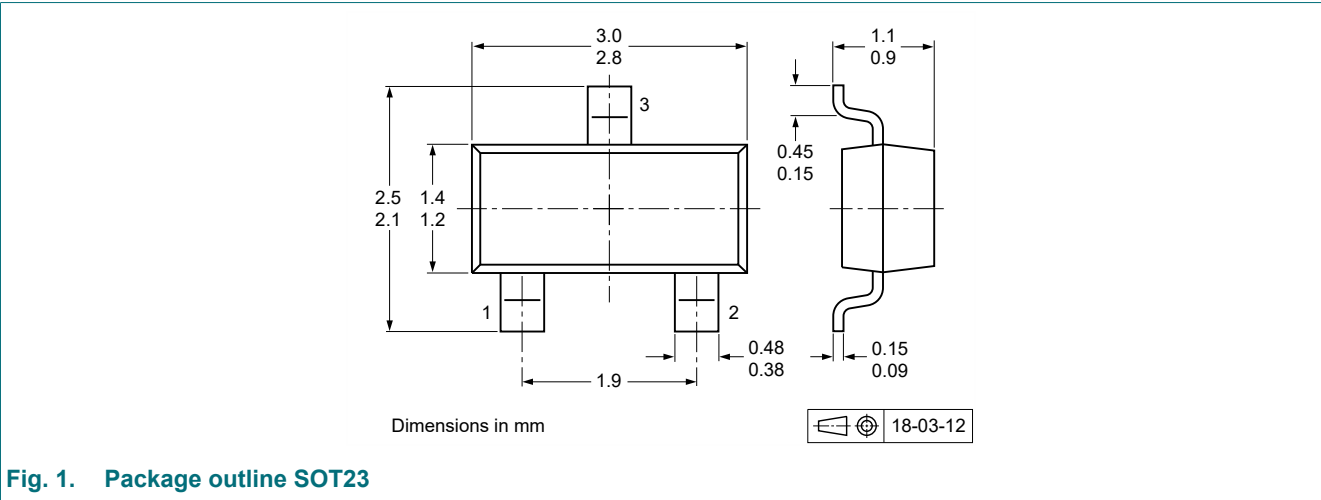
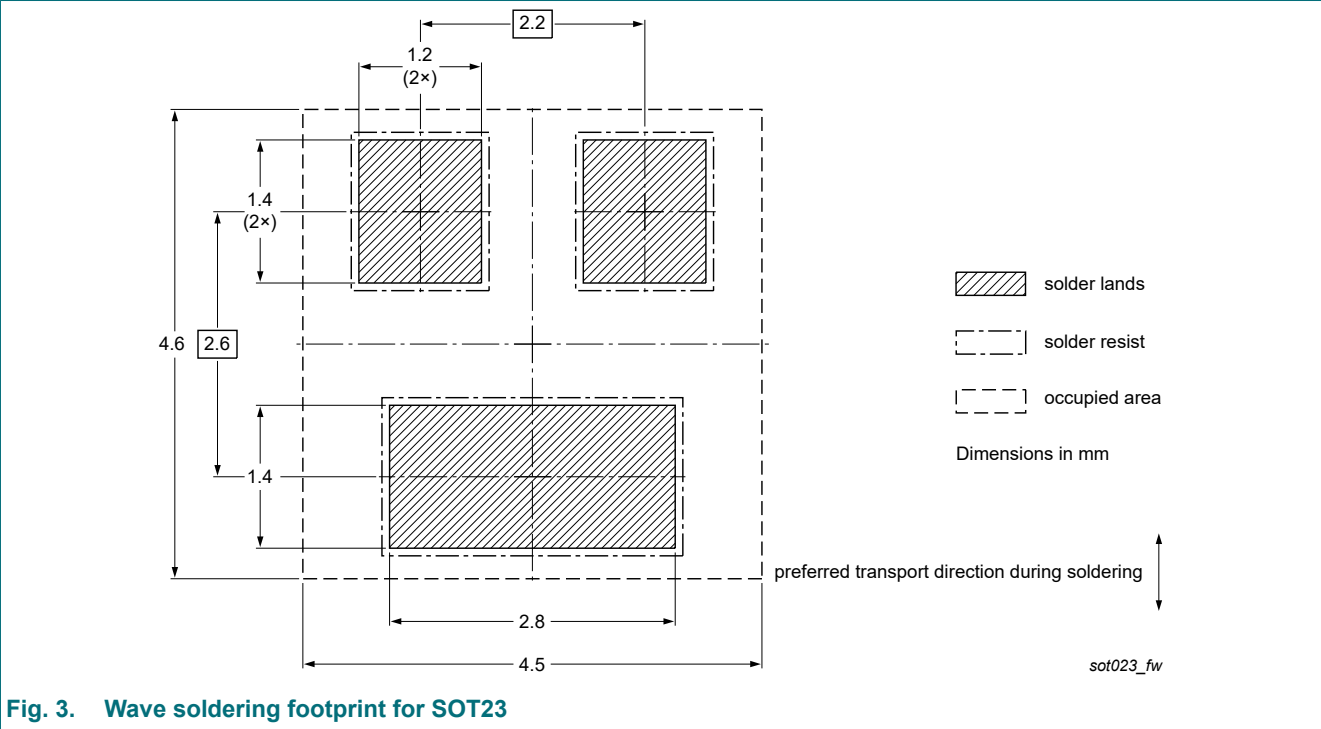
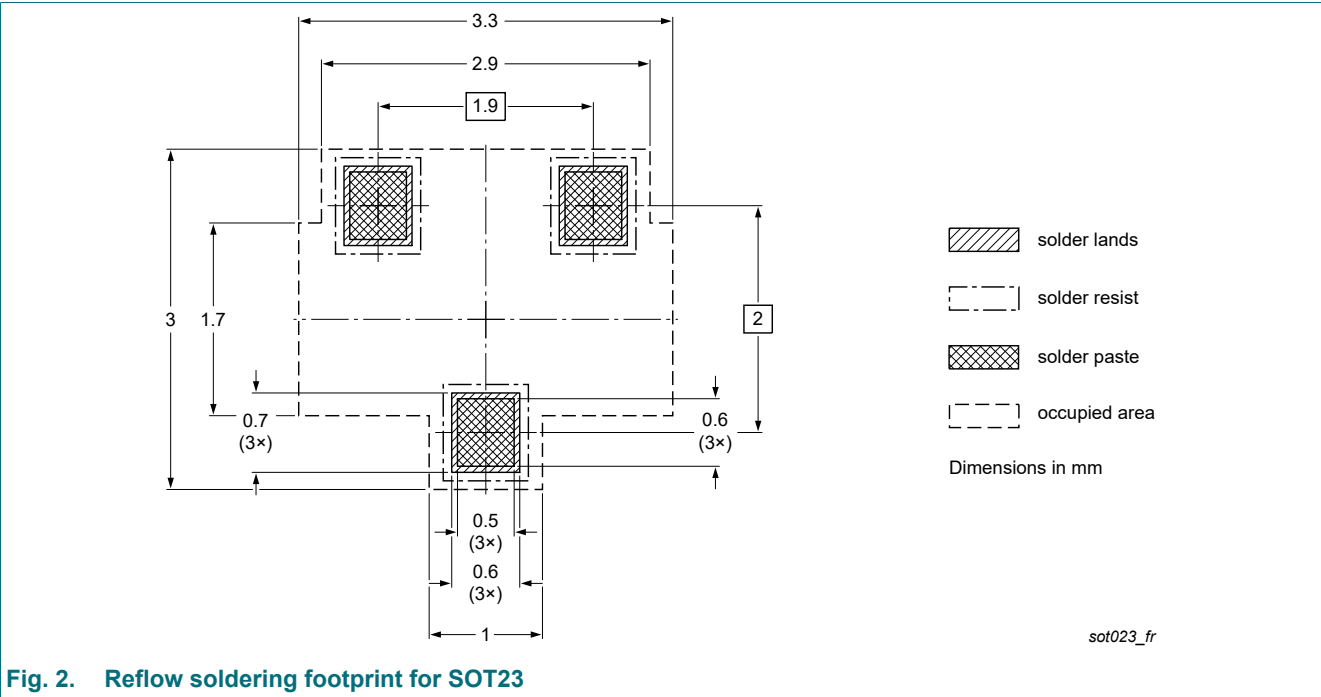


Fig. 1. Package outline SOT23
