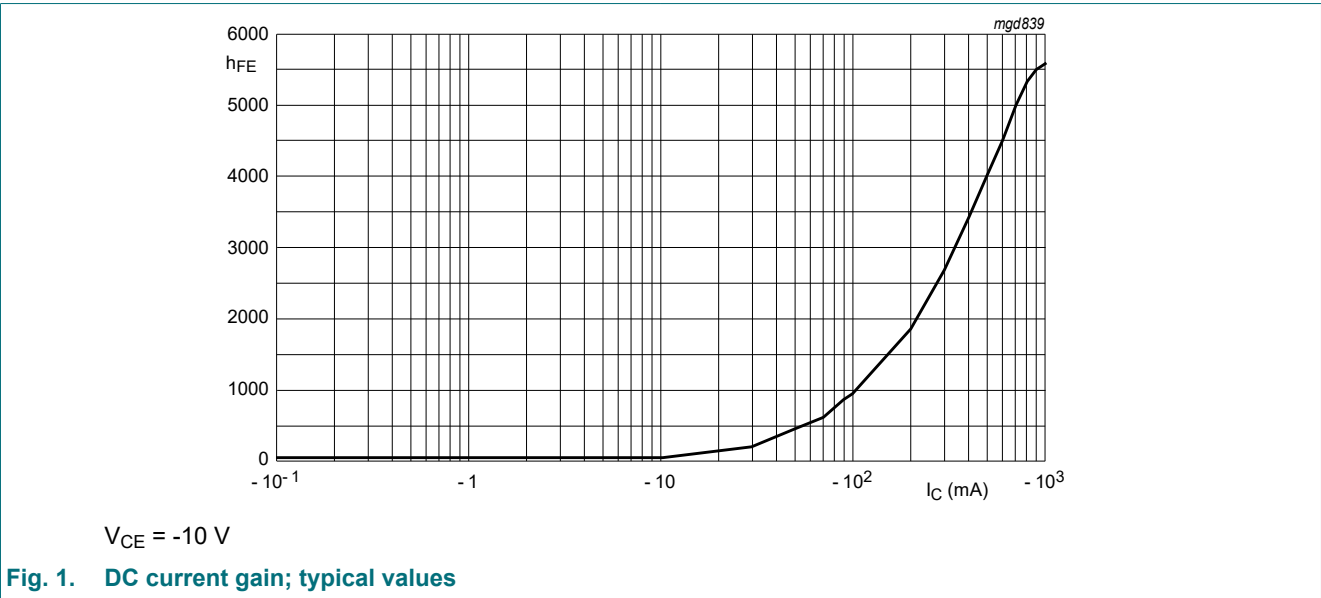

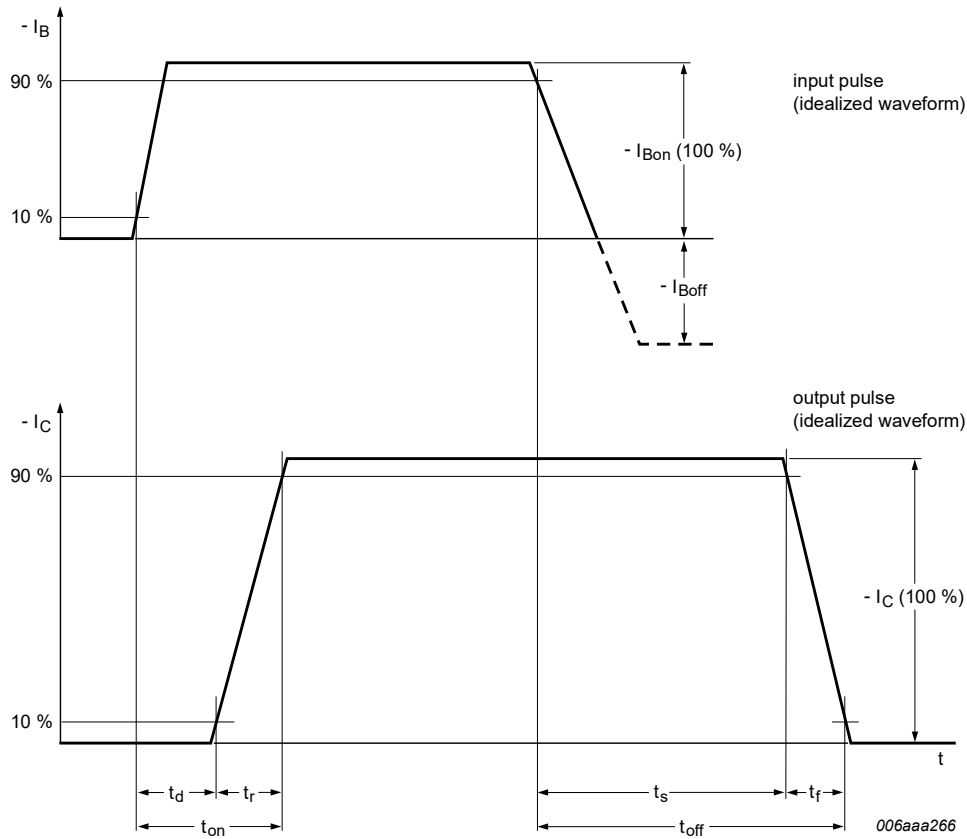


Fig. 2. Transistor switching time definition

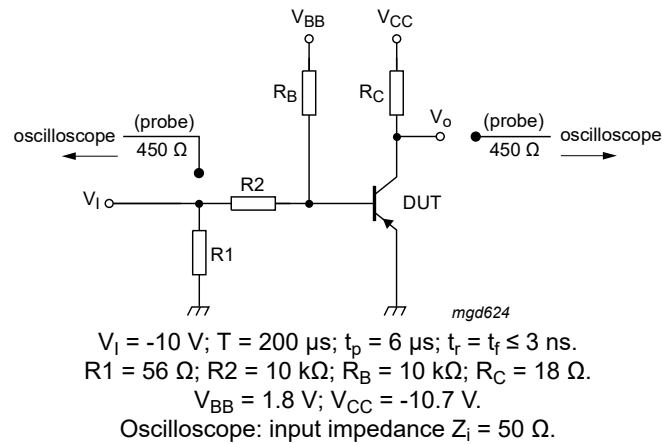


Fig. 3. Test circuit for switching times

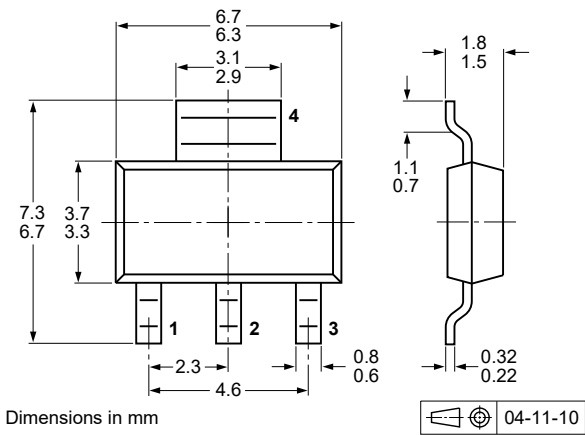


Fig. 4. Package outline SC-73 (SOT223)

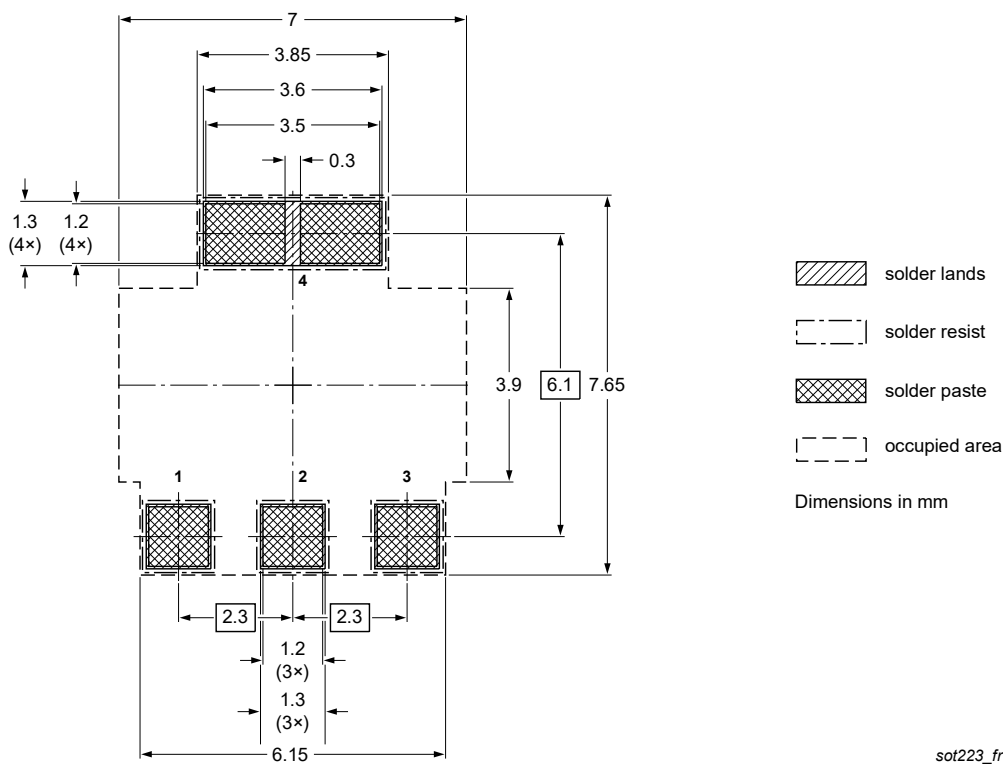


Fig. 5. Reflow soldering footprint for SC-73 (SOT223)

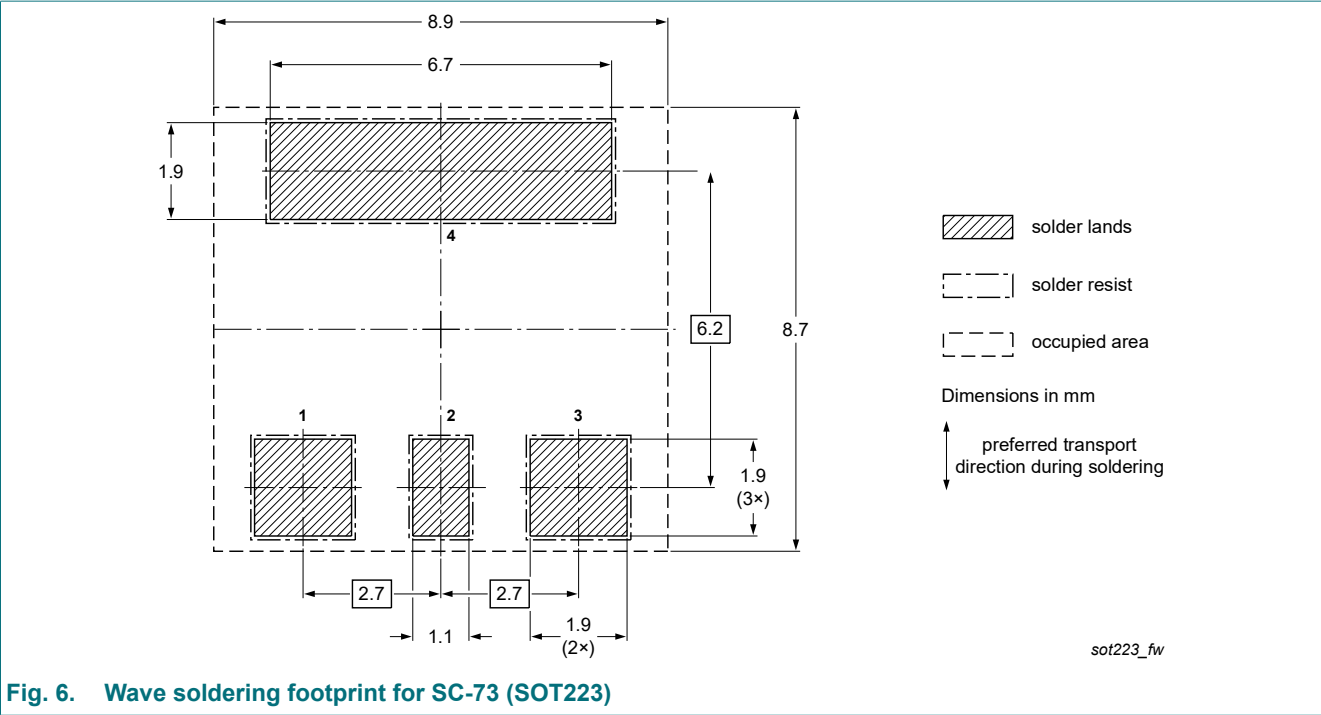


Fig. 6. Wave soldering footprint for SC-73 (SOT223)
