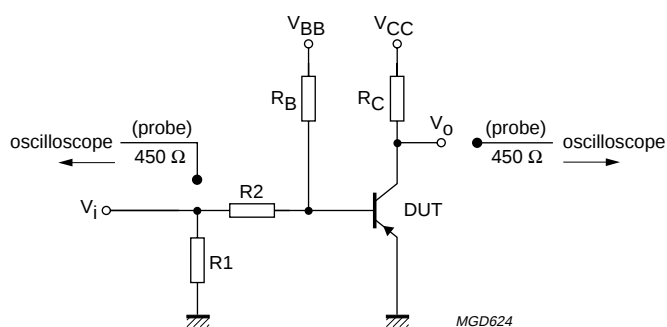

Fig.3 Test circuit for switching times.

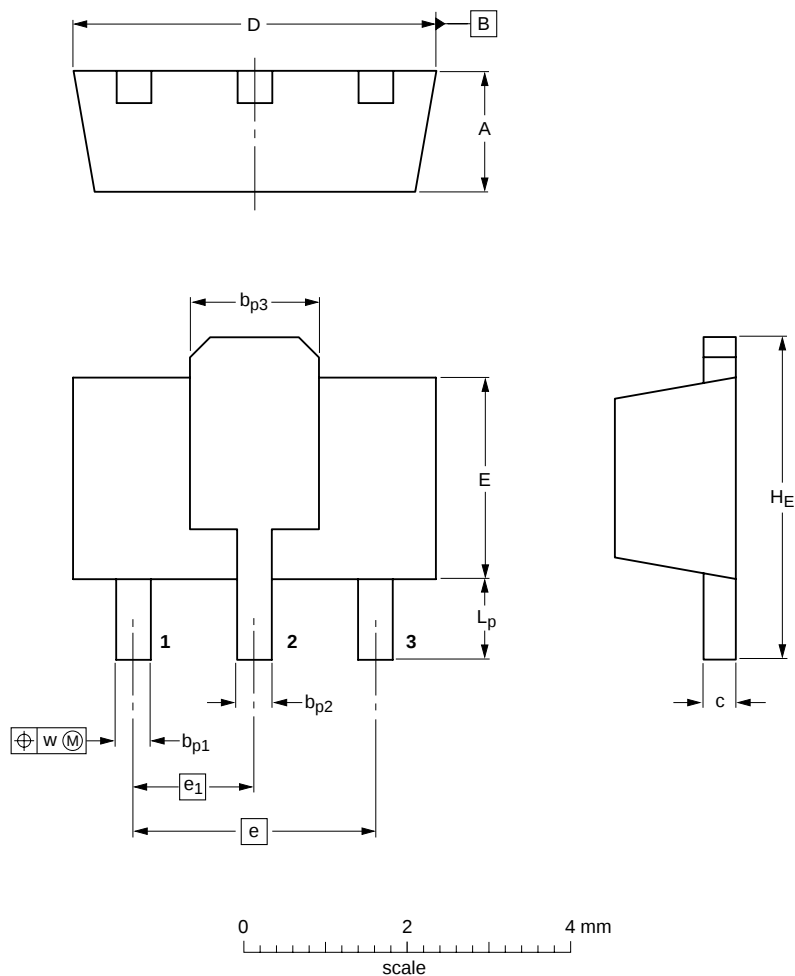
