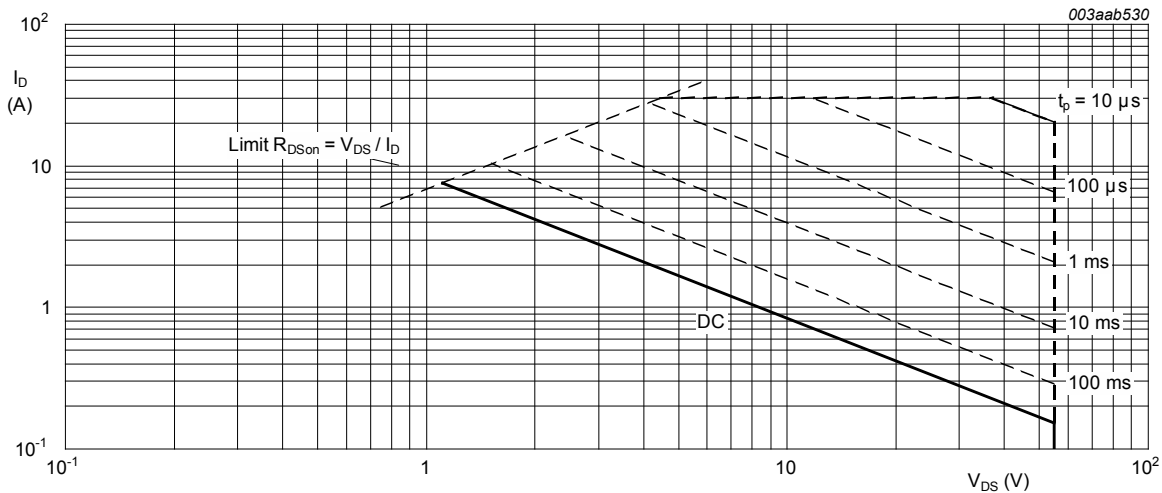


Fig. 3. Safe operating area; continuous and peak drain currents as a function of drain-source voltage

$T_{sp} = 25\text{ }^{\circ}\text{C}$; I_{DM} is single pulse

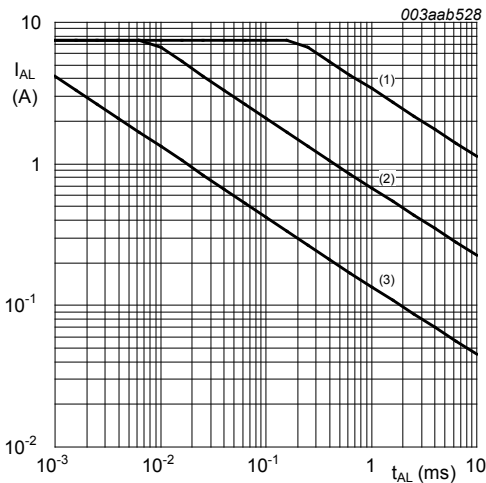


Fig. 4. Single-pulse and repetitive avalanche rating; avalanche current as a function of avalanche time

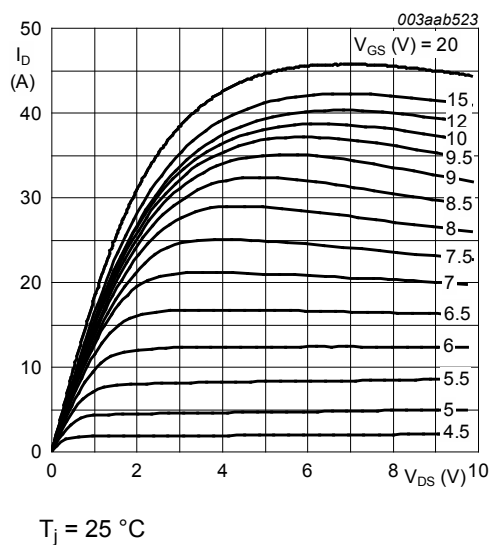


Fig. 5. Output characteristics: drain current as a function of drain-source voltage; typical values

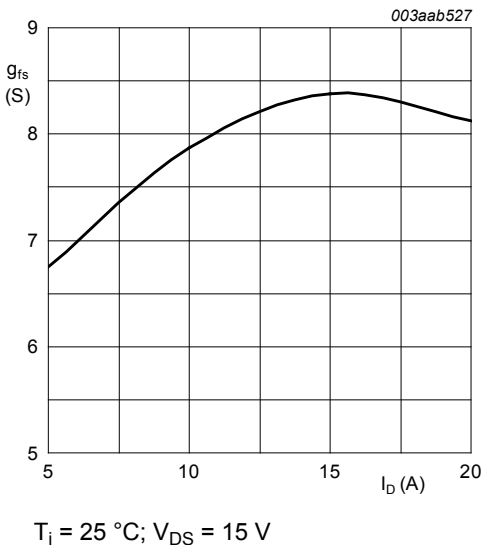


Fig. 6. Forward transconductance as a function of drain current; typical values

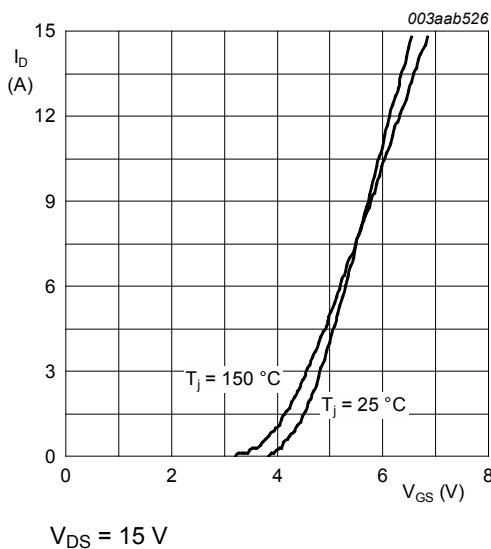


Fig. 7. Transfer characteristics: drain current as a function of gate-source voltage; typical values

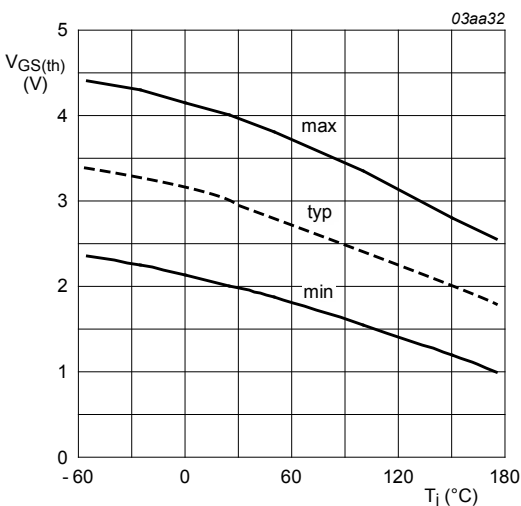


Fig. 8. Gate-source threshold voltage as a function of junction temperature

$I_D = 1\text{ mA}; V_{DS} = V_{GS}$

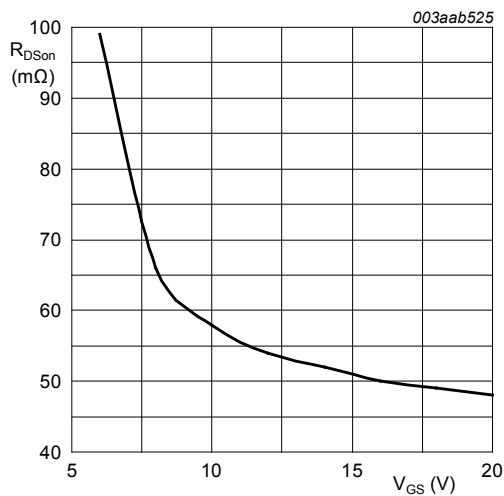


Fig. 9. Drain-source on-state resistance as a function of gate-source voltage; typical values

$$T_j = 25\text{ }^{\circ}\text{C}; I_D = 10\text{ A}$$

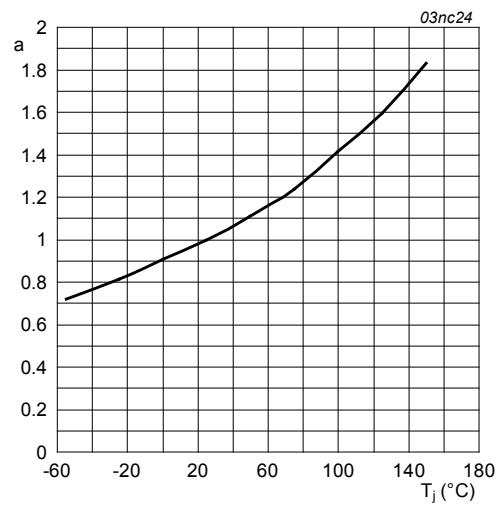


Fig. 10. Normalized drain source on-state resistance factor as a function of junction temperature

$$a = \frac{R_{DS(on)}}{R_{DS(on)25^{\circ}\text{C}}}$$

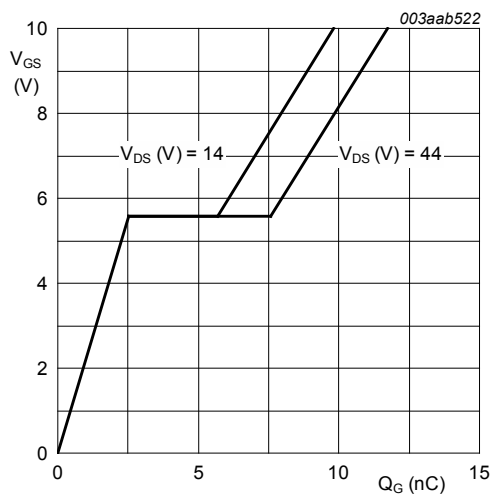


Fig. 11. Gate-source voltage as a function of gate charge; typical values

$$T_j = 25\text{ }^{\circ}\text{C}; I_D = 10\text{ A}$$

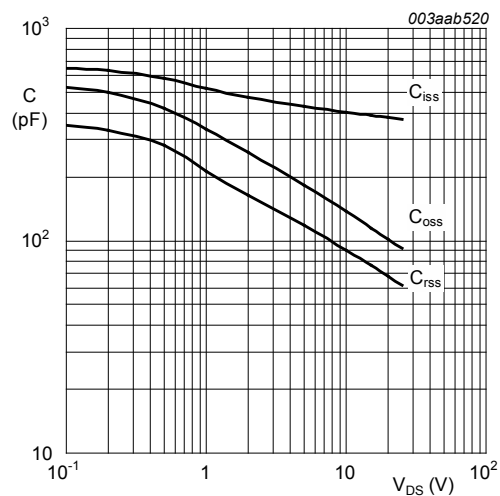


Fig. 12. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

$$V_{GS} = 0\text{ V}; f = 1\text{ MHz}$$

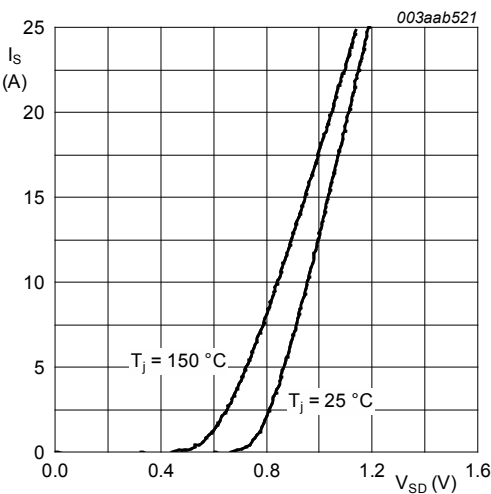
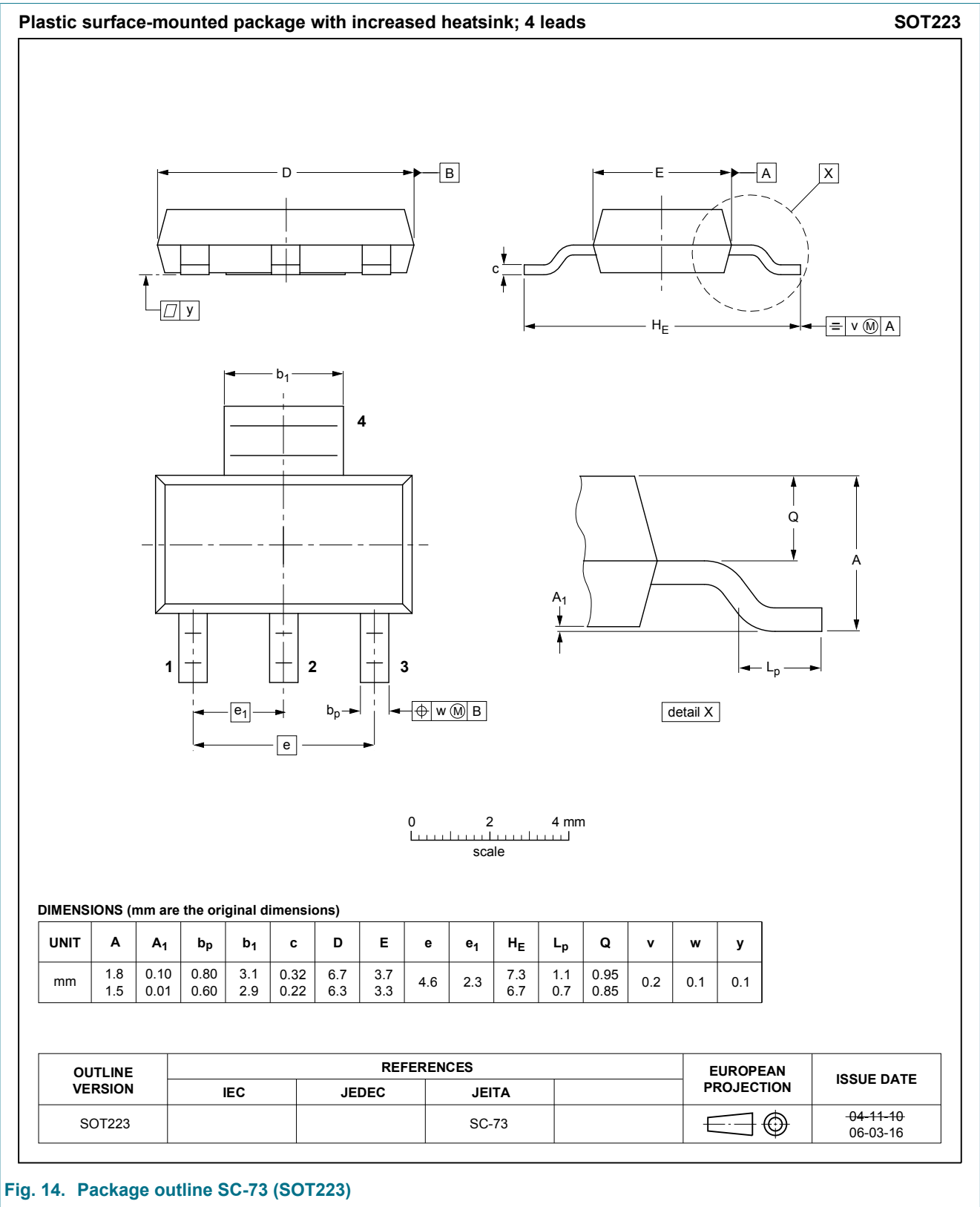


Fig. 13. Source current as a function of source-drain voltage; typical values
