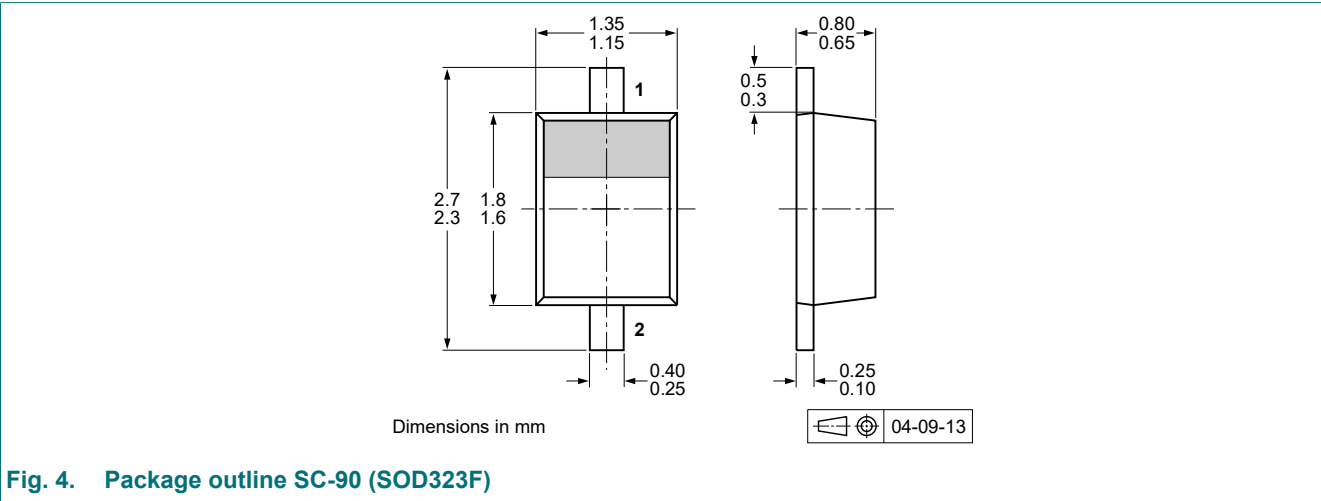
Fig. 3. Diode capacitance as a function of reverse voltage; typical values

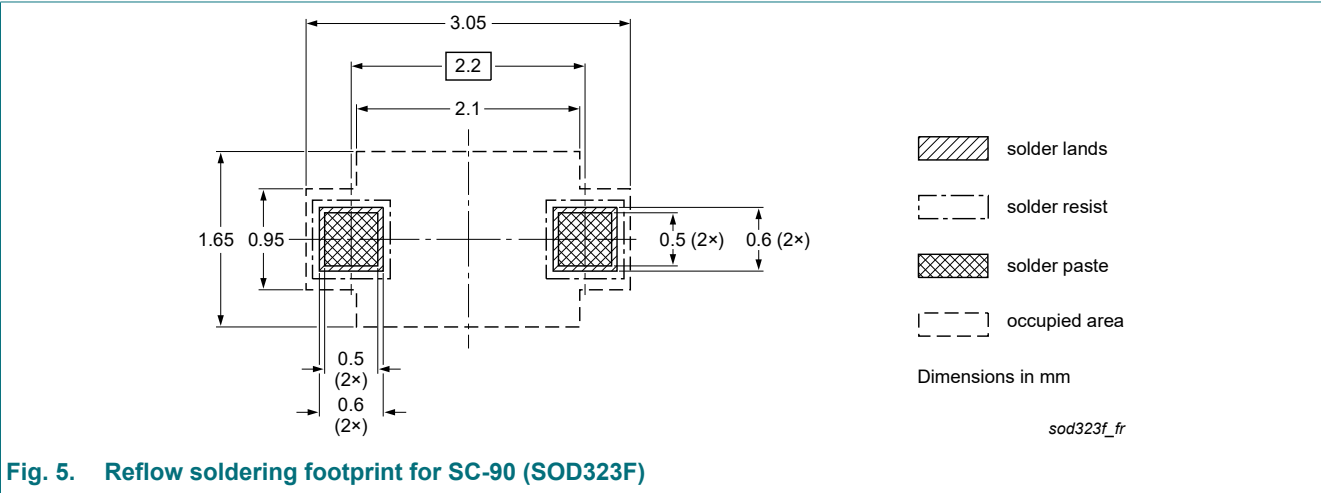
