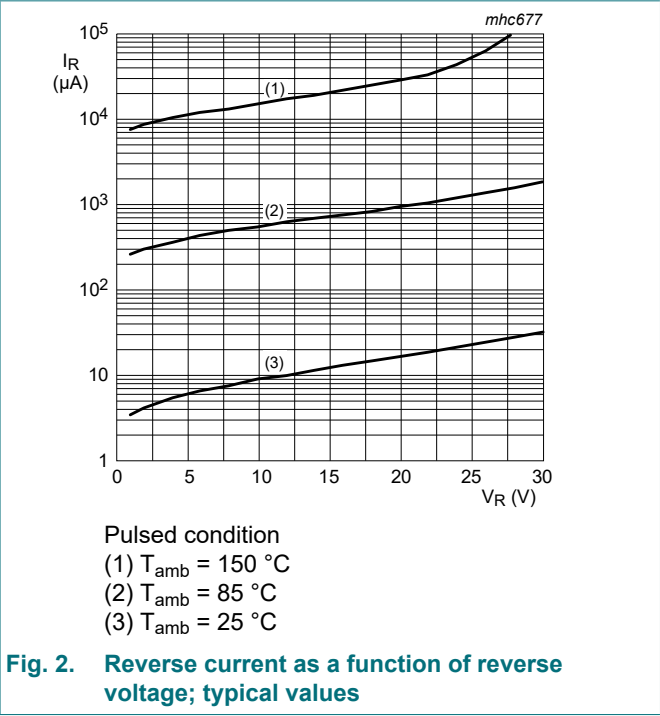
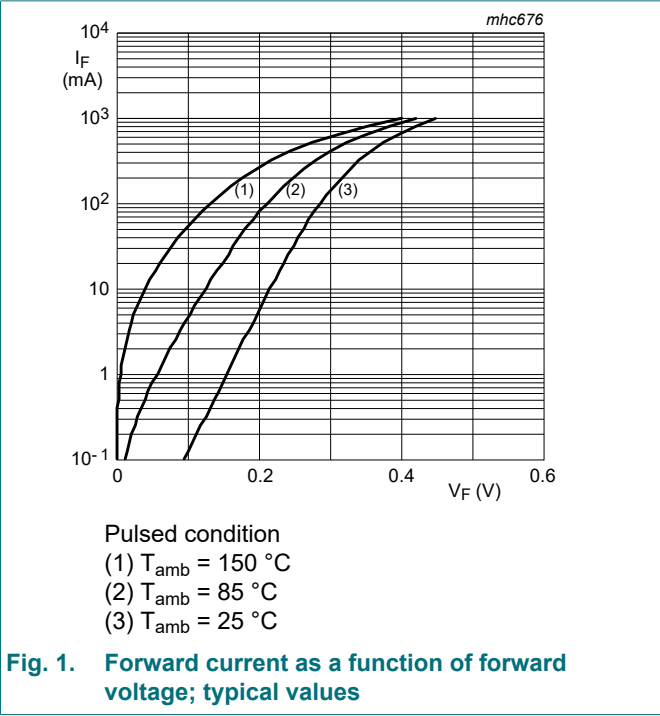

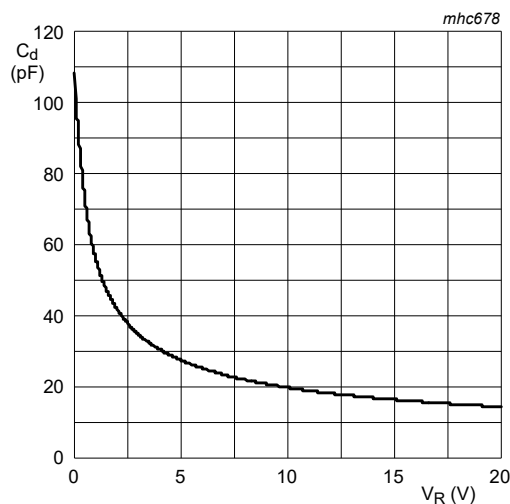

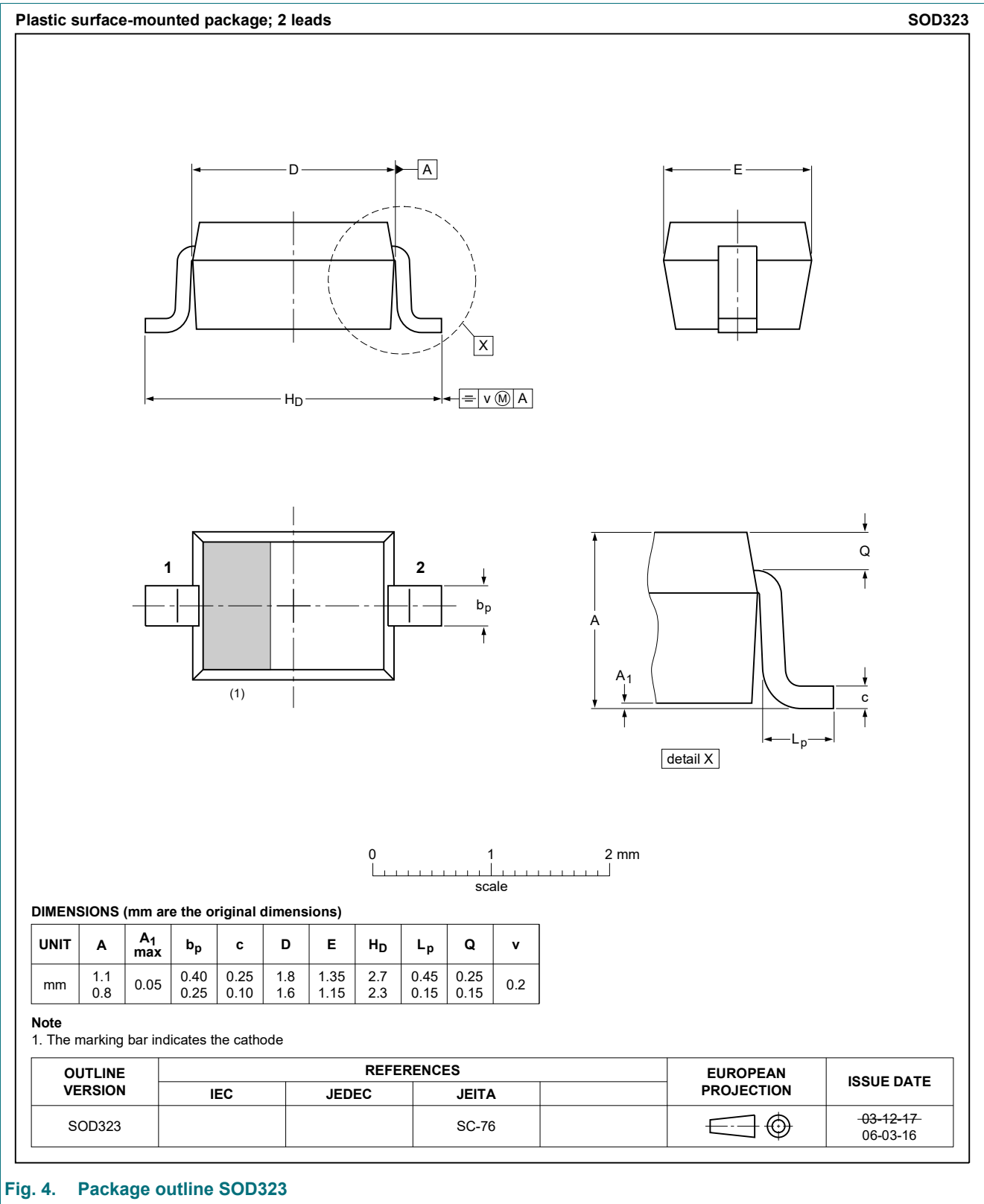


Fig. 4. Package outline SOD323

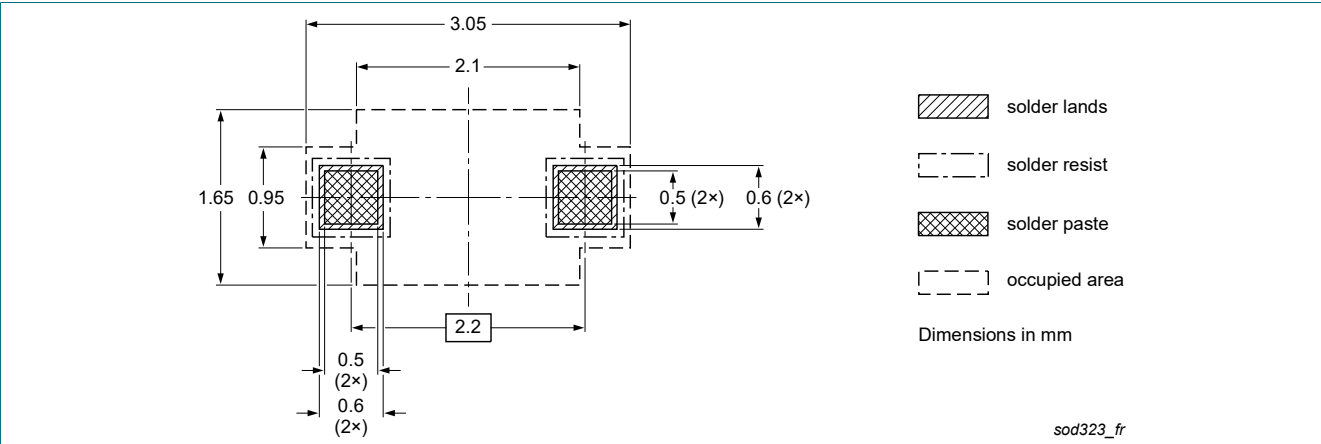


Fig. 5. Reflow soldering footprint for SOD323

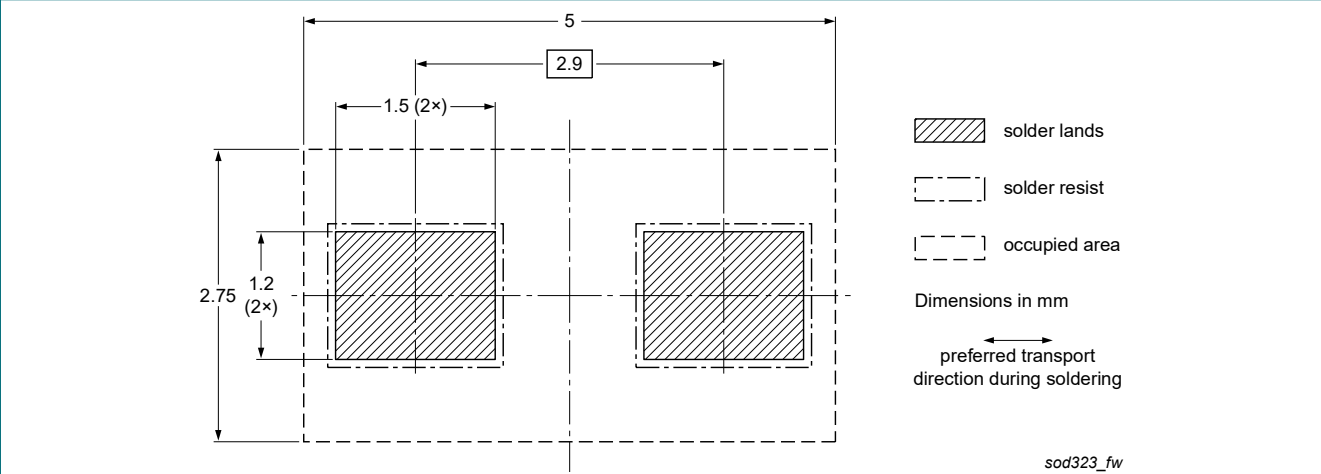


Fig. 6. Wave soldering footprint for SOD323
