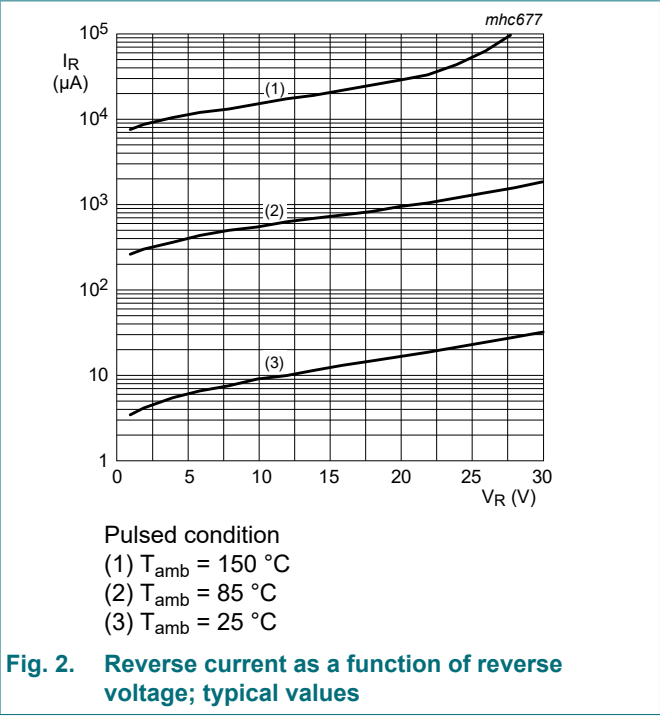

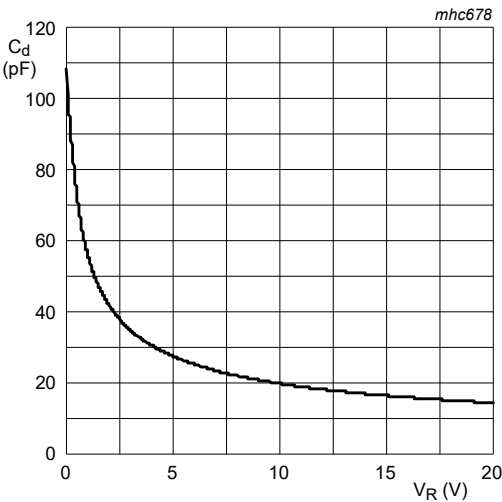

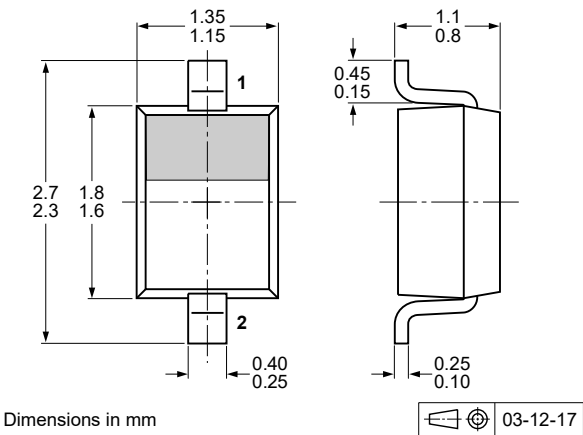
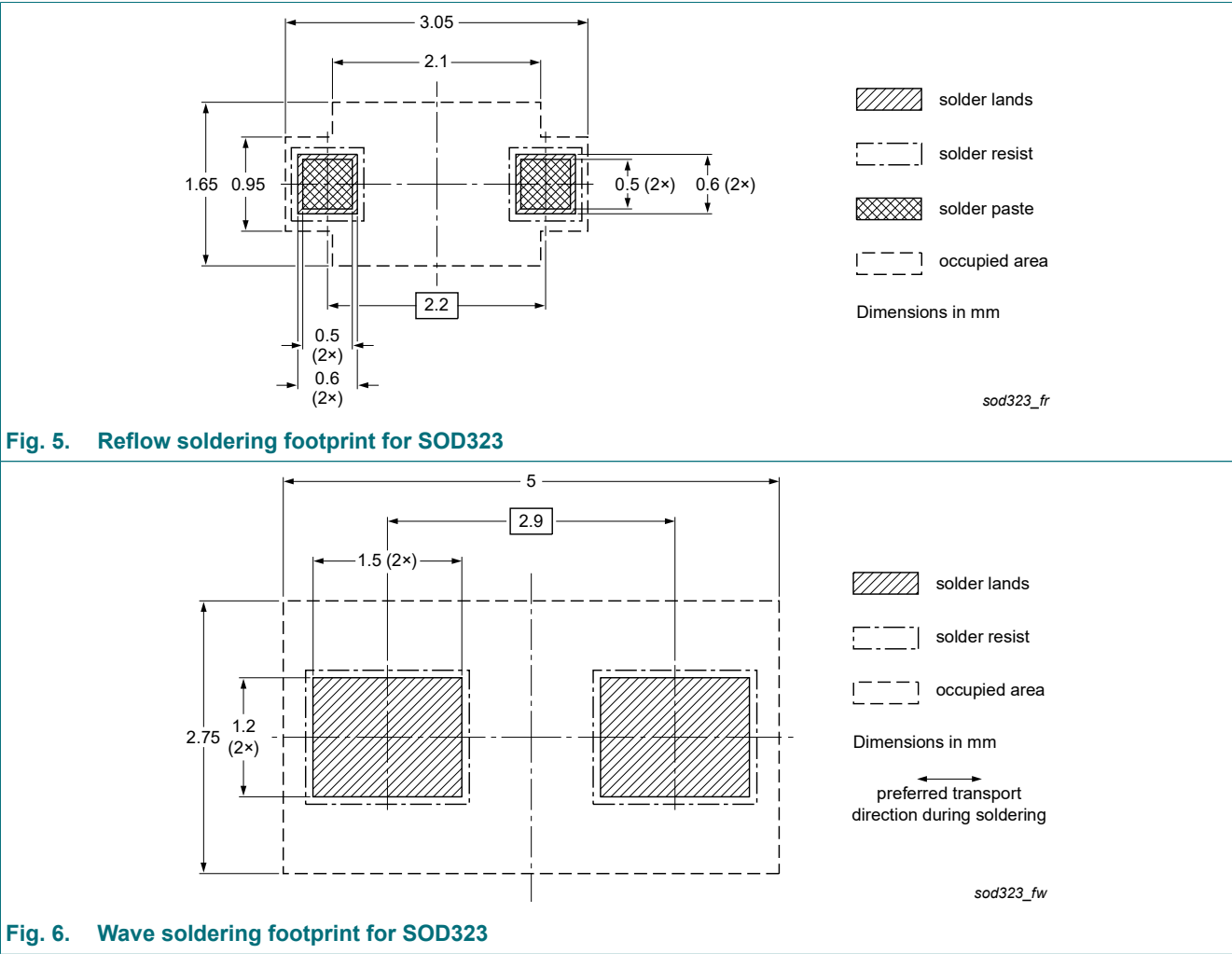


Fig. 4. Package outline SOD323
