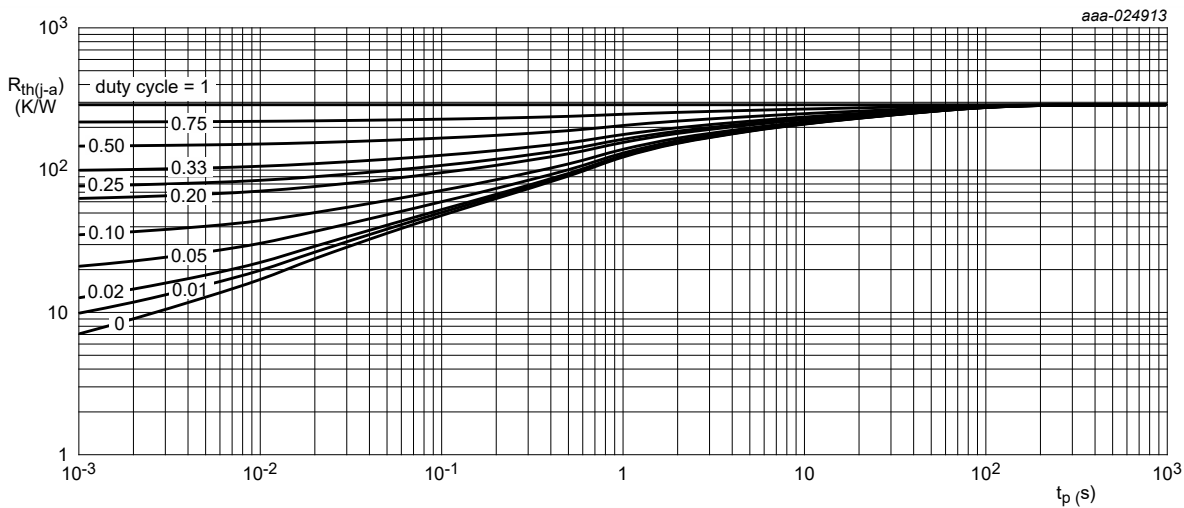

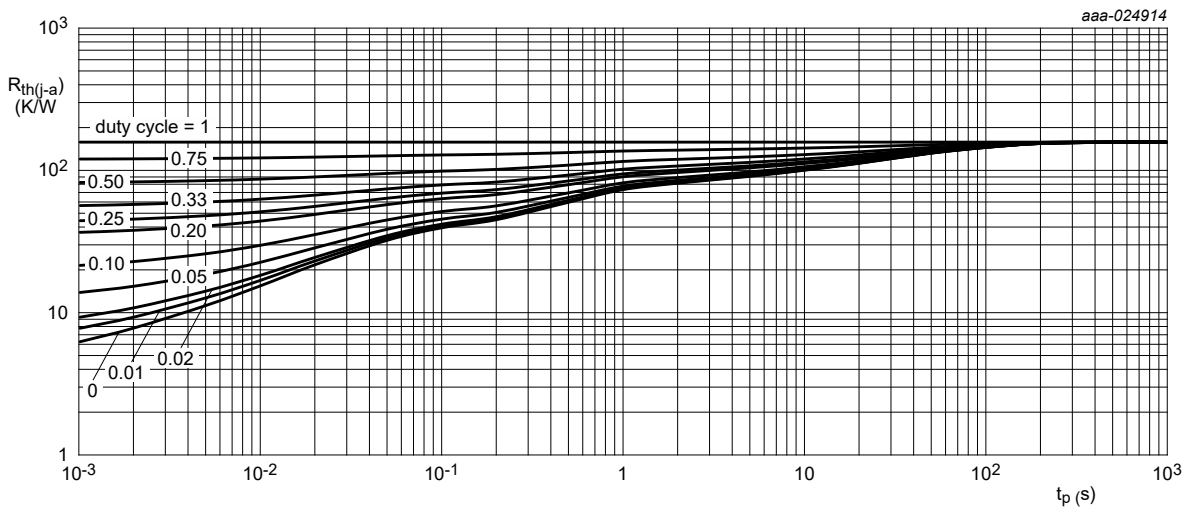

FR4 PCB, mounting pad for cathode 1 cm²

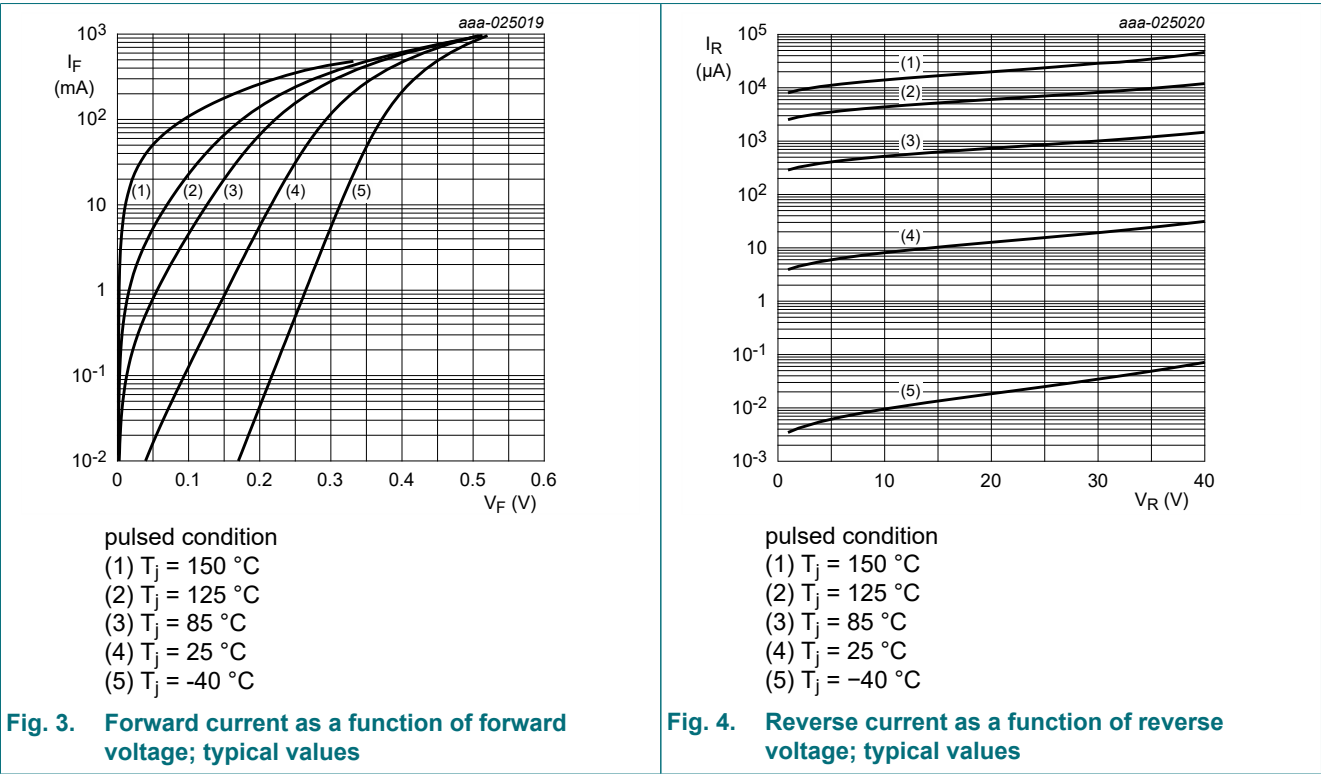
Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

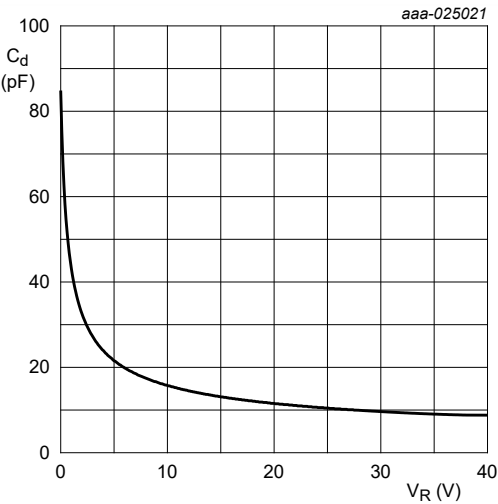

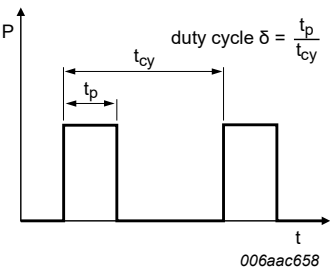


Fig. 6. Duty cycle definition

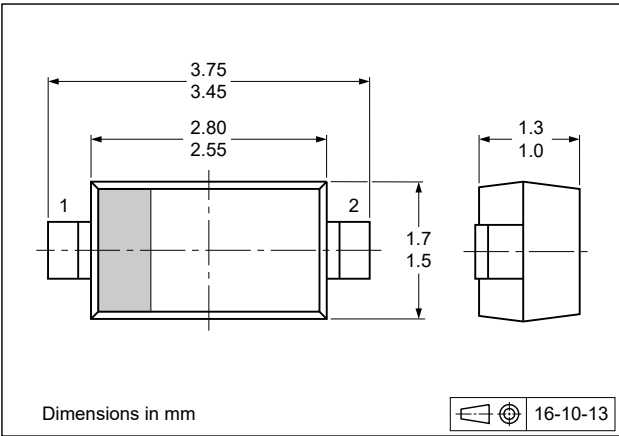


Fig. 7. Package outline SOD123

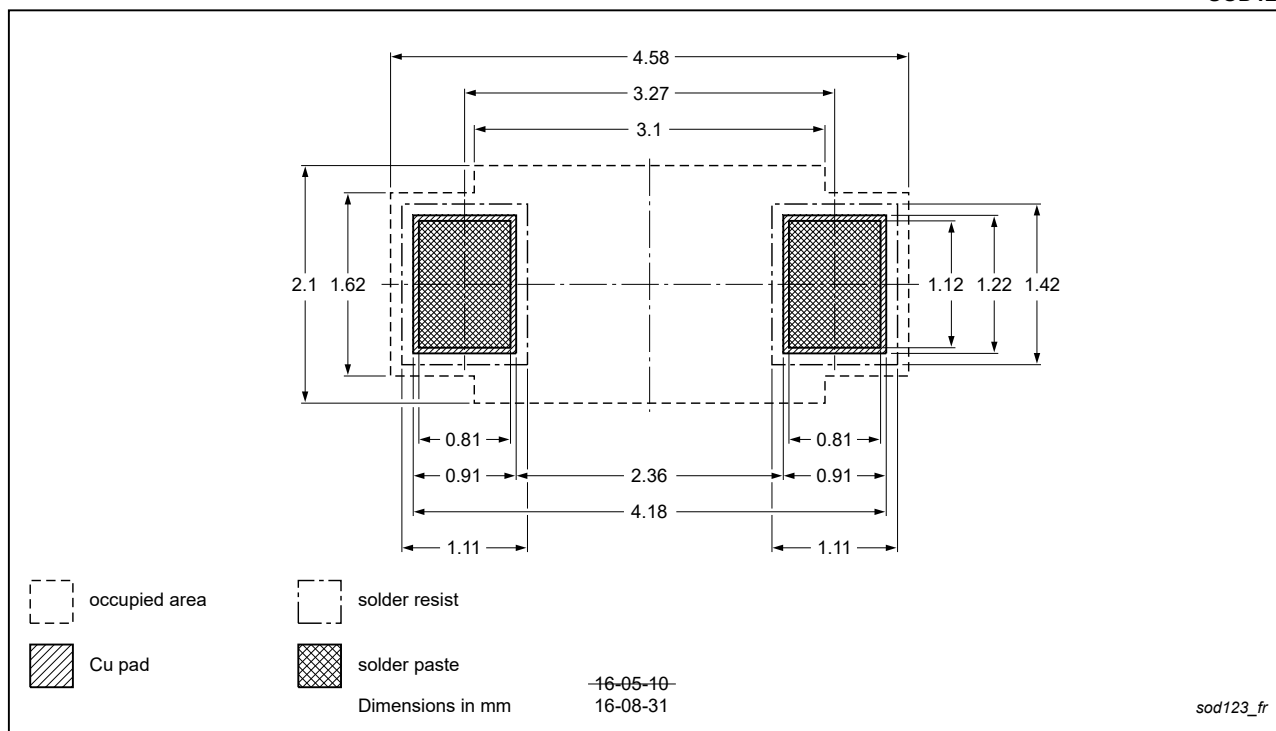


Fig. 8. Reflow soldering footprint for SOD123

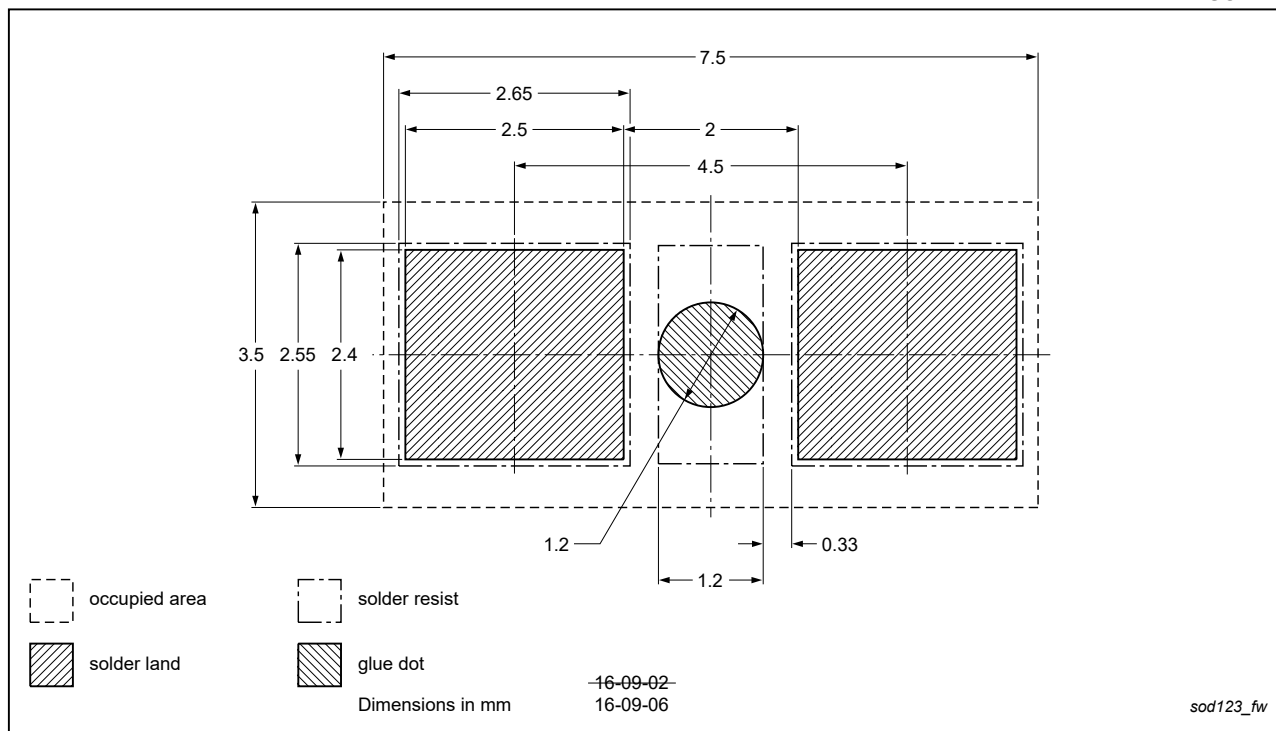


Fig. 9. Wave soldering footprint for SOD123
