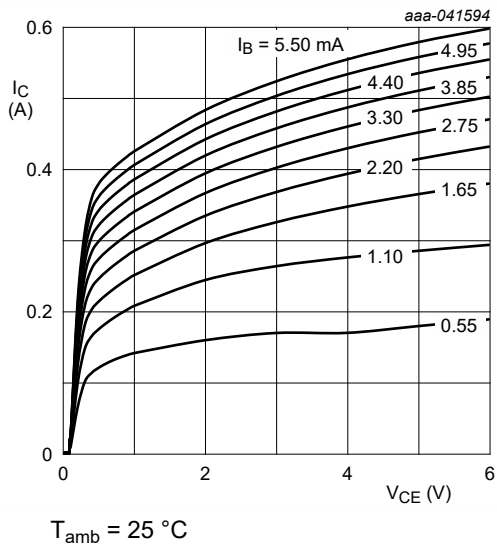


Fig. 1. Collector current as a function of collector-emitter voltage; typical values

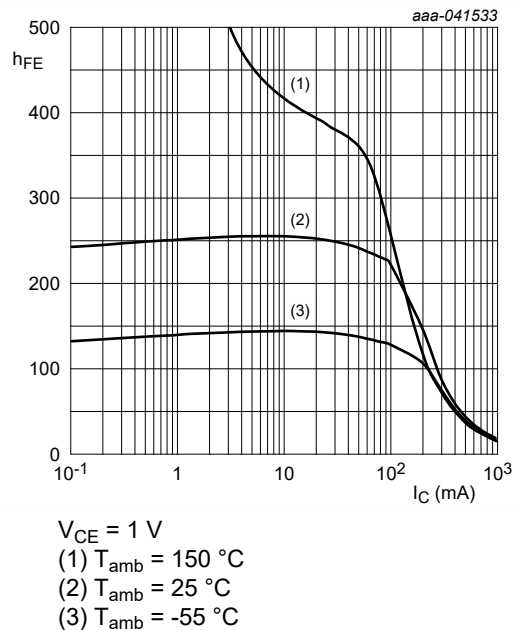


Fig. 2. DC current gain as a function of collector current; typical values

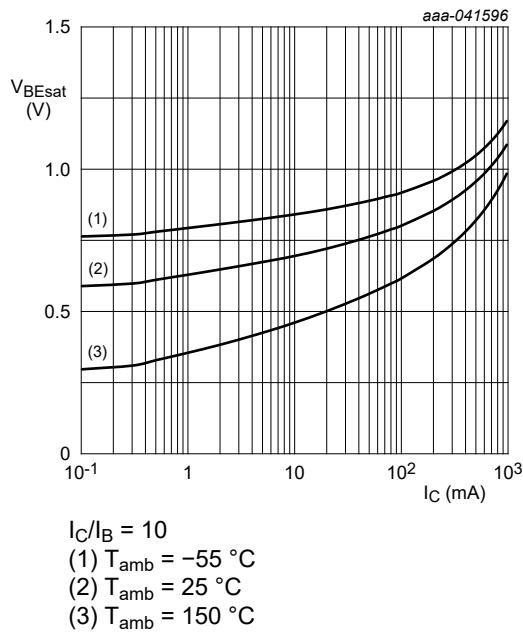


Fig. 3. Base-emitter saturation voltage as a function of collector current; typical values

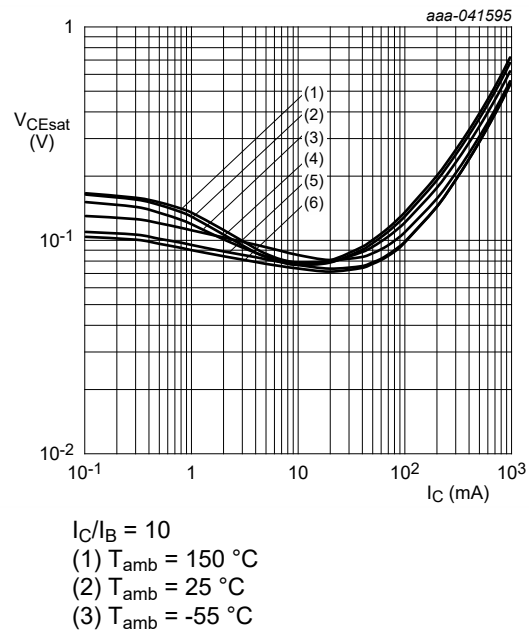


Fig. 4. Collector-emitter saturation voltage as a function of collector current; typical values

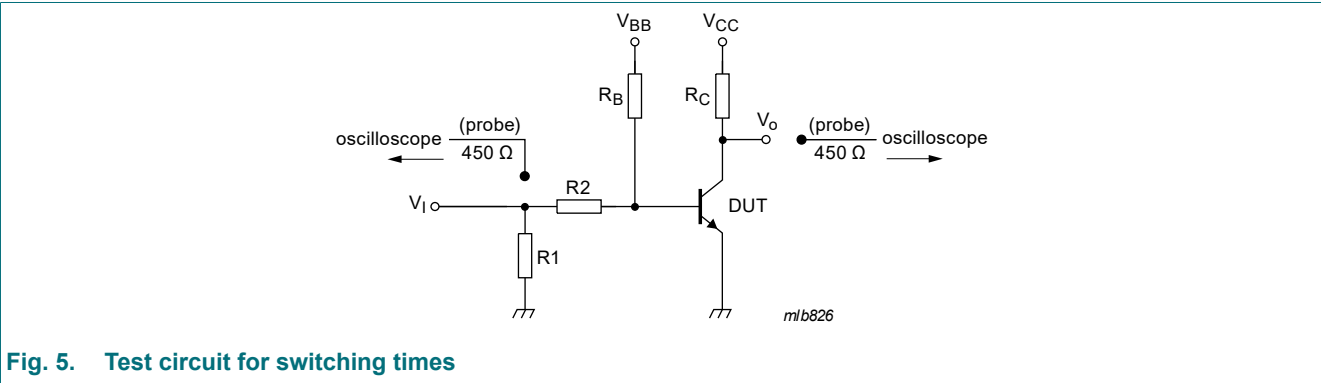


Fig. 5. Test circuit for switching times

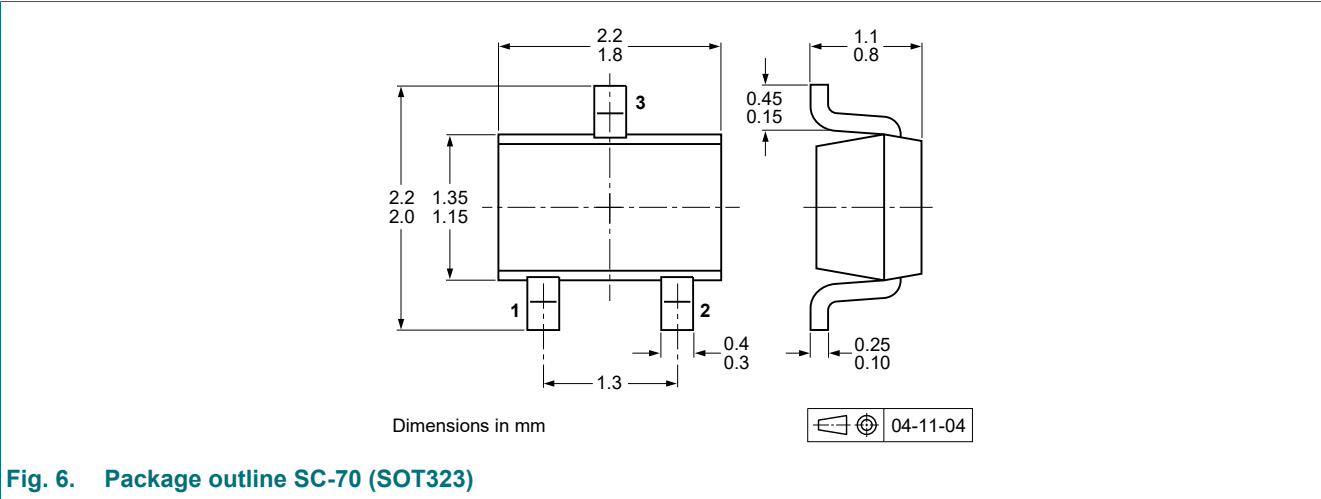


Fig. 6. Package outline SC-70 (SOT323)

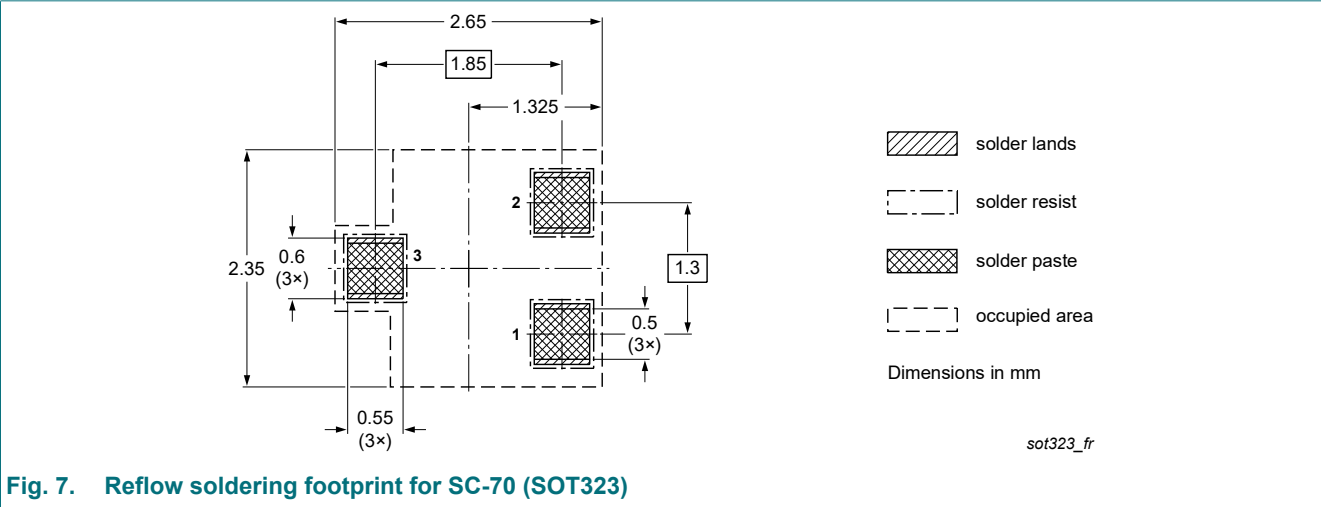
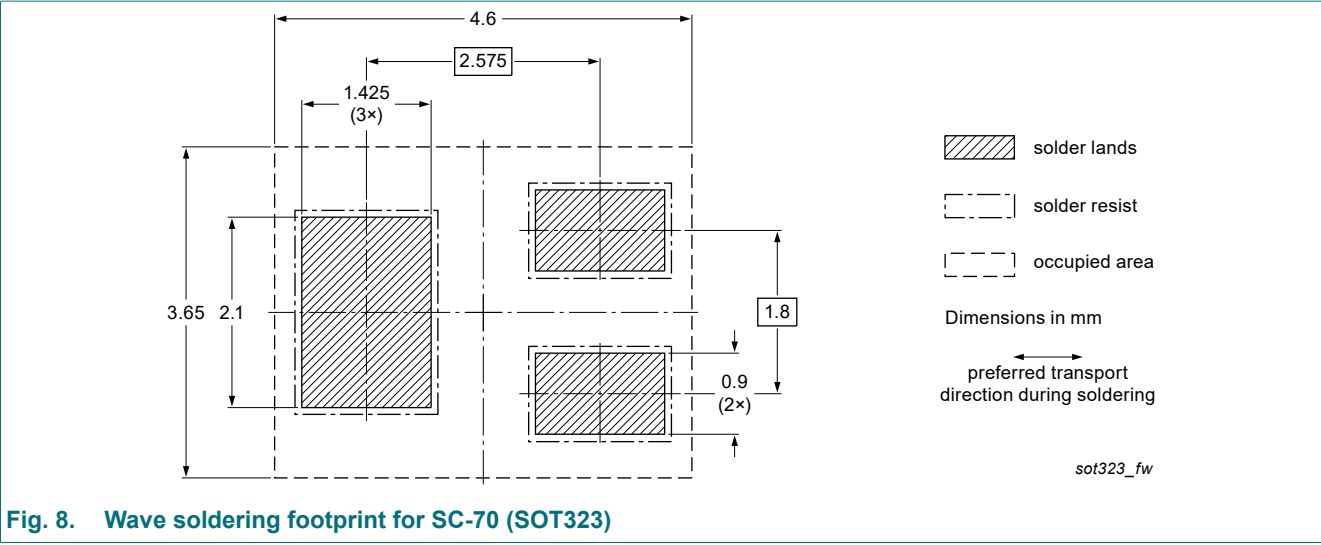


Fig. 7. Reflow soldering footprint for SC-70 (SOT323)
