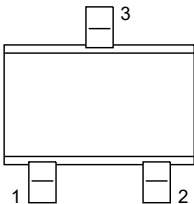
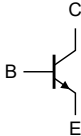

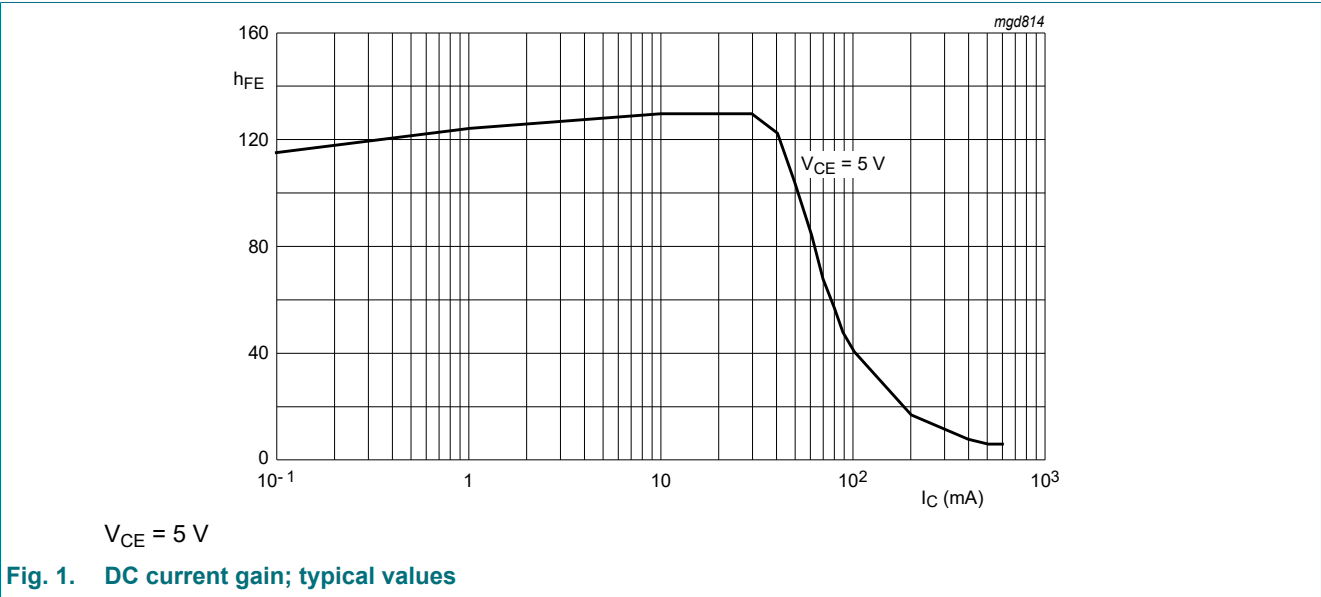


Fig. 1. DC current gain; typical values

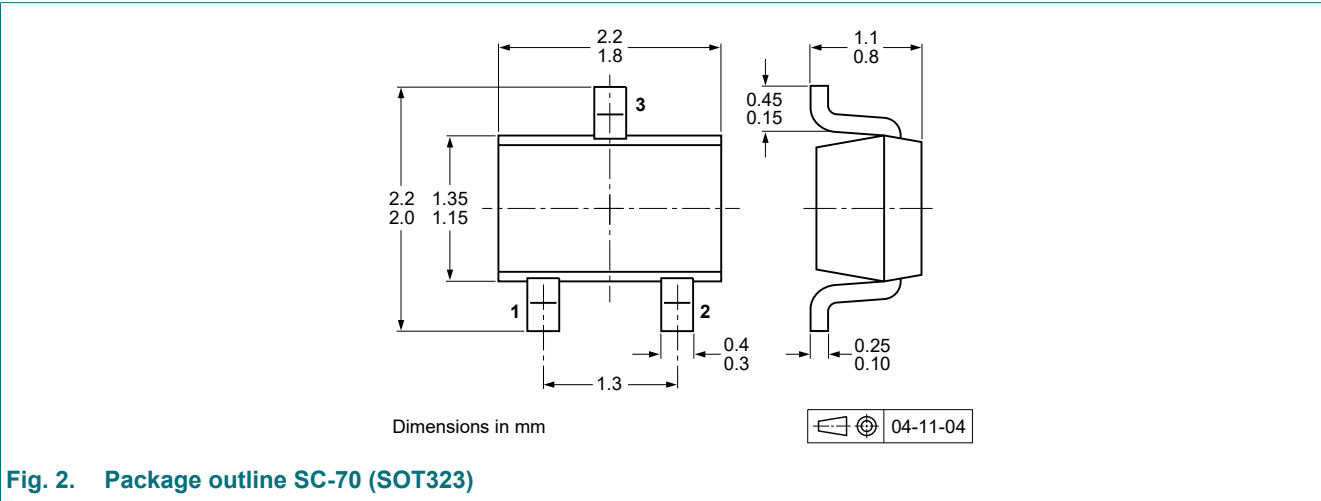


Fig. 2. Package outline SC-70 (SOT323)

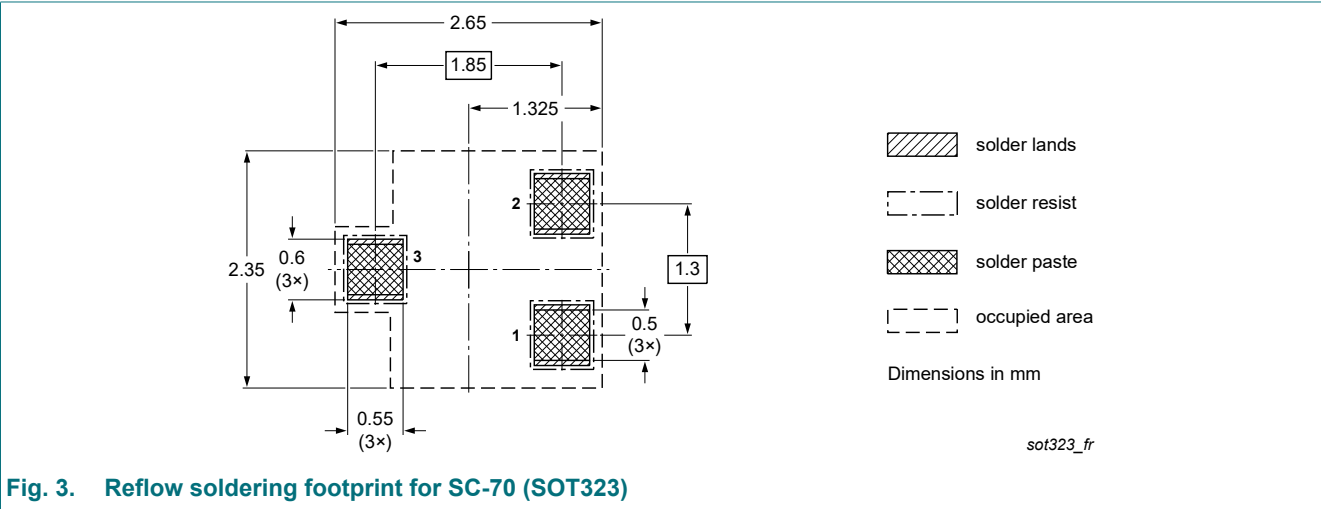
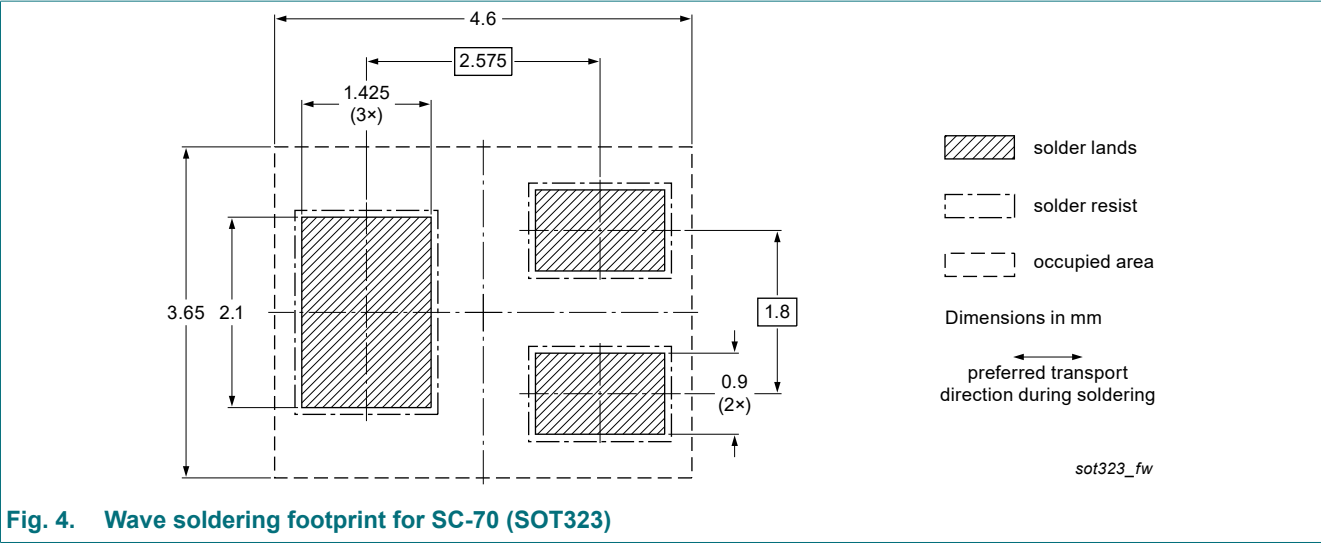


Fig. 3. Reflow soldering footprint for SC-70 (SOT323)
