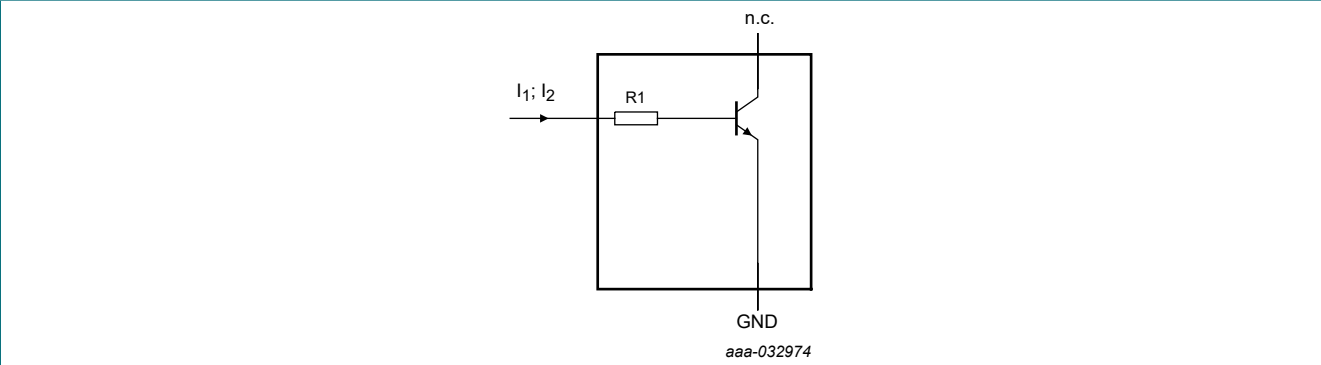


Fig. 3. TR1 (NPN): Resistor test circuit

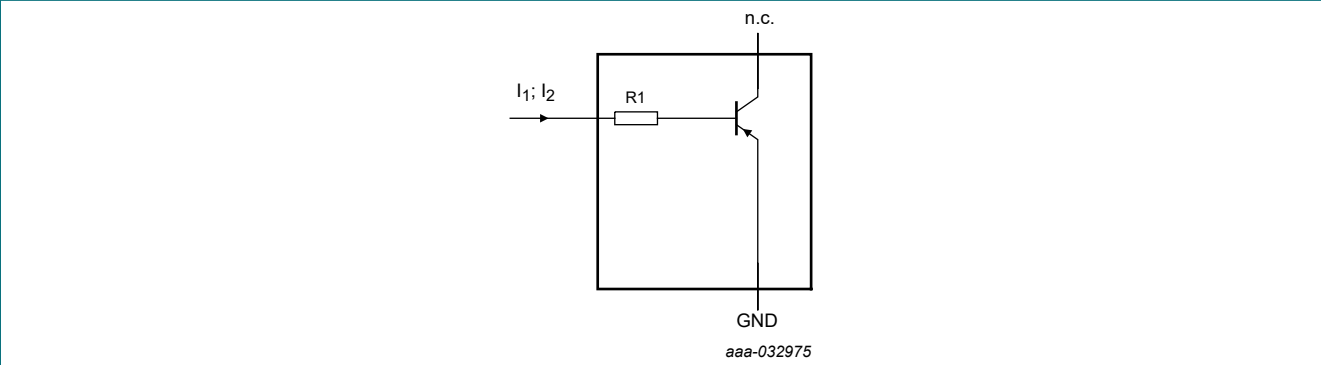


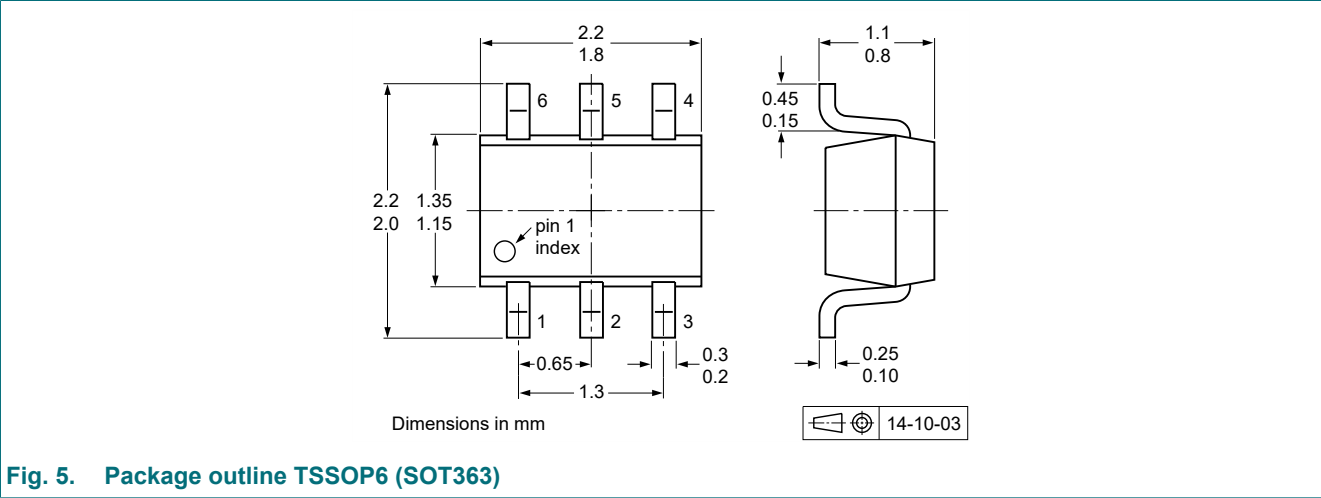
Fig. 4. TR2 (PNP): Resistor test circuit

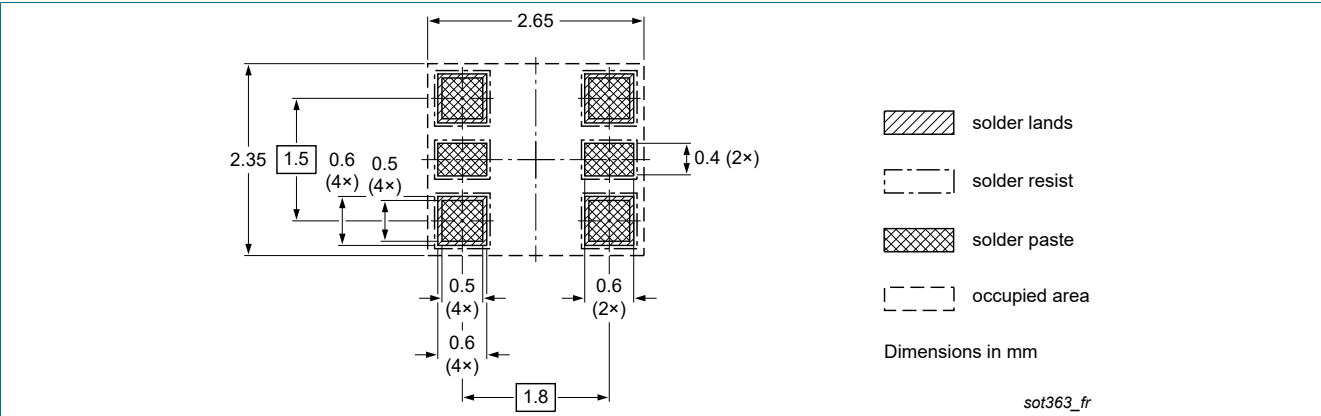


Fig. 6. Reflow soldering footprint for TSSOP6 (SOT363)

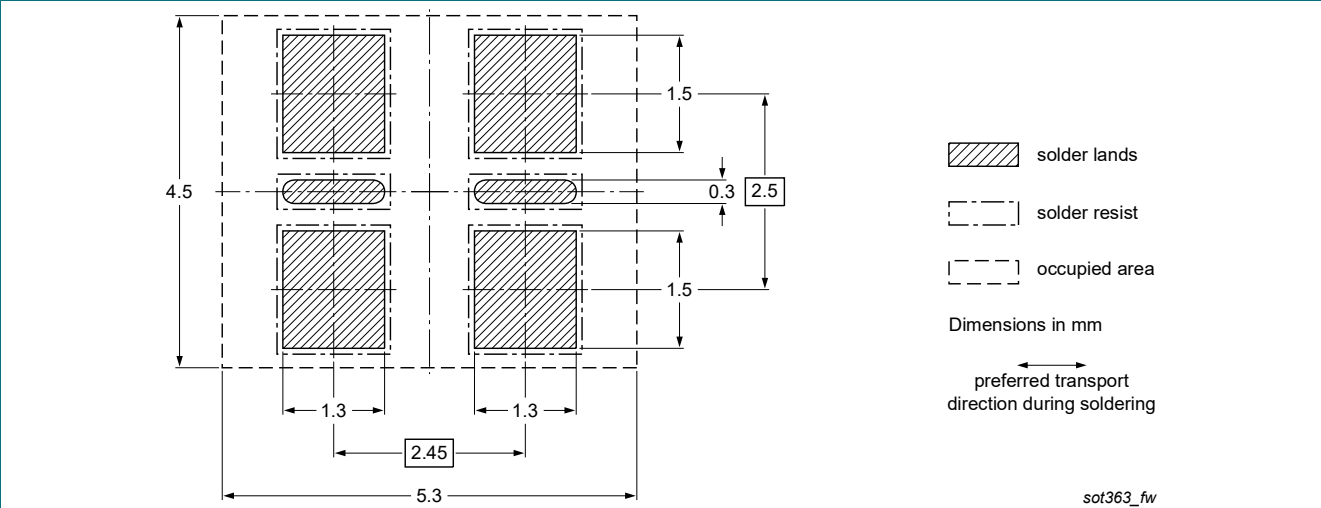


Fig. 7. Wave soldering footprint for TSSOP6 (SOT363)
