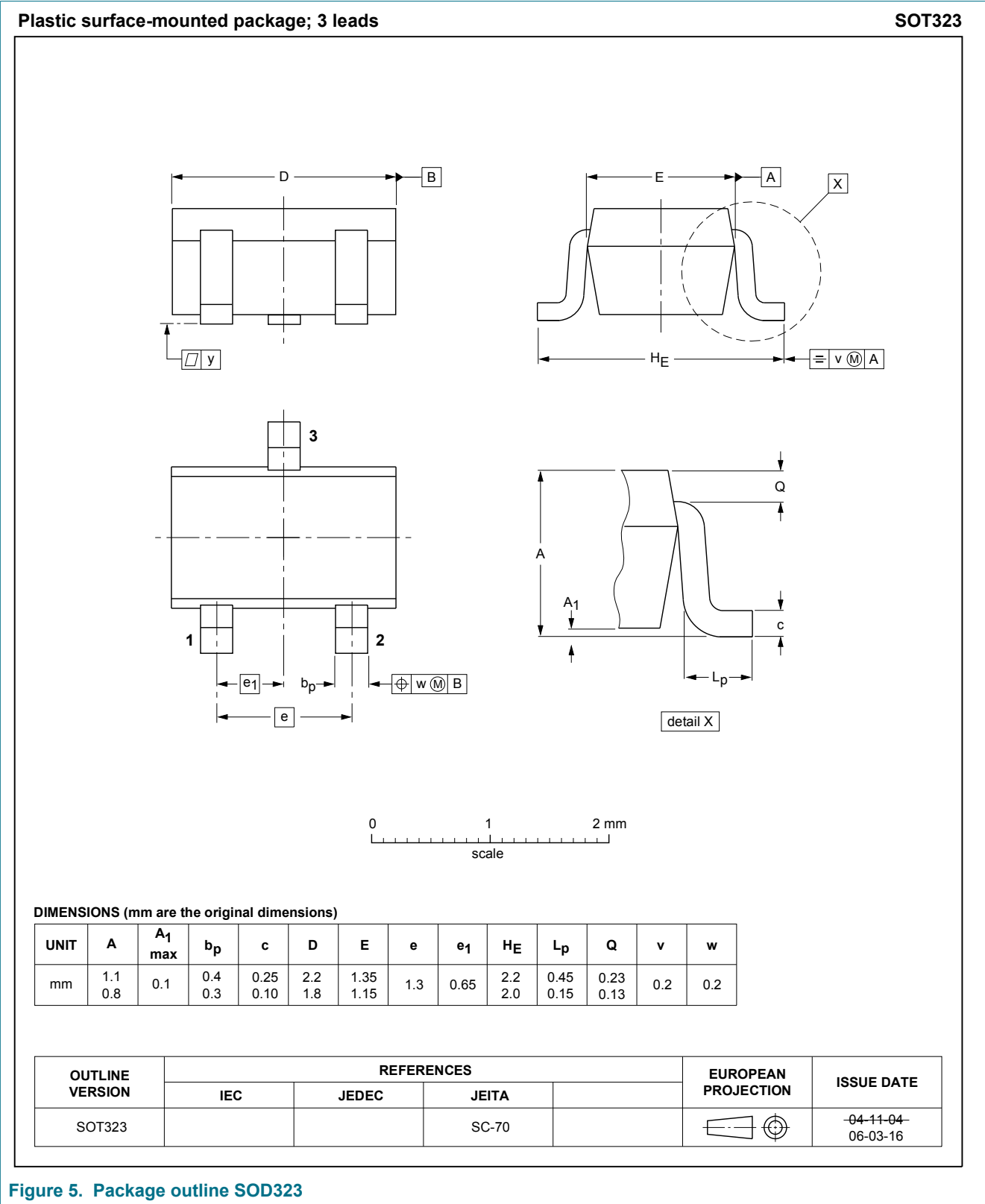


Figure 5. Package outline SOT323
