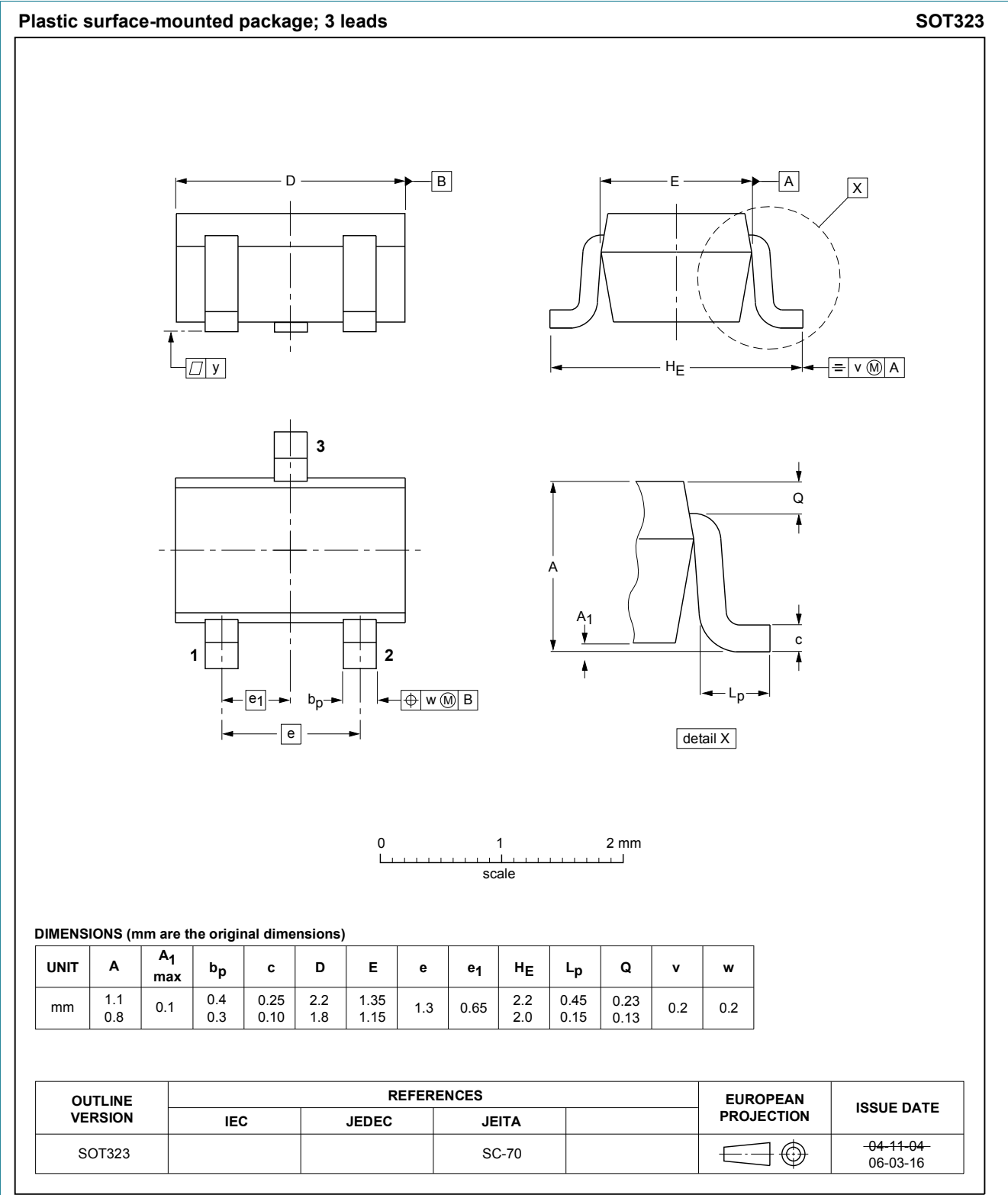


Figure 6. Package outline SOT323
