GRAPHICAL DATA



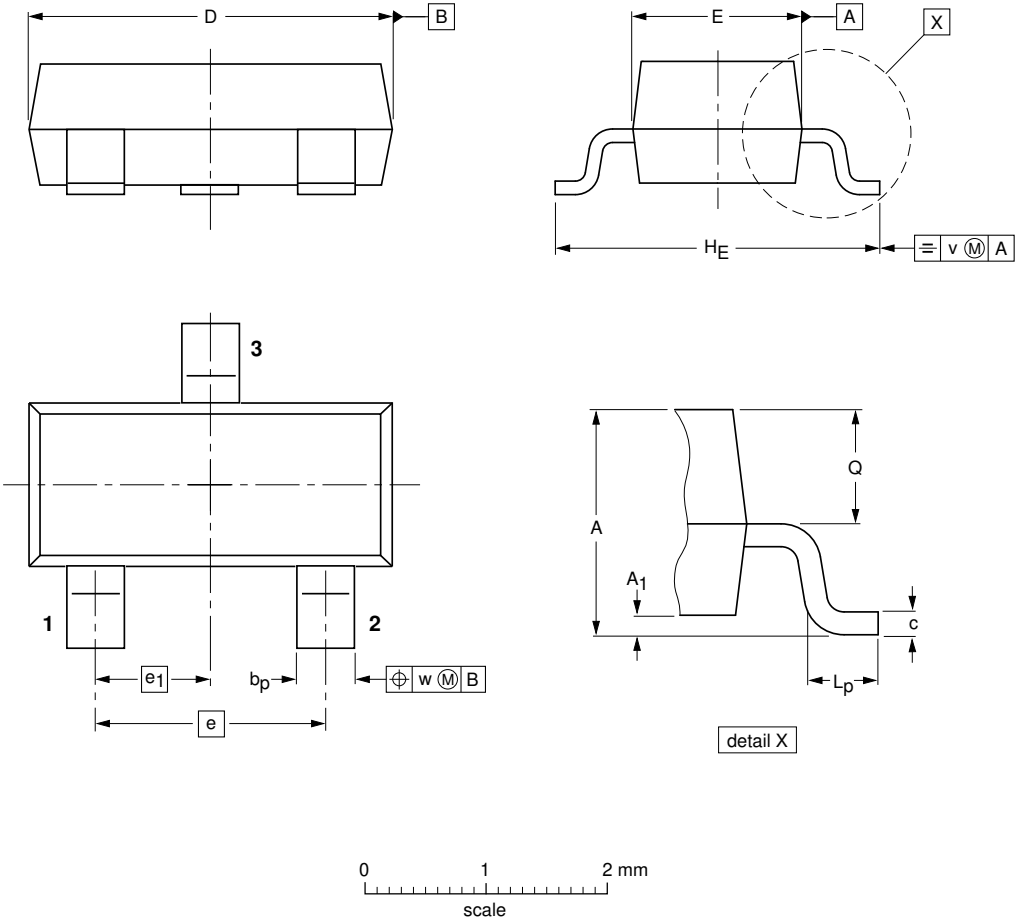
