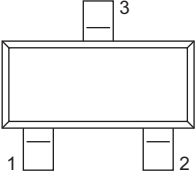

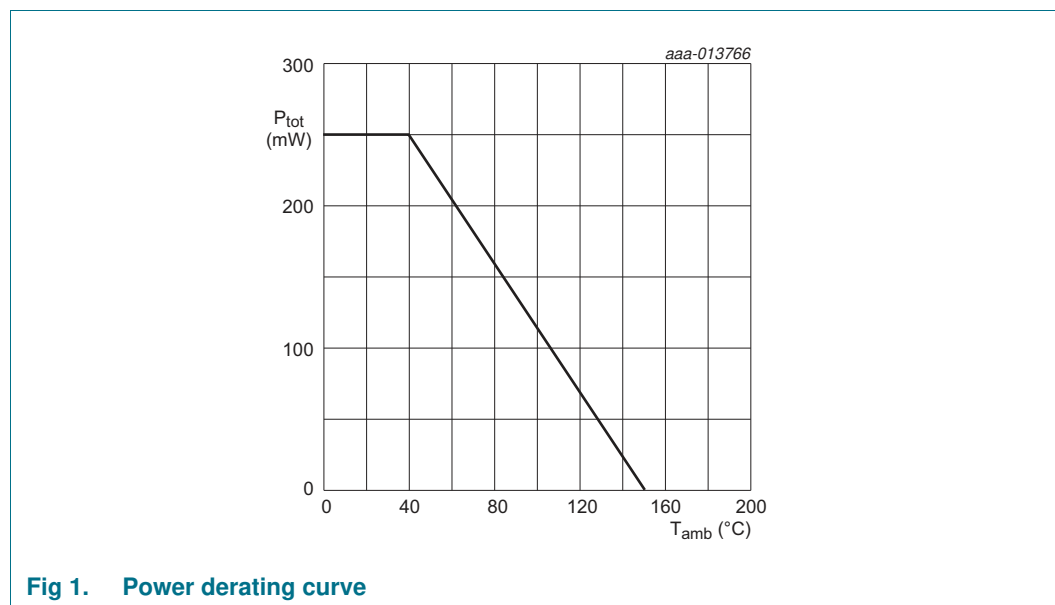


Fig 1. Power derating curve

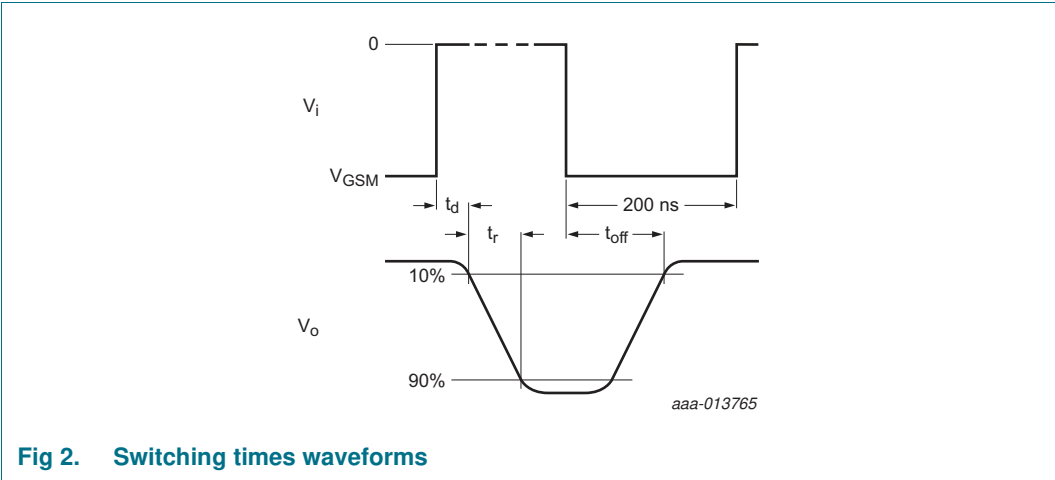
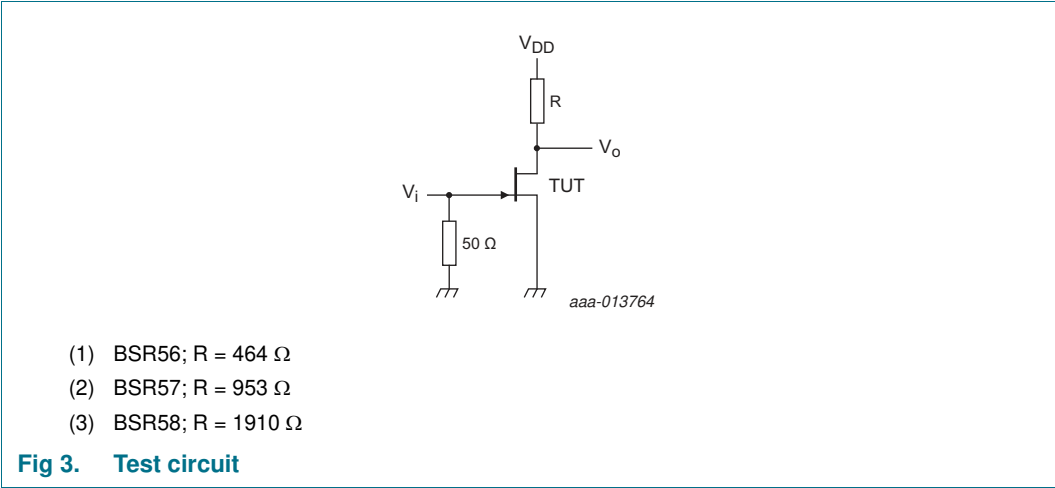


Fig 2. Switching times waveforms

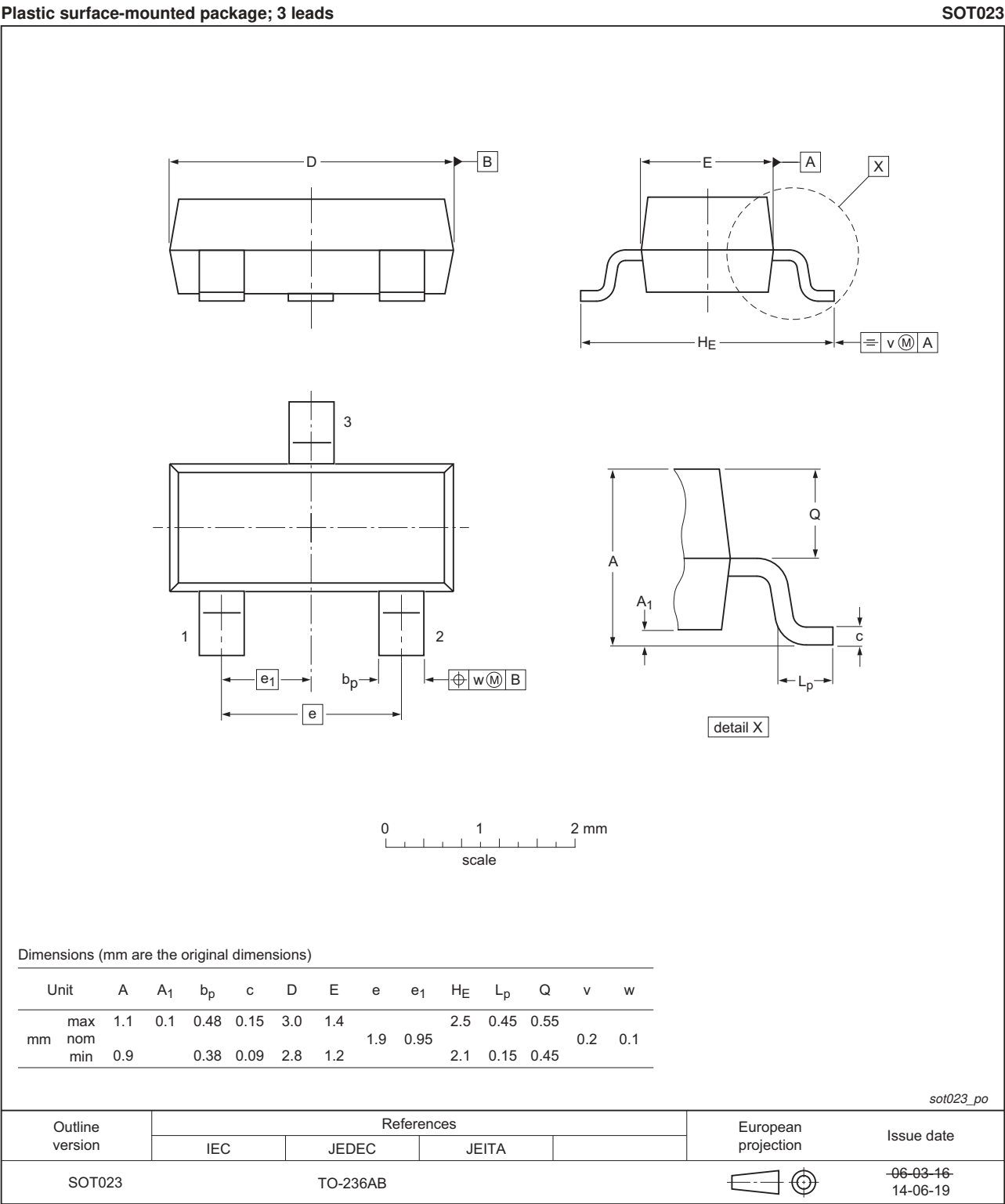


Fig 4. Package outline SOT23 (TO-236AB)
