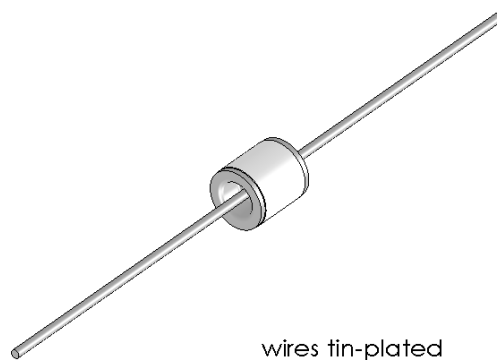
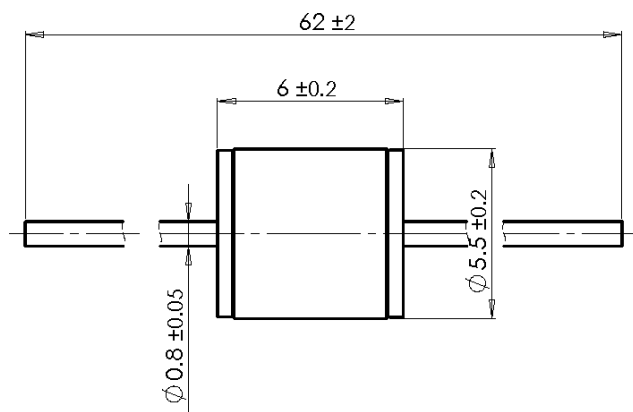

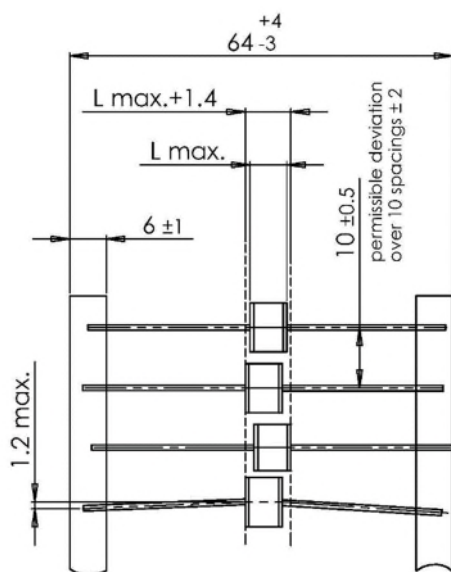

Dimensional drawing in mm

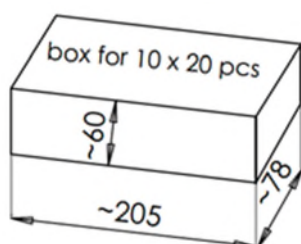
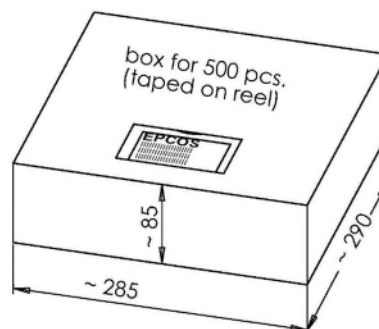
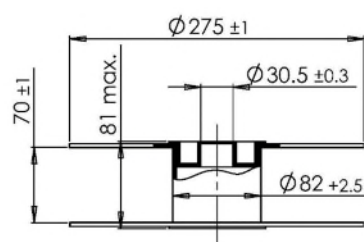

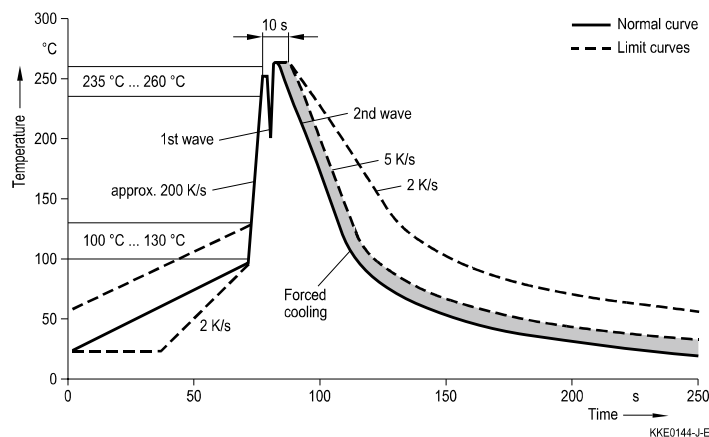
