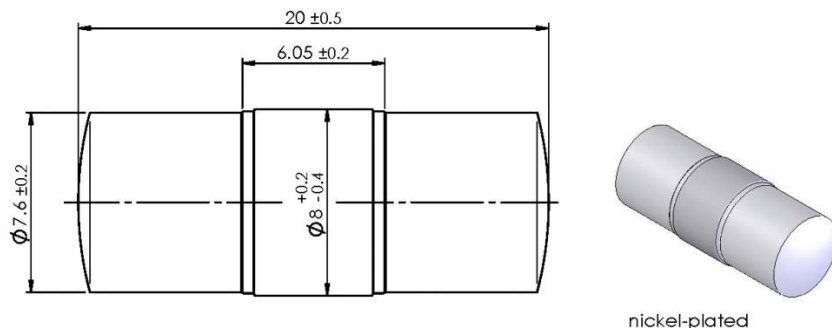

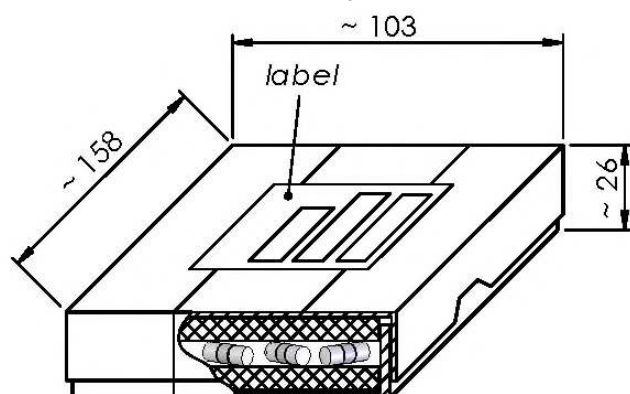

Cautions and warnings
