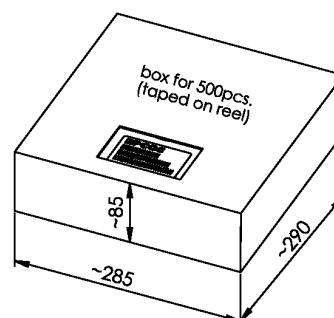

Dimensional drawing in mm



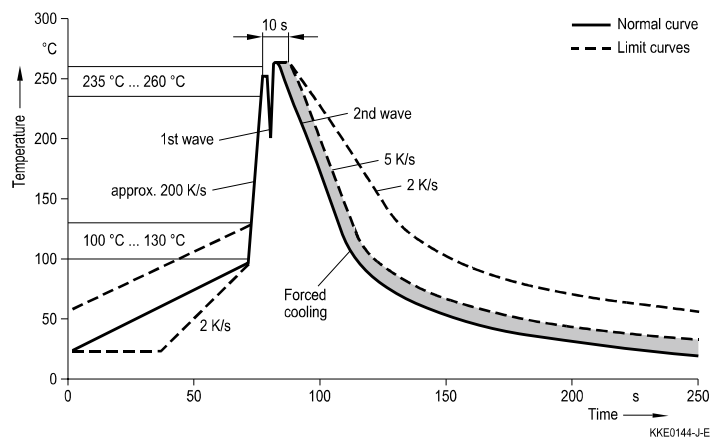
