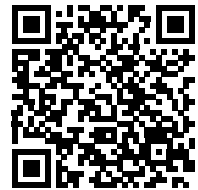

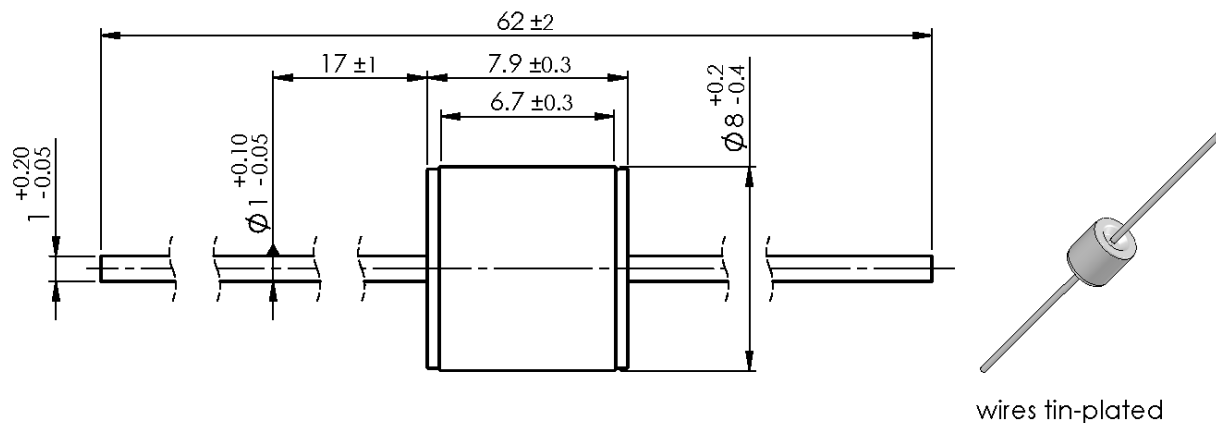

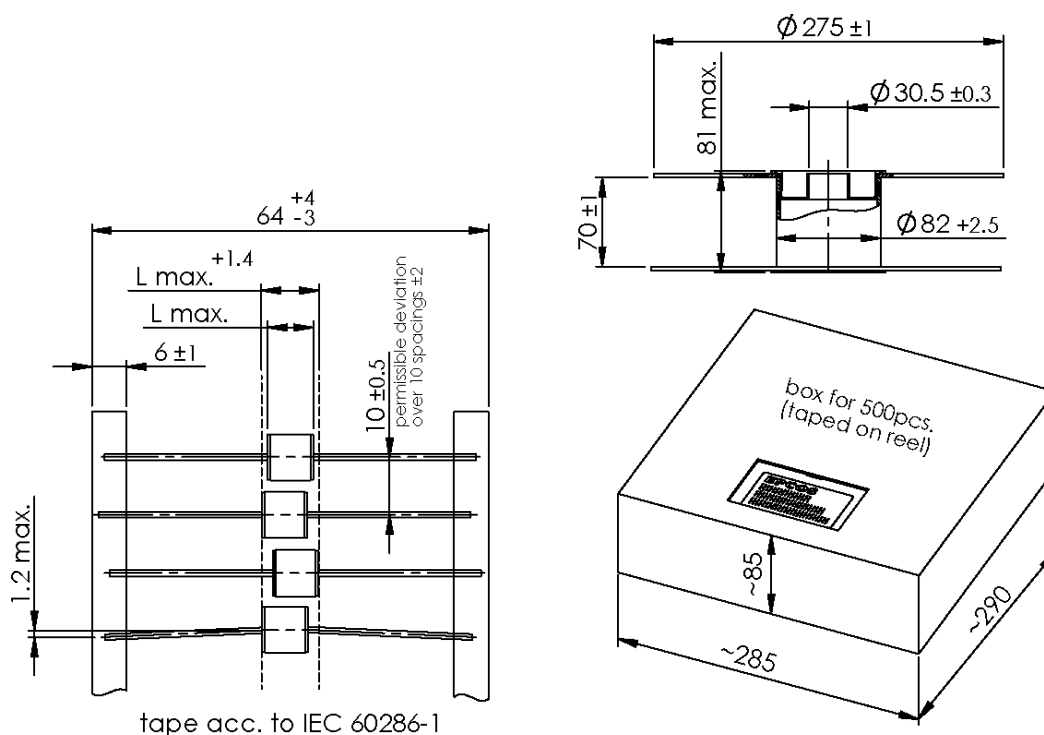

Dimensional drawing in mm



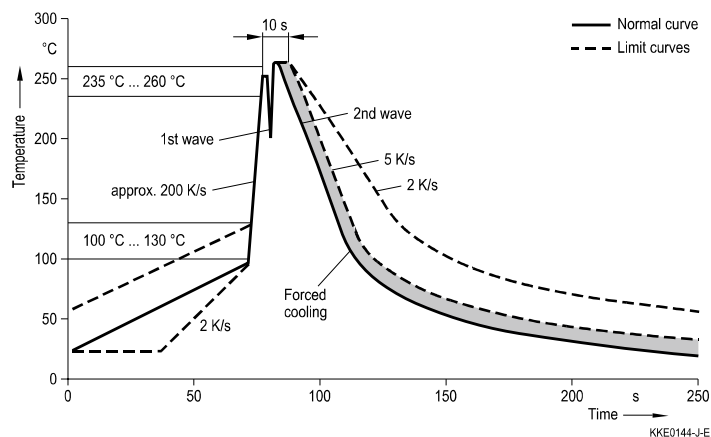
