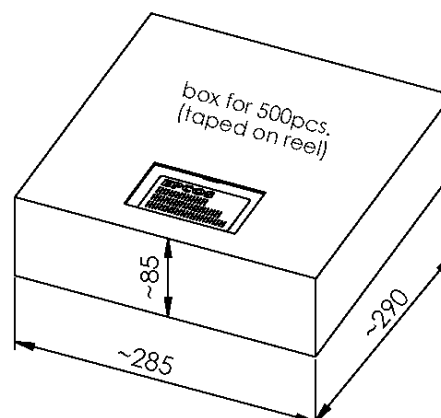
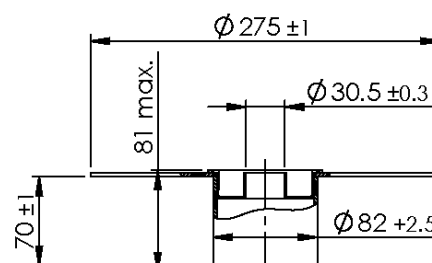
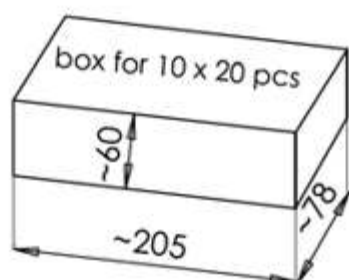
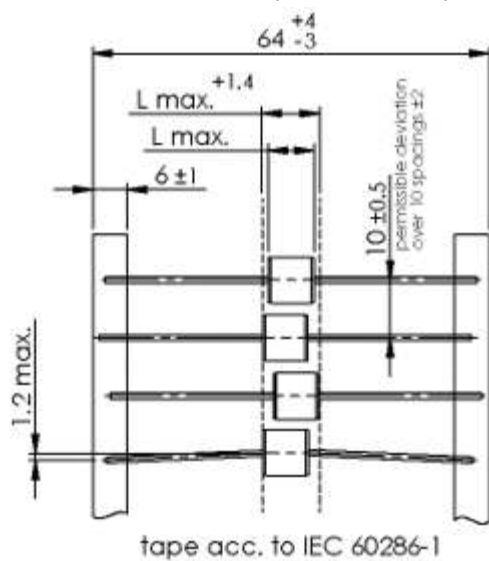
Dimensional drawing in mm

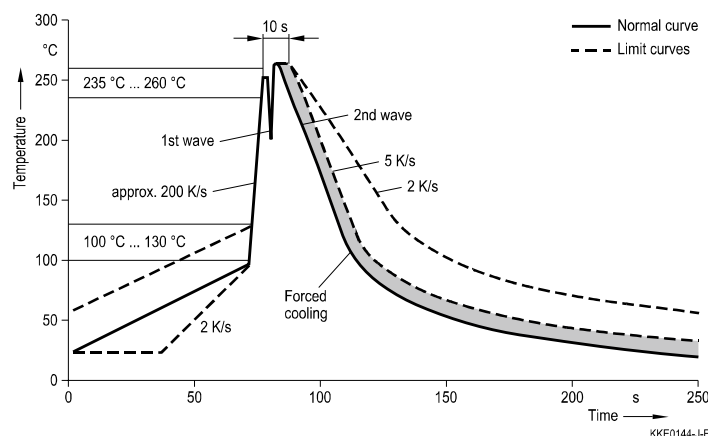
