Fig. 1: QC- test circuit (100% outgoing inspection)

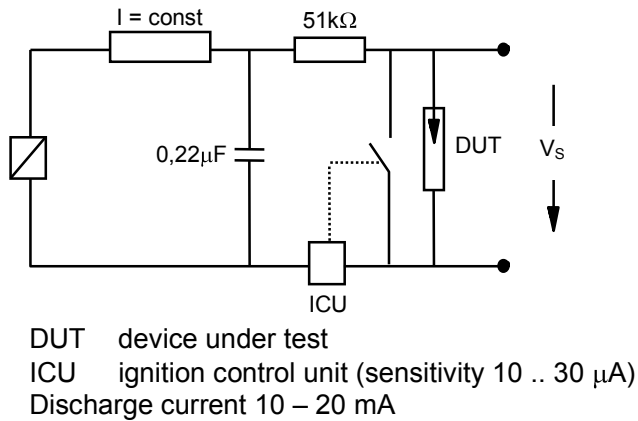


Fig. 2: Explanation of measurands

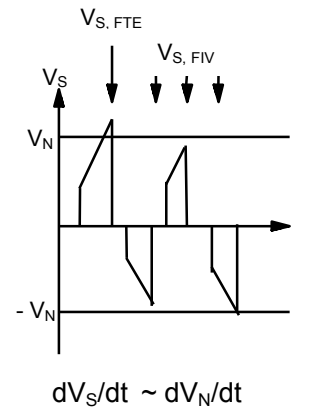


Fig. 3: QC- test circuit (sampling inspection at 25 °C)

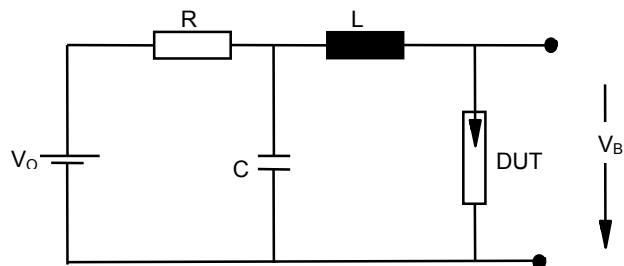
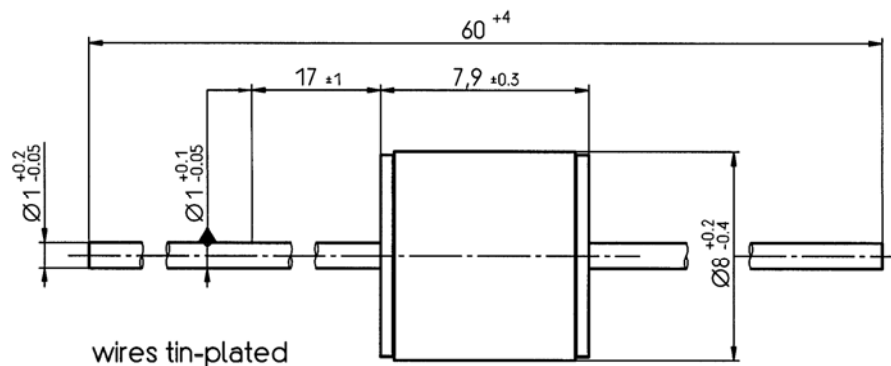
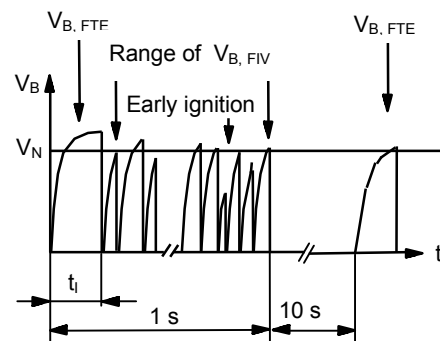


Fig. 4: Explanation of measurands
