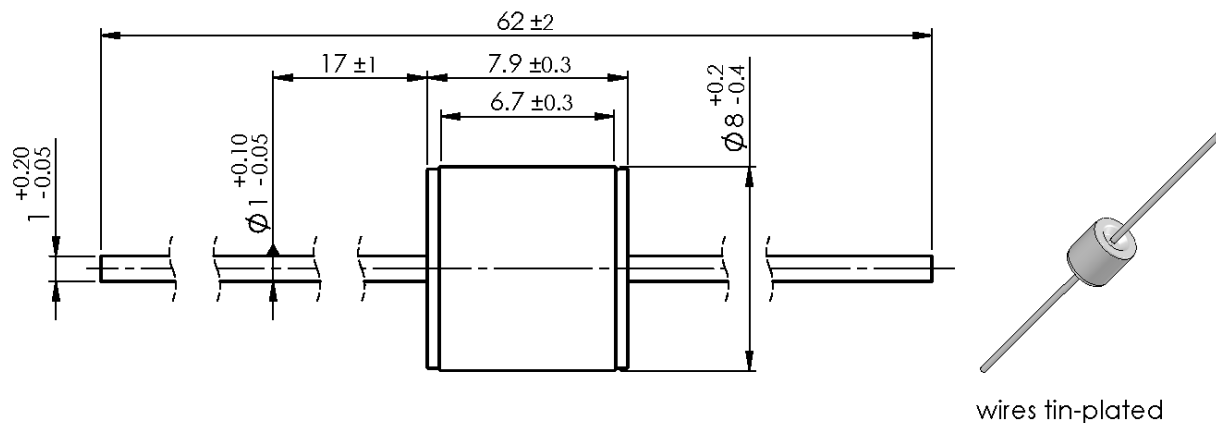

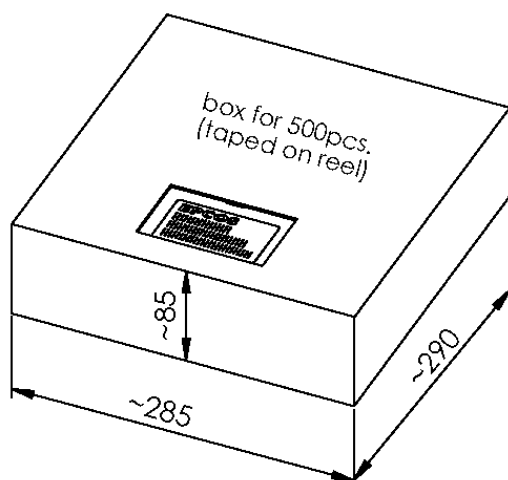
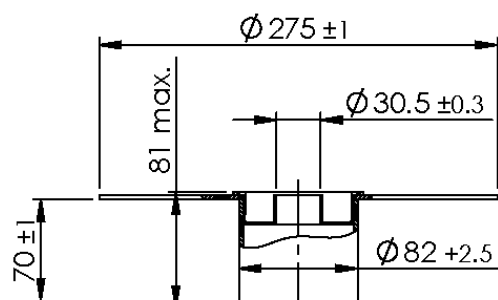

Dimensional drawing in mm



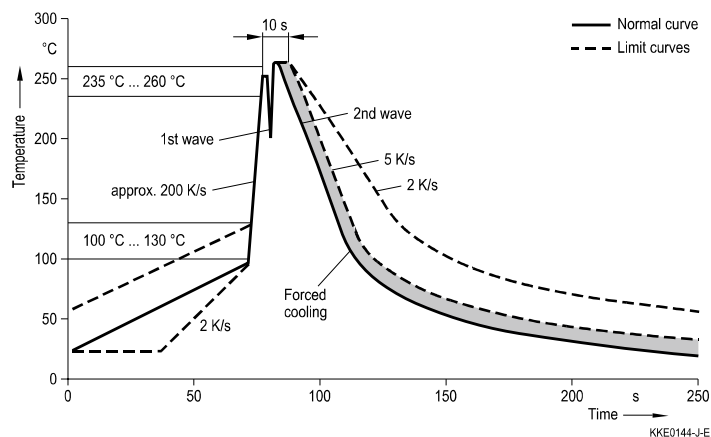
