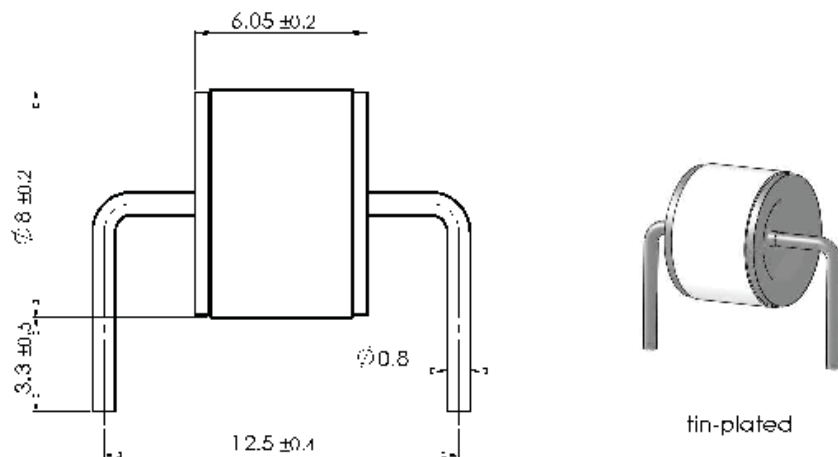

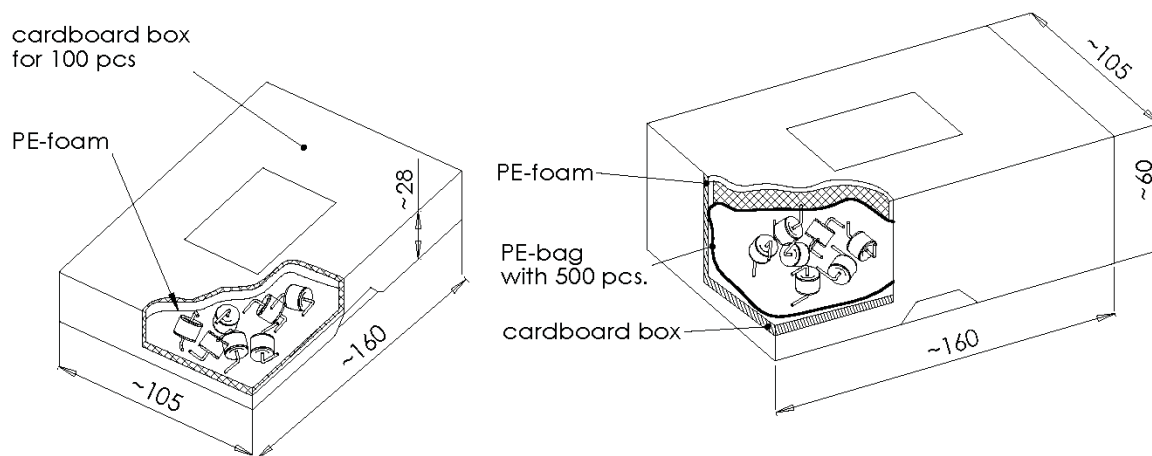
Dimensional drawing in mm

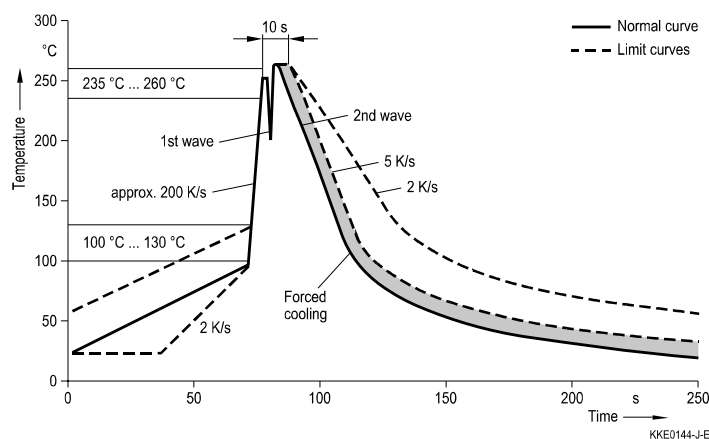
