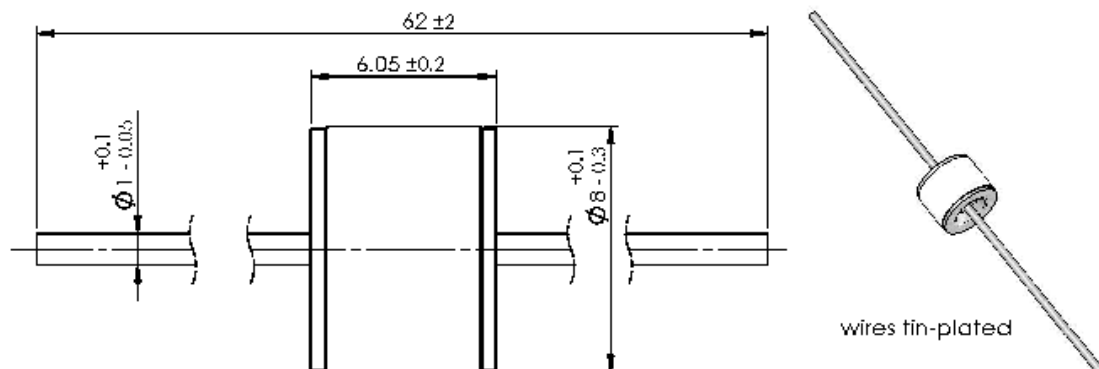

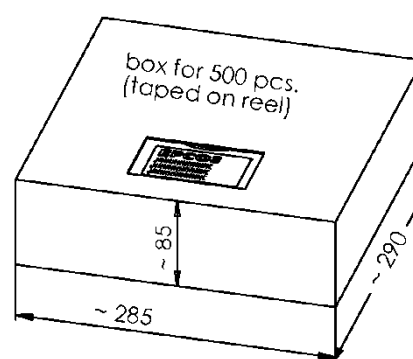
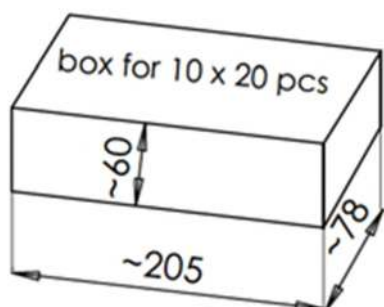
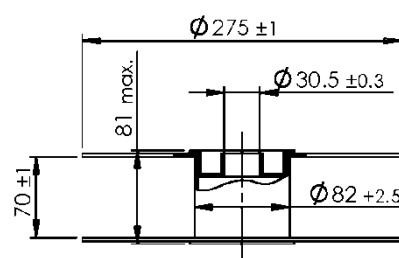
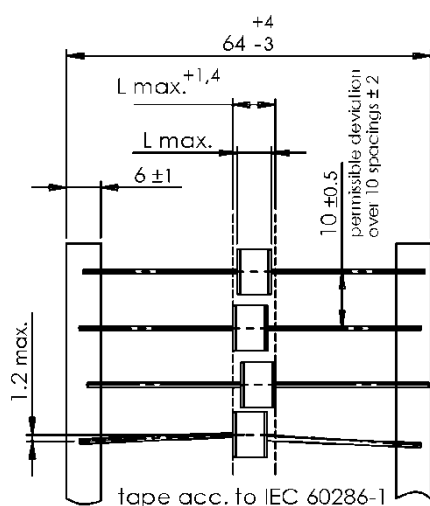
Dimensional drawing in mm

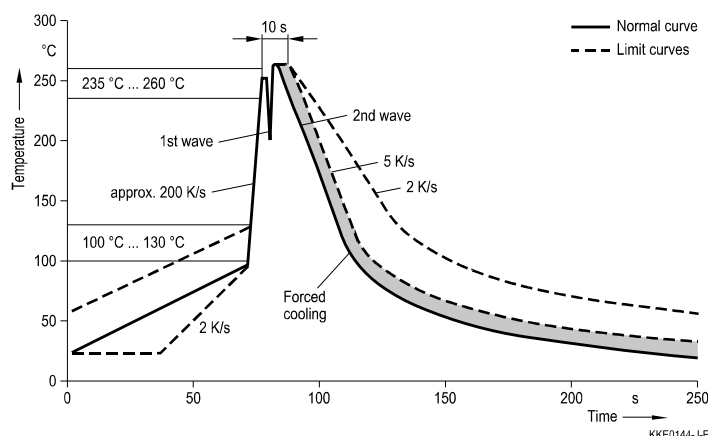
