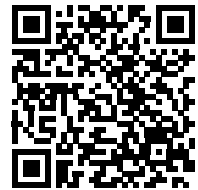

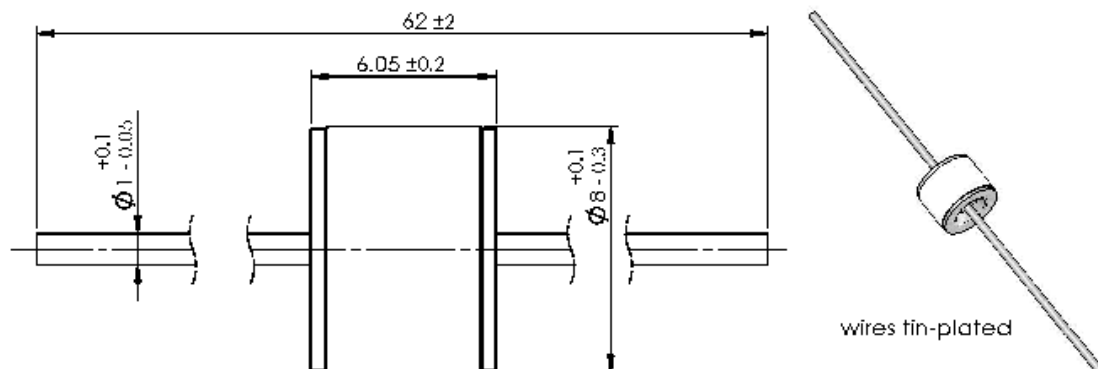

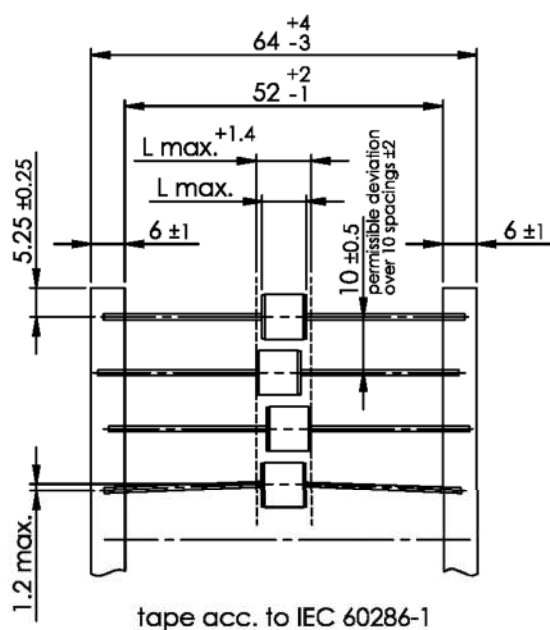
Dimensional drawing in mm



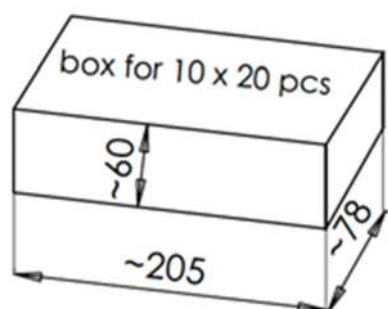
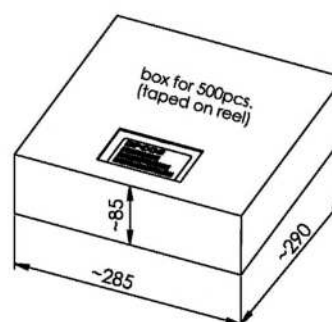
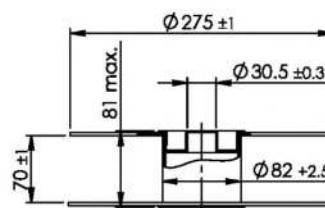

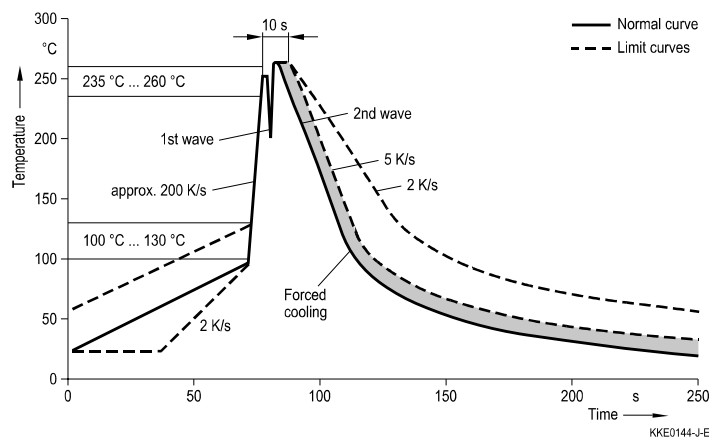
