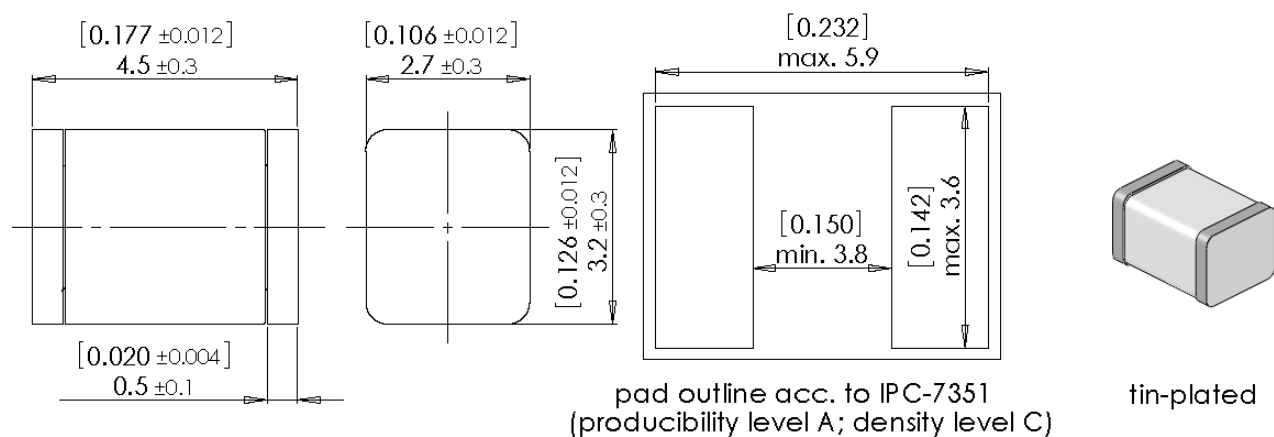

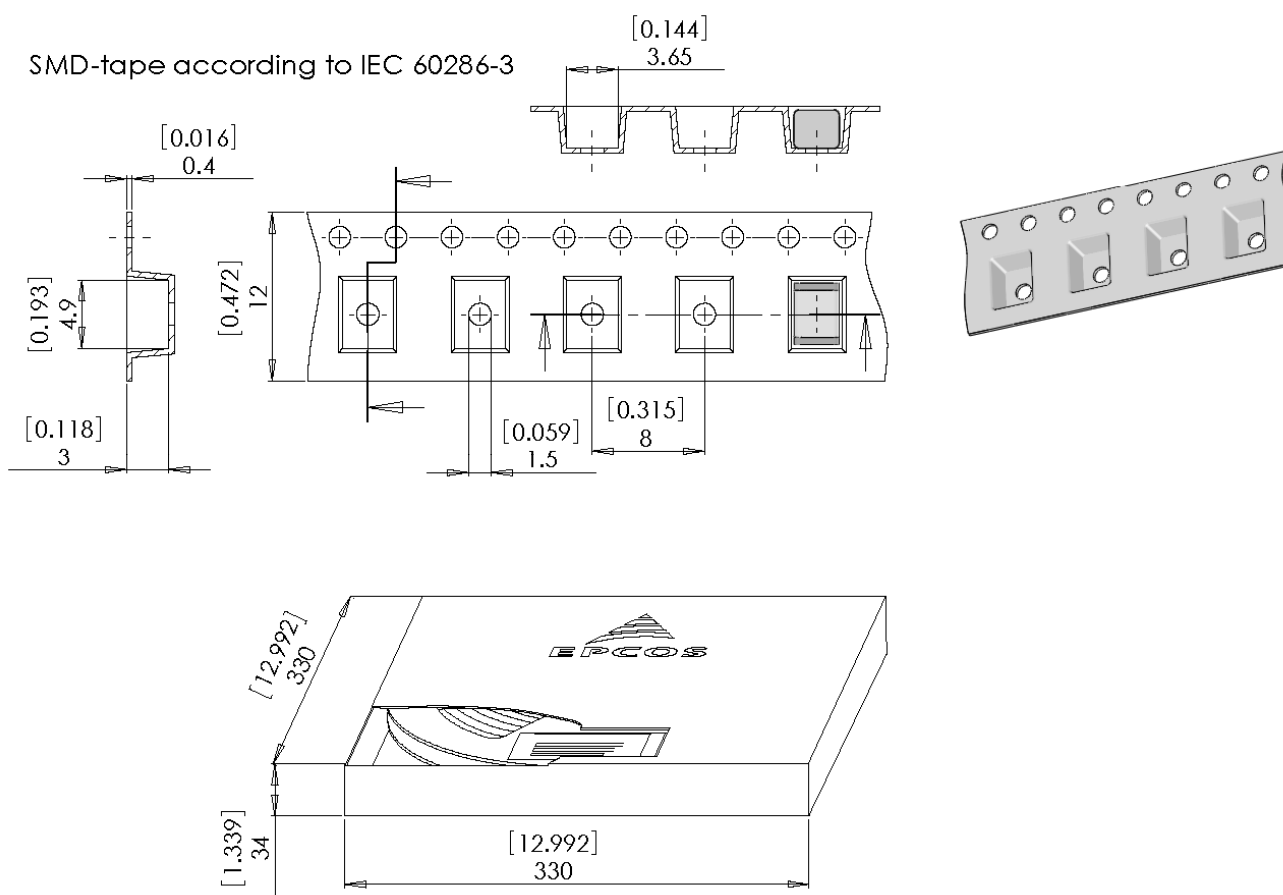
Dimensional drawing in mm

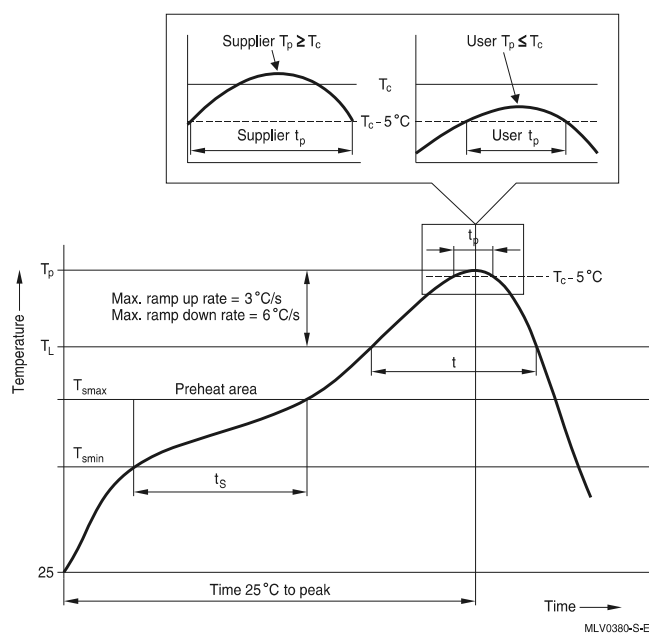

SMD-tape according to IEC 60286-3



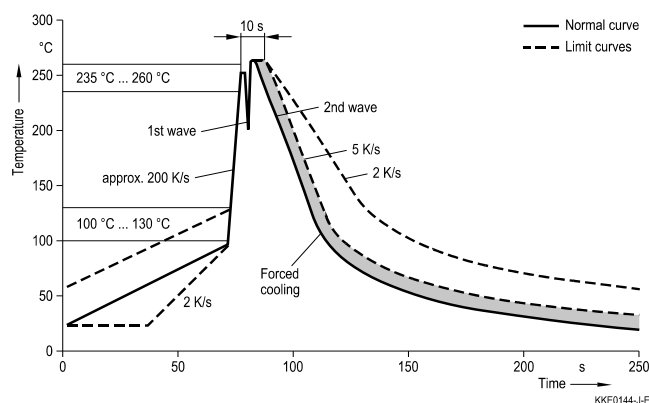
