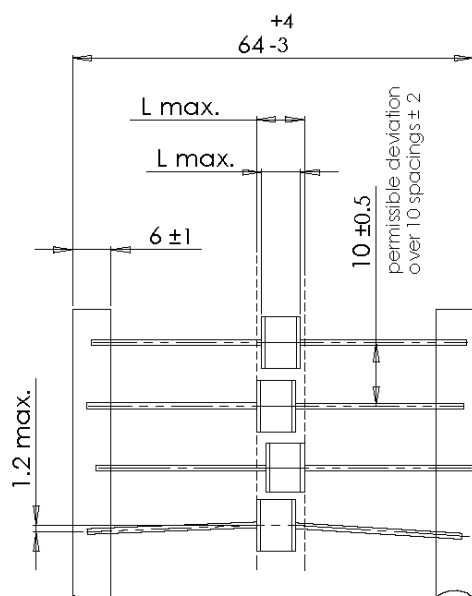
Dimensional drawing in mm



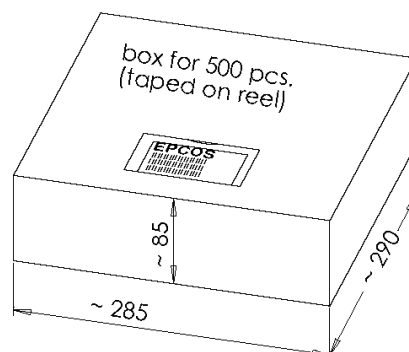
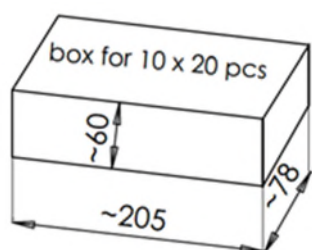
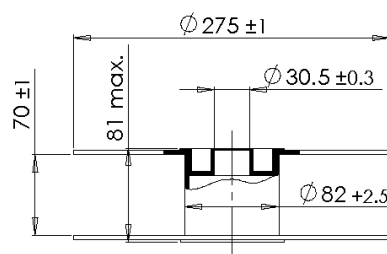

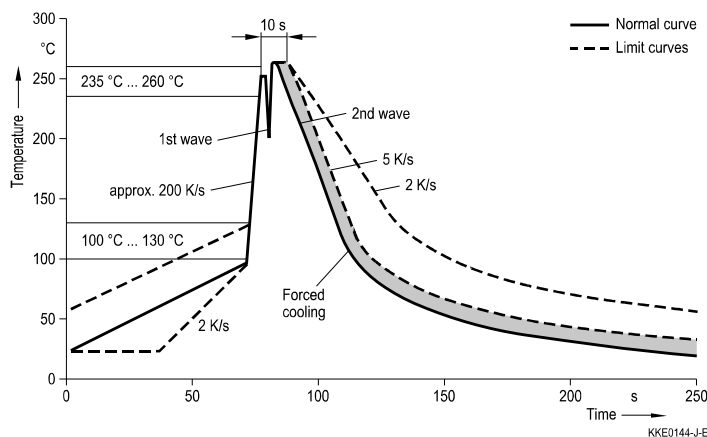
