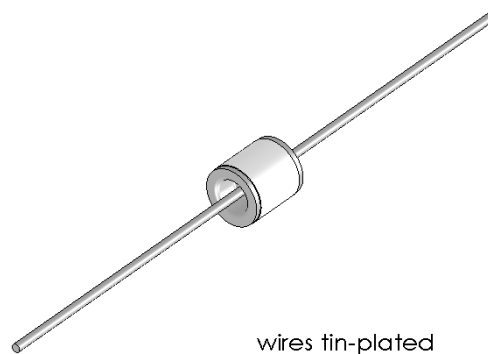
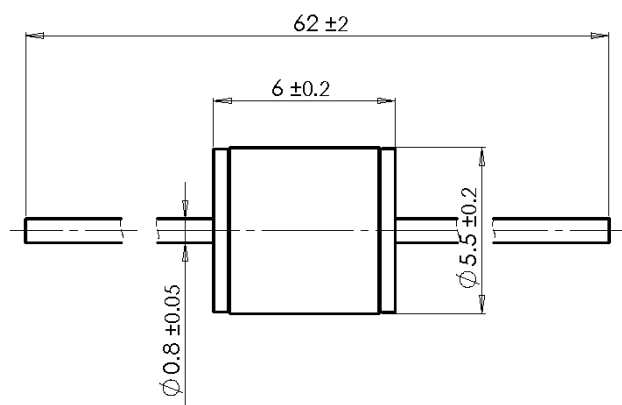

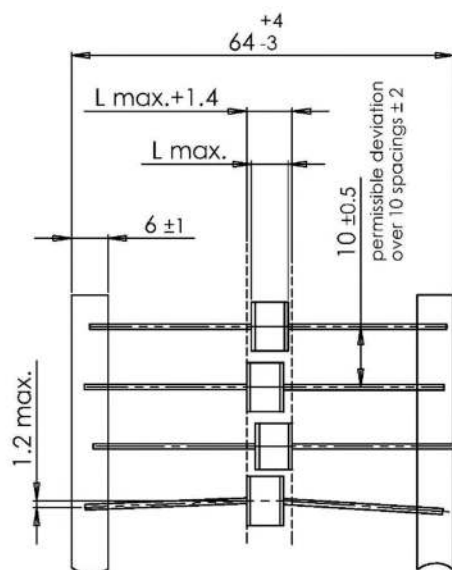
Dimensional drawing in mm



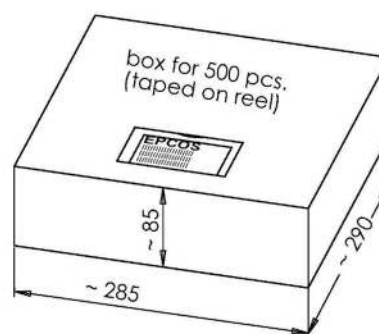
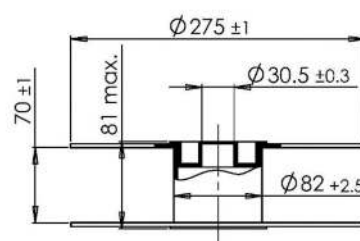
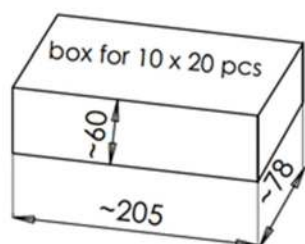

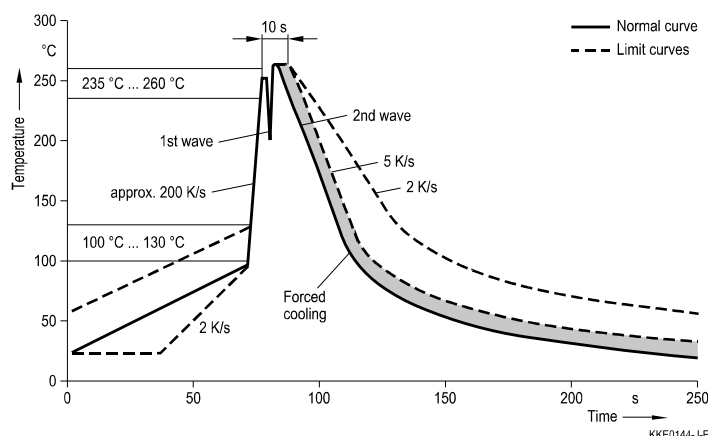
