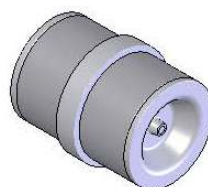
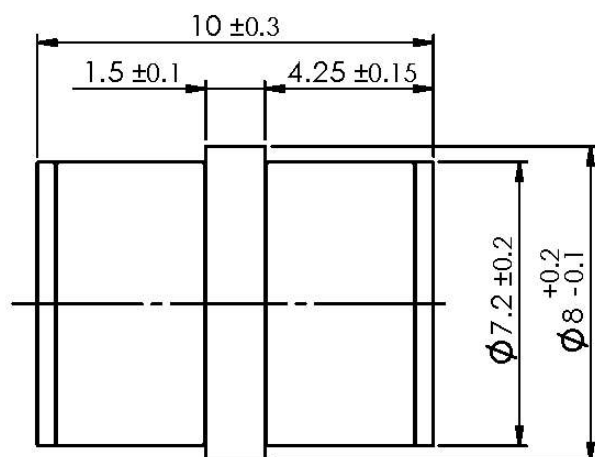

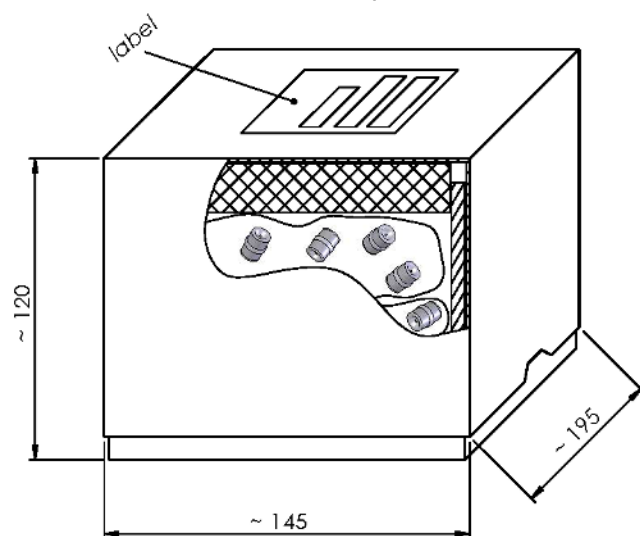
Dimensional drawing in mm
