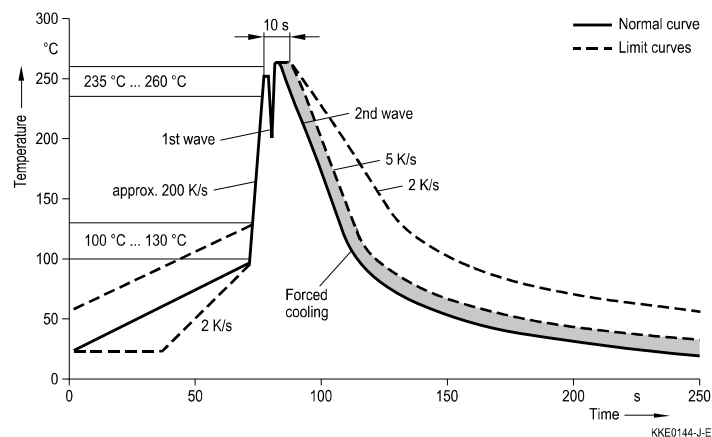

Cautions and warnings
