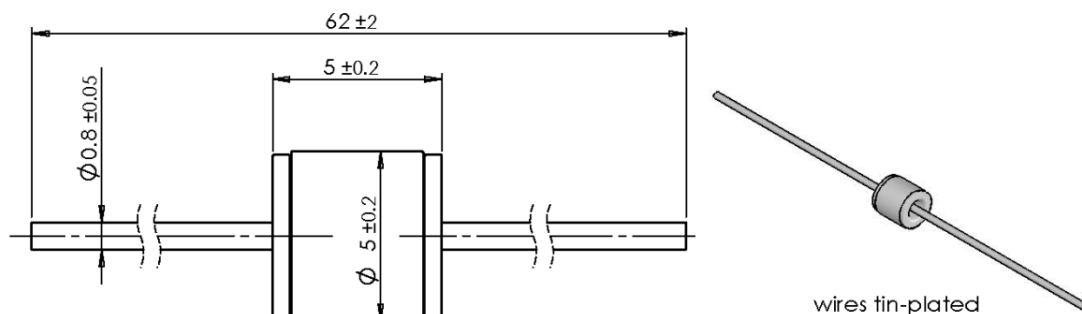

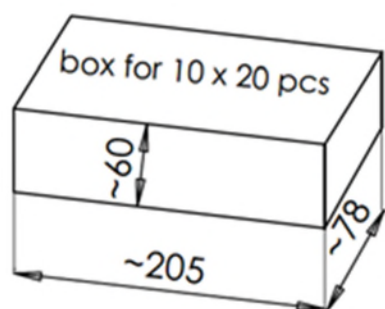
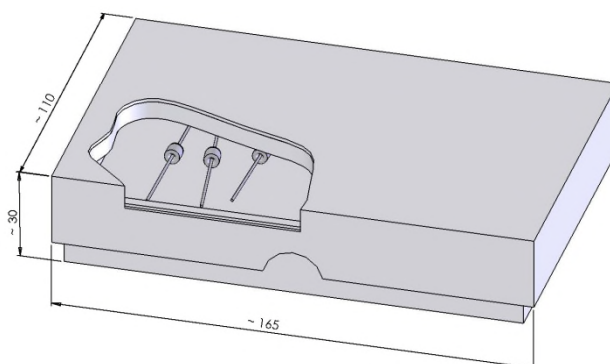
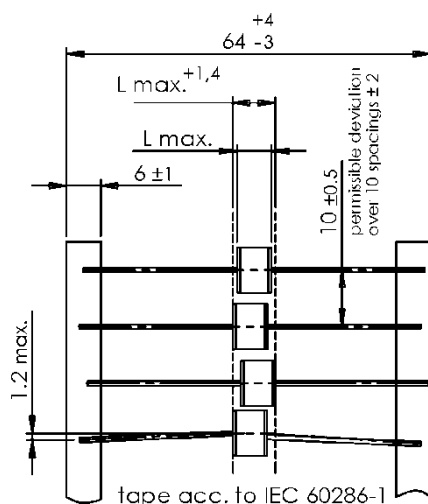
Dimensional drawing in mm

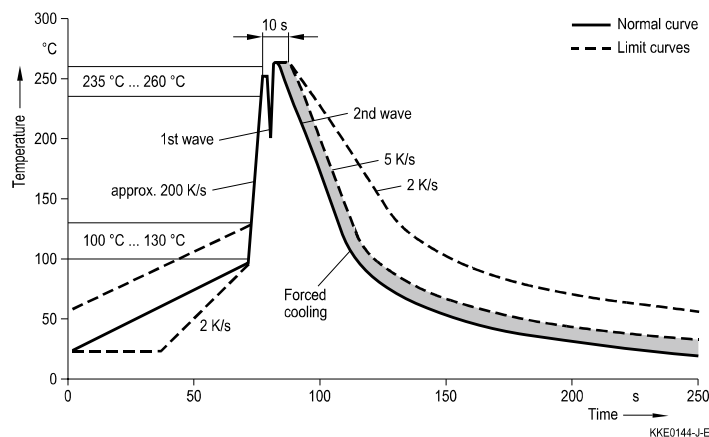
